I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Tajikistan perceive the WBG. The survey explored:

- *General Issues Facing Tajikistan*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in Tajikistan*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From January to February 2017, 534 stakeholders of the WBG in Tajikistan were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the office of the President/Prime Minister, office of a Minister, office of a Parliamentarian, employees of ministries/ministerial departments/implementation agencies, Project Management Units (PMUs) overseeing implementation of WBG projects or consultants/contractors working on WBG-supported projects/programs, local government office or staff, bilateral/multilateral agencies, private sector organizations, the financial sector/private banks, civil society organizations, the media, independent government institutions, academia/research institutes/think tanks, and the judiciary branch.

A total of 362 stakeholders participated in the survey (68% response rate). Respondents either received the questionnaire via courier and returned it accordingly, received an invitation via email and completed the questionnaire online, or completed the questionnaire with a representative from the fielding agency.

Every country that engages in the Country Opinion Survey must include specific indicator questions that will be aggregated for the WBG's annual Corporate Scorecard. These questions are identified throughout the survey report.

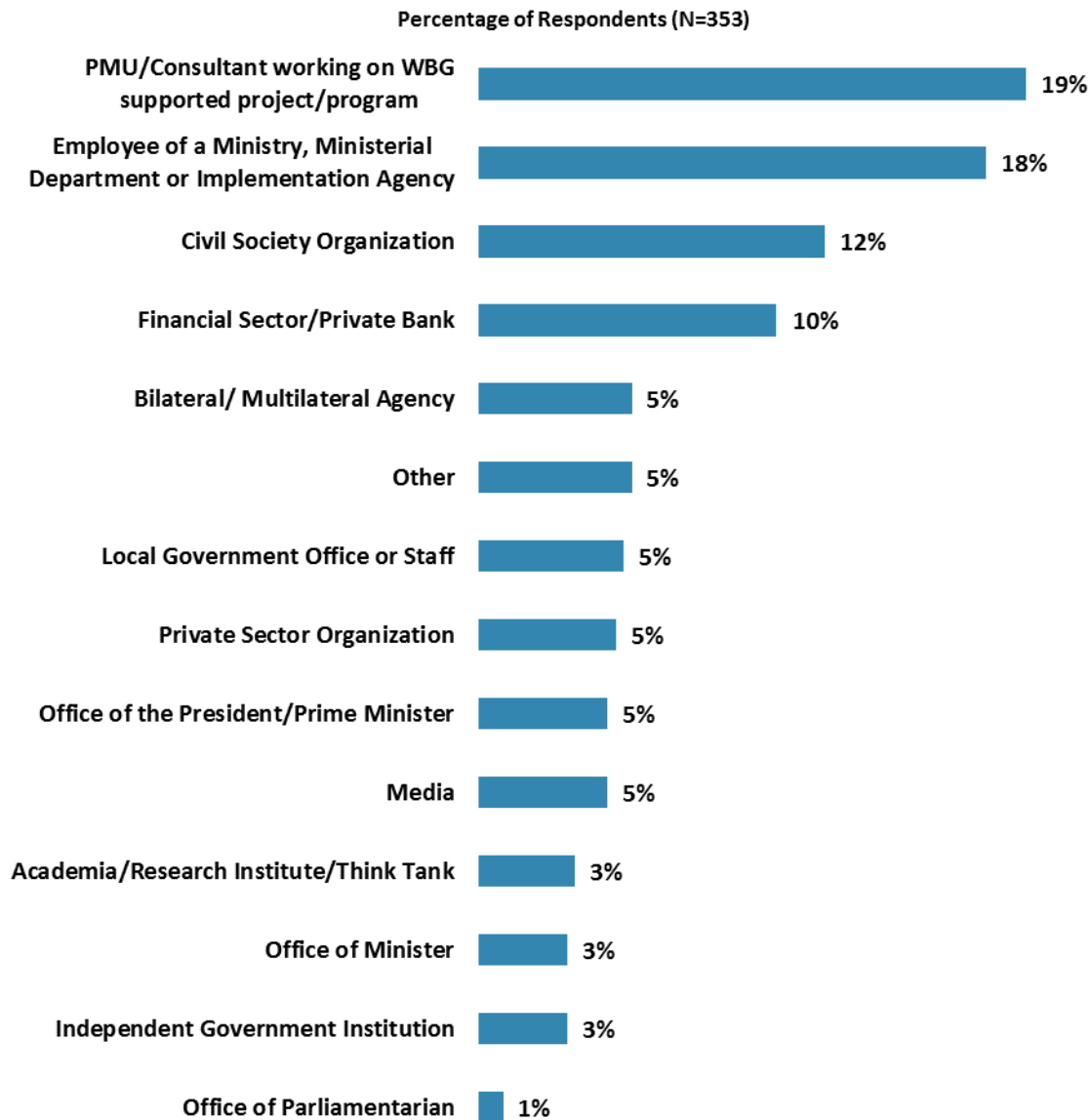
The results of this year's Country Survey were compared to those in the Country Survey conducted in FY '14 (response rate was 57%, N = 272). The data were weighted to reach similar stakeholder compositions across the two survey years, allowing for more statistically reliable comparisons. Note, there were insufficient numbers of respondents from the office of the President/Prime Minister in FY '14 to be included in these analyses. Also, stakeholders who identified themselves as "Other" in the stakeholder category options were not included in these comparisons. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY '14 COS report and the non-weighted data presented in this report. 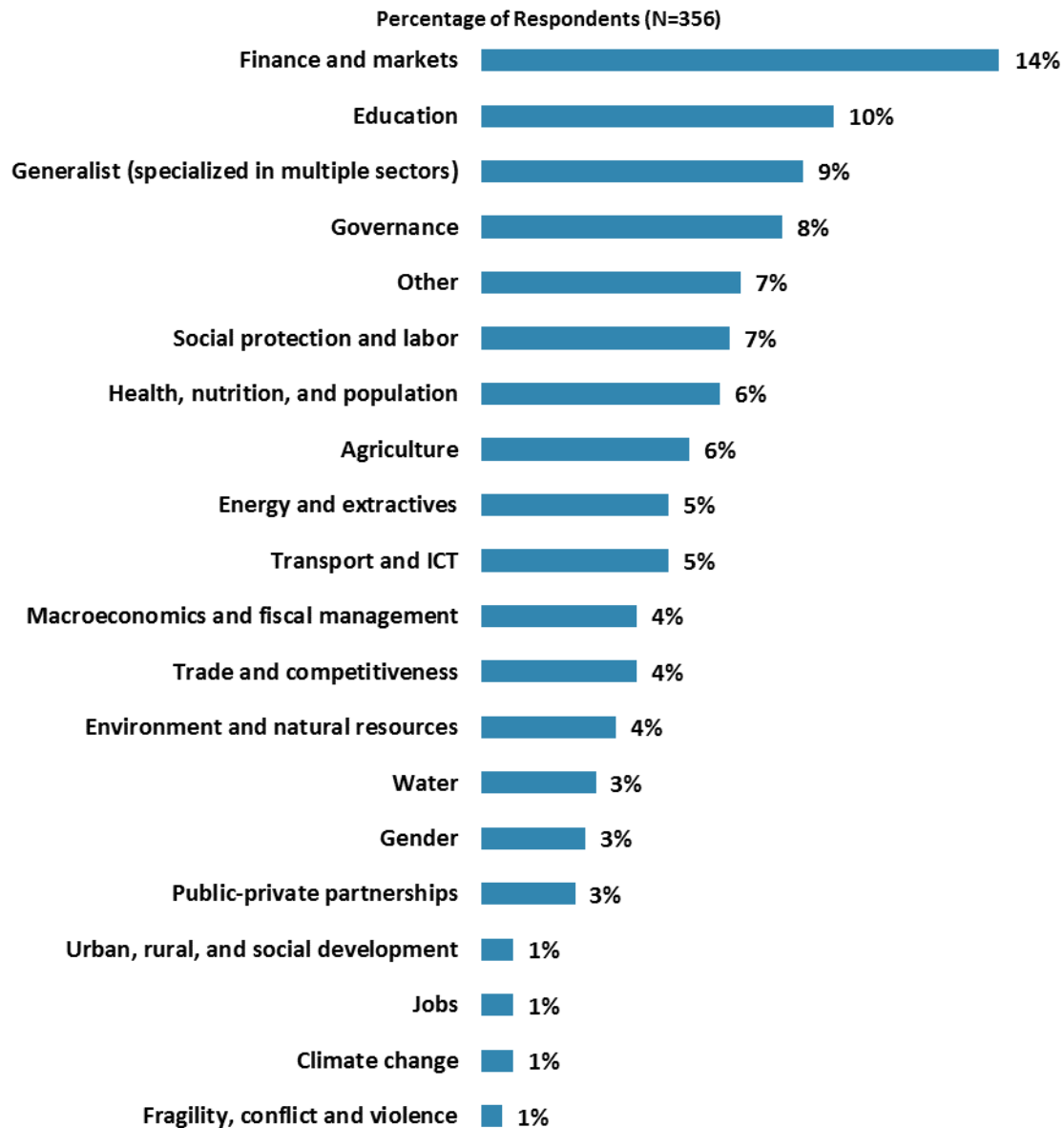


“Which of the following best describes your current position? (Select only ONE response)”

Area of Primary Specialization



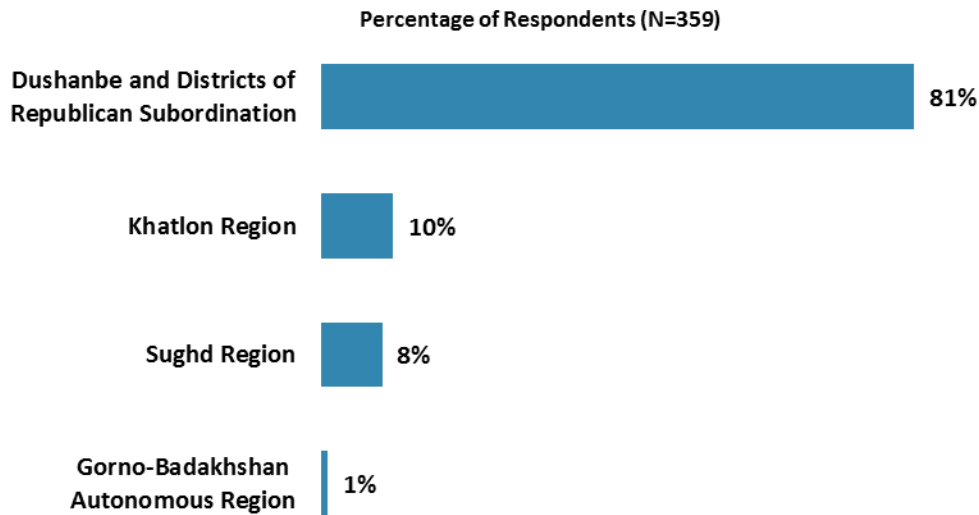
"Please identify the primary specialization of your work. (Select only ONE response)"

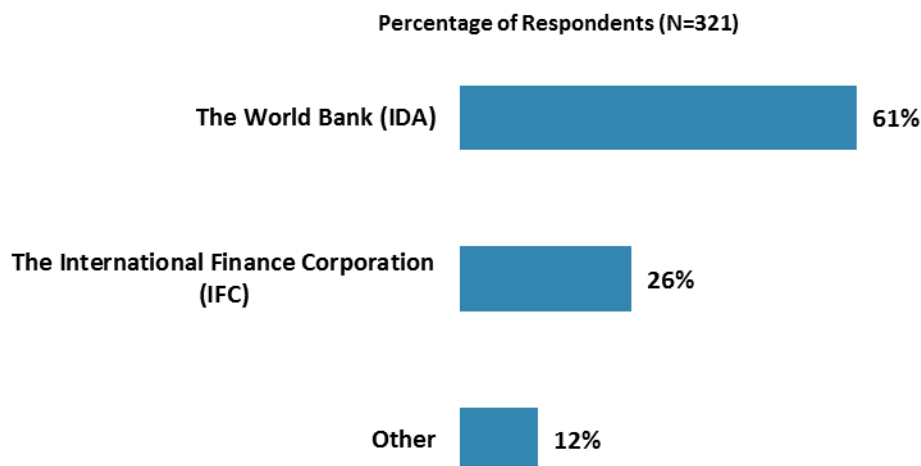
Geographic Locations

Exposure to Agencies within the World Bank Group



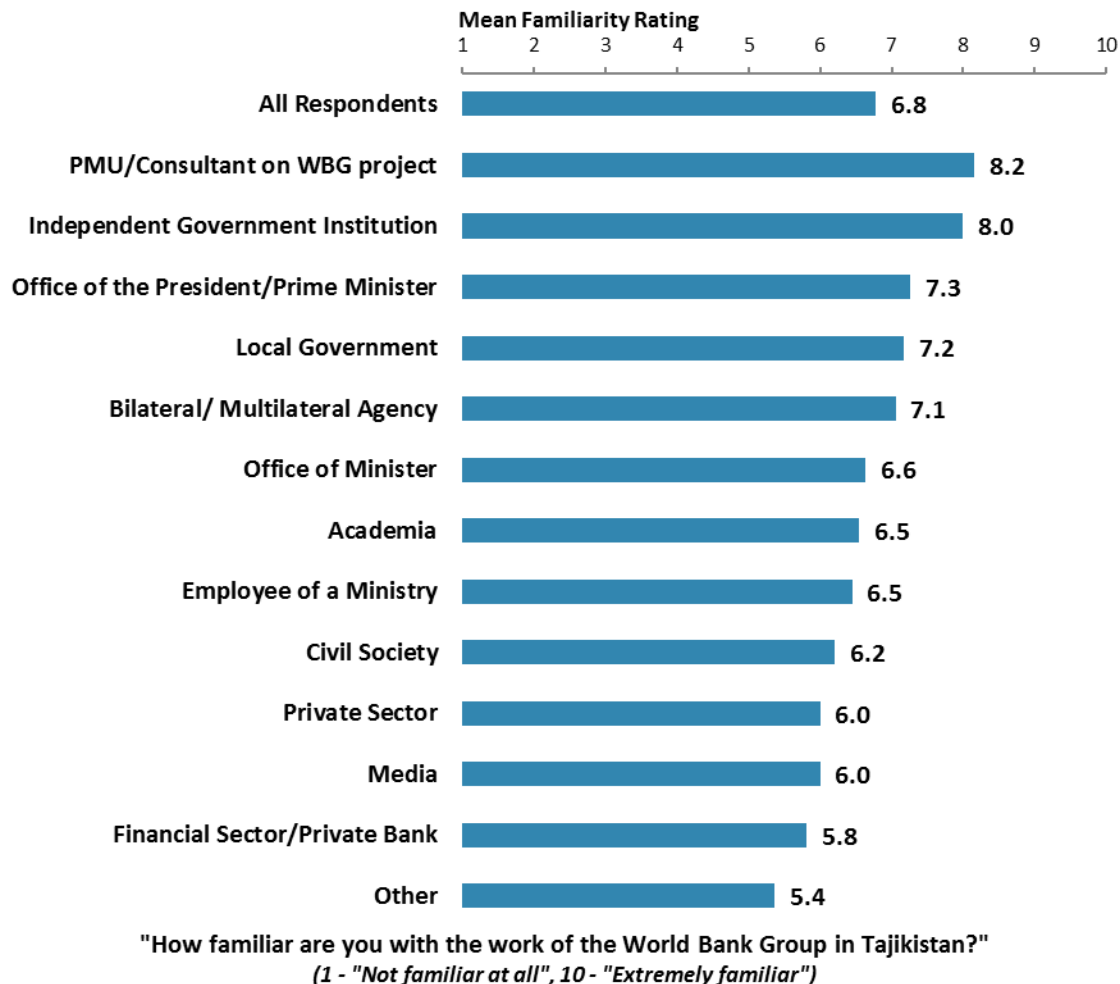
“Which of the following agencies of the World Bank Group do you primarily engage with in Tajikistan? (Select only ONE response)” (Respondents choose from a list)



III. Demographics of the Sample (continued)

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey indicated significantly higher levels of familiarity with the WBG compared to respondents from the FY '14 Country Survey (weighted mean in FY '17 = 6.6; weighted mean in FY '14 = 5.3)¹.
- **Collaboration:** Respondents who collaborate with the WBG gave significantly higher ratings of familiarity with the WBG (mean rating = 7.6) than respondents who do not collaborate with the WBG (mean rating = 5.3).
- **Impact of Familiarity:** Respondents' ratings of familiarity with the WBG were strongly, significantly correlated with their ratings of the WBG's overall effectiveness in Tajikistan, and moderately, significantly, correlated with the extent to which the WBG's work helps to achieve development results and the extent to which the WBG plays a relevant role in development in Tajikistan.



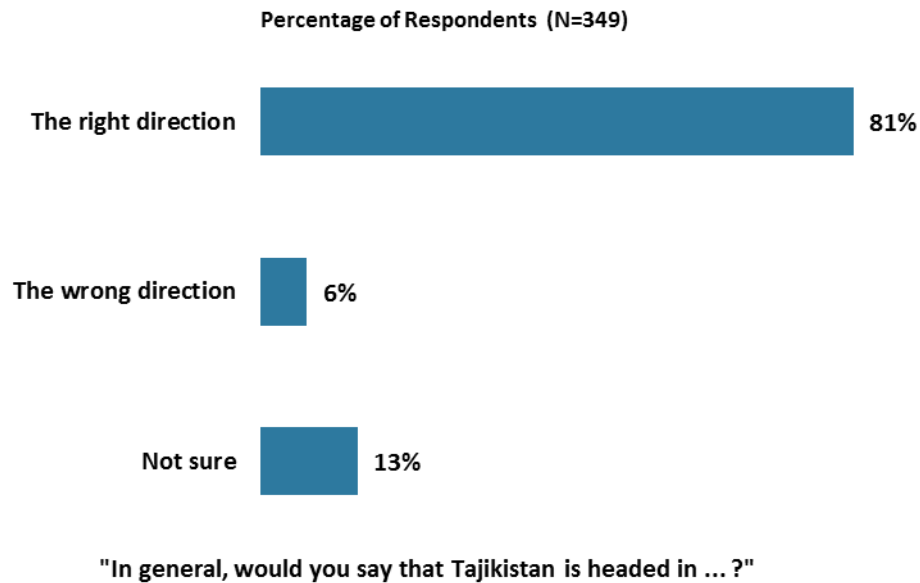

IV. General Issues Facing Tajikistan

Headed in the Right Direction

- **Year comparison:** A plurality of respondents in the FY '14 Country Survey indicated that Tajikistan was headed in the right direction (percentage of respondents = 46%), with smaller numbers indicating that Tajikistan was headed in the wrong direction (19%) or that they were not sure (35%).

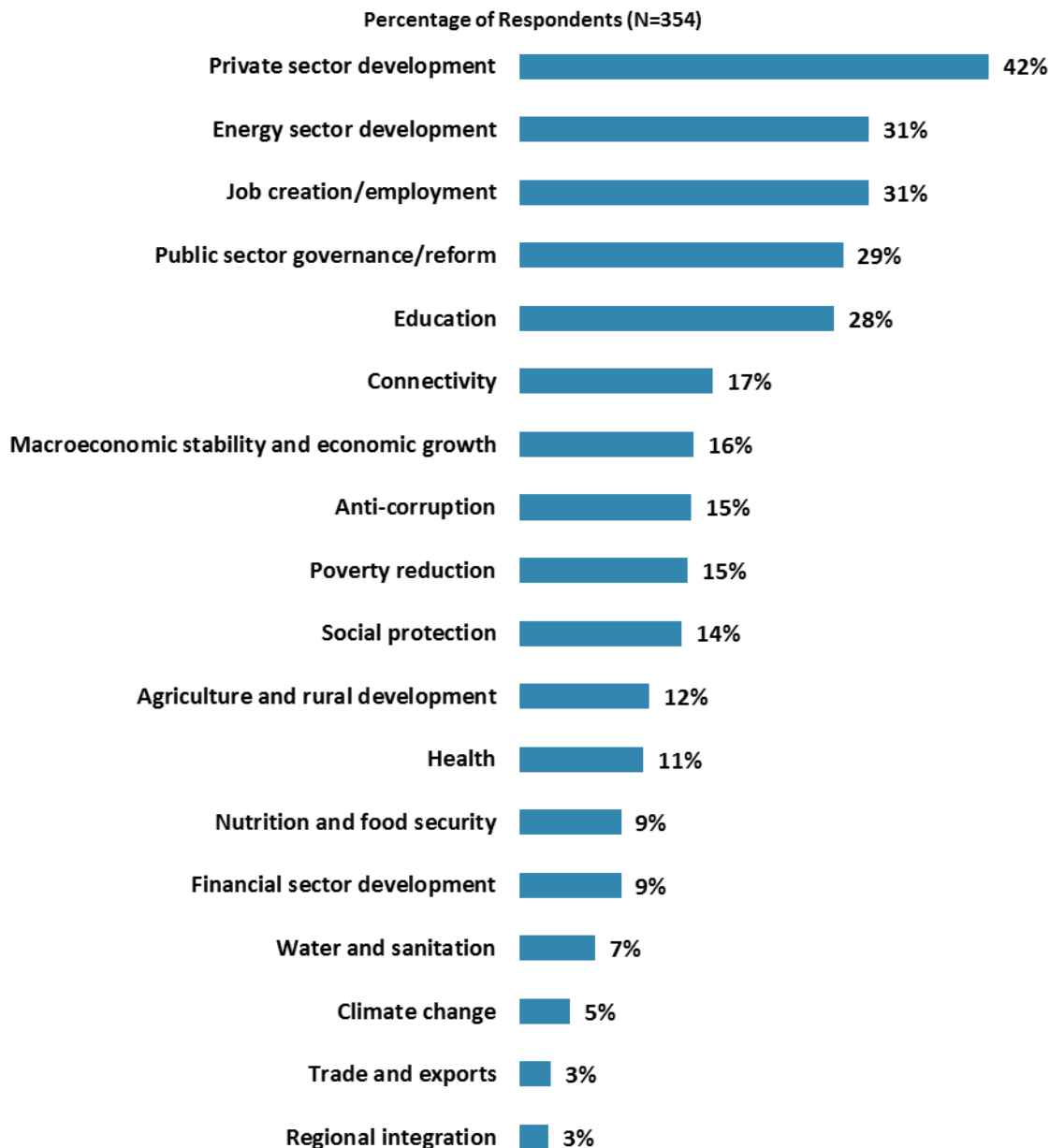




IV. General Issues Facing Tajikistan (continued)

Development Priority

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that the most important development priorities in Tajikistan were quality public services (percentage of respondents = 40%) and anti-corruption (36%), followed by public sector governance/reform (28%), job creation/employment (28%), and economic growth (27%).



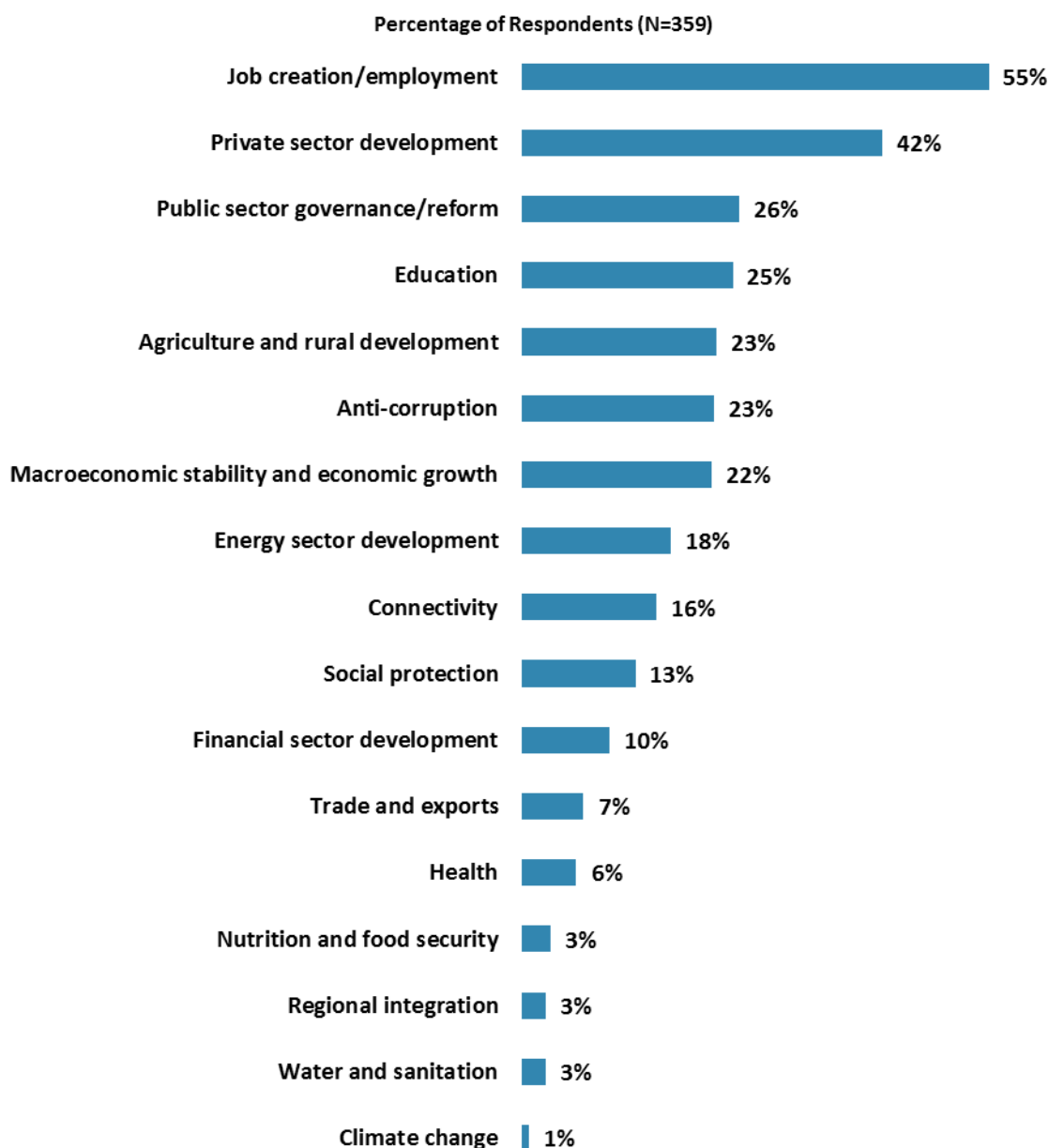

Factors Contributing to Poverty Reduction

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that the areas that would contribute most to poverty reduction in Tajikistan were anti-corruption (percentage of respondents = 50%) and job creation/employment (49%), followed by economic growth (37%).



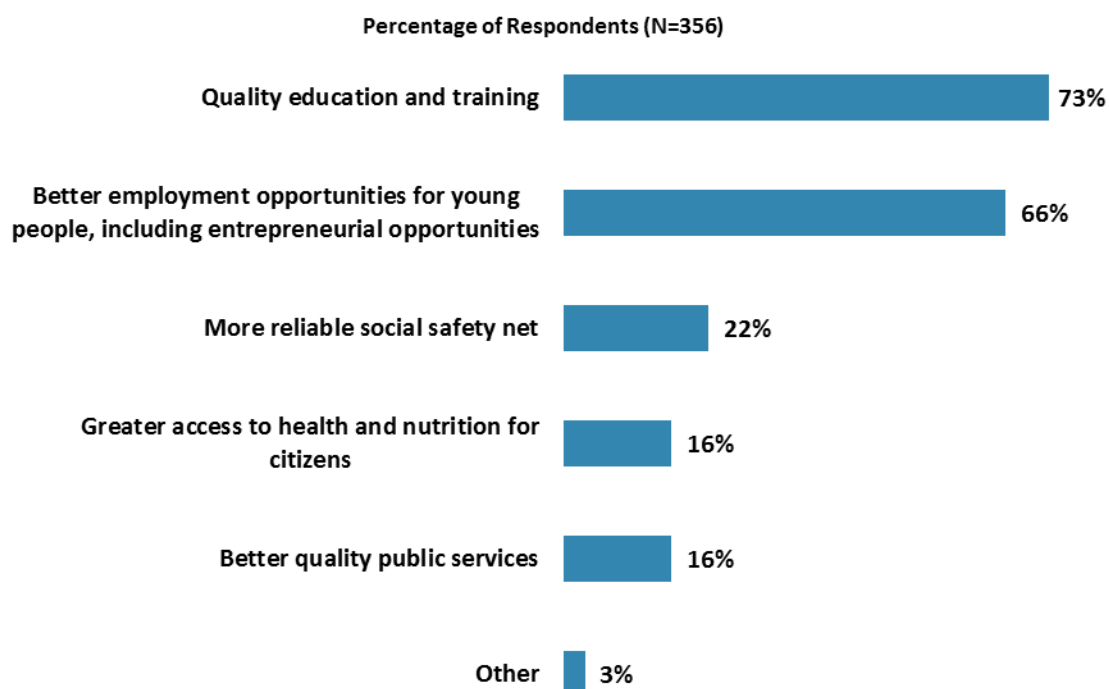

Factors Contributing to “Shared Prosperity”

- **Year comparison:** Respondents in the FY ‘14 Country Survey indicated that the areas that would best illustrate how “shared prosperity” would be achieved in Tajikistan were education and training that better ensure job opportunity (percentage of respondents = 38%), better entrepreneurial opportunities (31%), better employment for young people (29%), and consistent economic growth (28%).

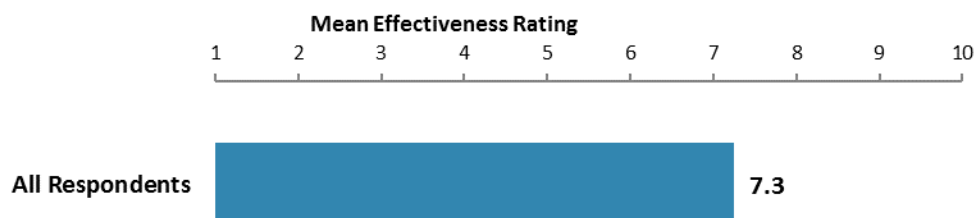


V. Overall Attitudes toward the World Bank Group

As noted in the “Methodology” section, the indicator questions referred to throughout the survey report are questions that are asked in every country that engages in the Country Opinion Survey. These will be aggregated for the World Bank Group’s annual Corporate Scorecard.

The World Bank Group’s Overall Effectiveness (*Indicator Question*)

- **Year comparison:** Respondents in this year’s Country Survey gave statistically similar ratings for the WBG’s overall effectiveness in Tajikistan (weighted mean = 7.0) compared to respondents from the FY ‘14 Country Survey (weighted mean = 6.6)².
- **Stakeholders:** Respondents from PMUs/Consultants on WBG-supported projects gave the highest mean ratings for the WBG’s overall effectiveness in Tajikistan whereas respondents from the media gave significantly lower mean ratings.
- **Collaboration:** Respondents who are collaborating with the WBG gave significantly higher ratings for the WBG’s overall effectiveness in Tajikistan (mean rating = 7.6) compared to respondents who are not collaborating (mean rating = 6.5).



"Overall, please rate your impression of the World Bank Group’s effectiveness in Tajikistan." (1 - "Not effective at all", 10 - "Very effective")

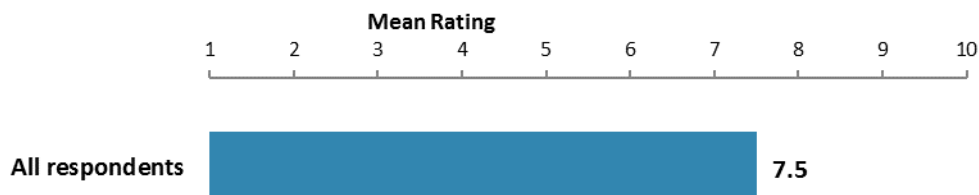

Achieving Development Results (*Indicator Question*)

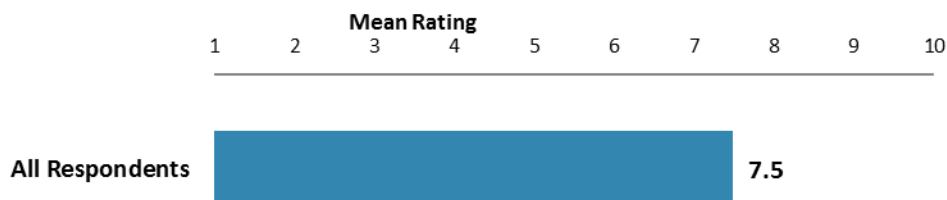
- **Year comparison:** Respondents in this year's Country Survey gave statistically similar ratings for the extent to which the WBG achieves development results (weighted mean = 7.4) compared to respondents from the FY '14 Country Survey (weighted mean = 7.2)³.
- **Stakeholders:** Respondents from local government gave the highest ratings for the extent to which the WBG achieves development results whereas respondents from bilateral/multilateral agencies gave significantly lower mean ratings.

WBG Staff Preparedness

- **Year comparison:** Respondents in this year's Country Survey gave statistically similar ratings for the WBG's staff being well prepared (weighted mean = 7.3) compared to respondents from the FY '14 Country Survey (weighted mean = 7.7)³.
- **Stakeholders:** Respondents from PMUs/Consultants on WBG-supported projects and local government gave the highest ratings for the WBG's staff being well prepared whereas respondents from bilateral/multilateral agencies and the media gave significantly lower mean ratings.
- **Collaboration:** Respondents who are collaborating with the WBG gave significantly higher ratings for the WBG's staff being well prepared (mean rating = 7.7) compared to respondents who are not collaborating (mean rating = 7.1).

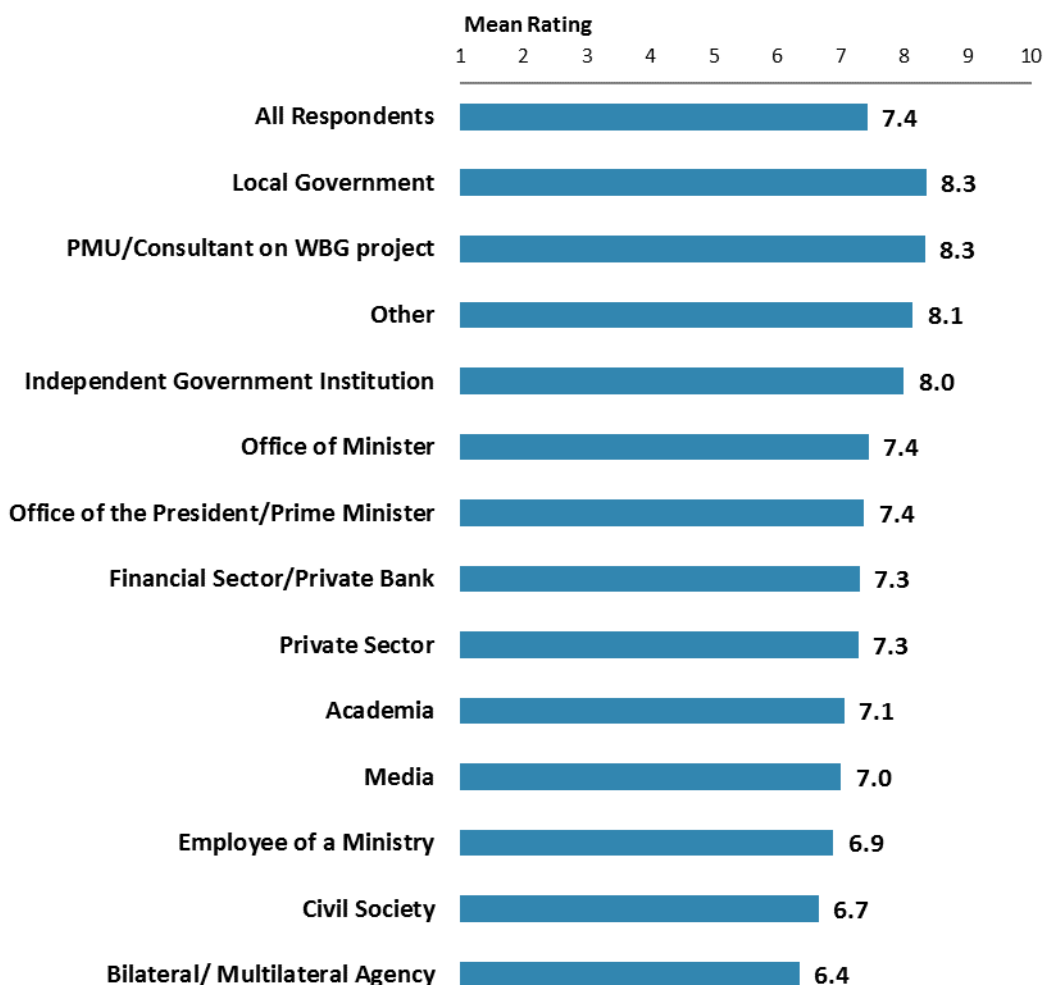

Overall Ratings for Indicator Questions by Stakeholder Groups

- **Stakeholders:** Respondents from local government and PMUs/Consultants on WBG-supported projects had the highest mean ratings for the aggregated responses to the twenty-six COS indicator questions whereas respondents from bilateral/multilateral agencies and civil society had significantly lower mean ratings. Responses for individual indicator questions by stakeholder groups can be found in Appendix B (see page 52).
- **Collaboration:** Respondents who collaborate with the WBG had a significantly higher mean rating for the aggregated responses to the twenty-six COS indicator questions (mean rating = 7.6) compared to respondents who do not collaborate with the WBG (mean rating = 7.2). Responses for individual indicator questions by exposure to the WBG can be found in Appendix F (see page 79).



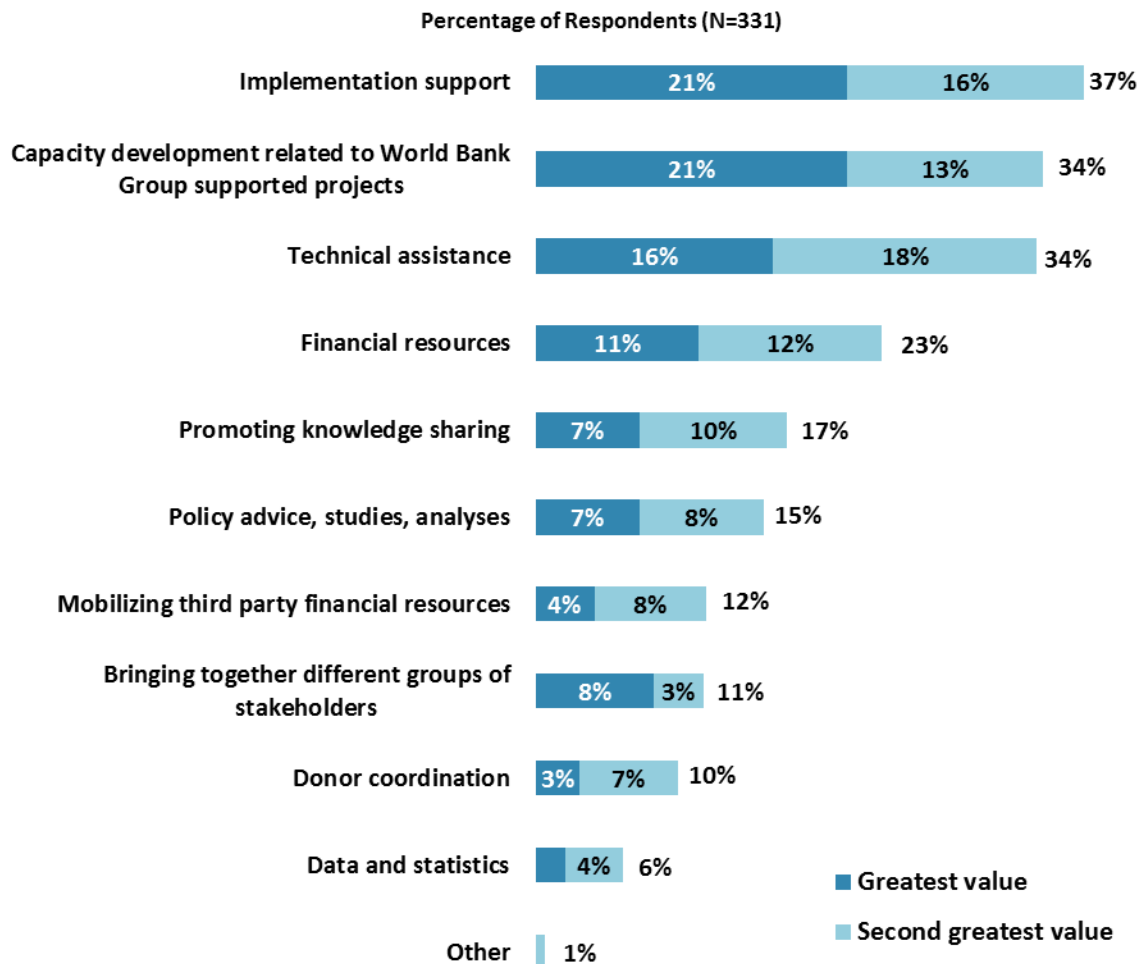
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

Greatest Value

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that the WBG's greatest value to Tajikistan was its financial resources (percentage of respondents = 73%), followed by its technical assistance (30%) and capacity development (25%).

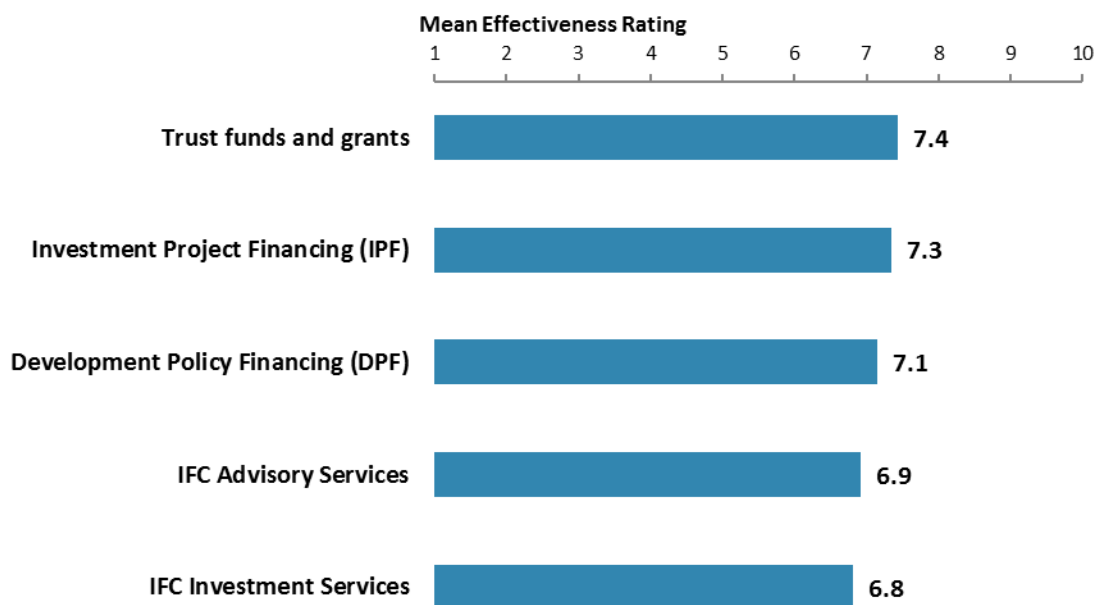

Effectiveness of WBG's Instruments in Reducing Poverty



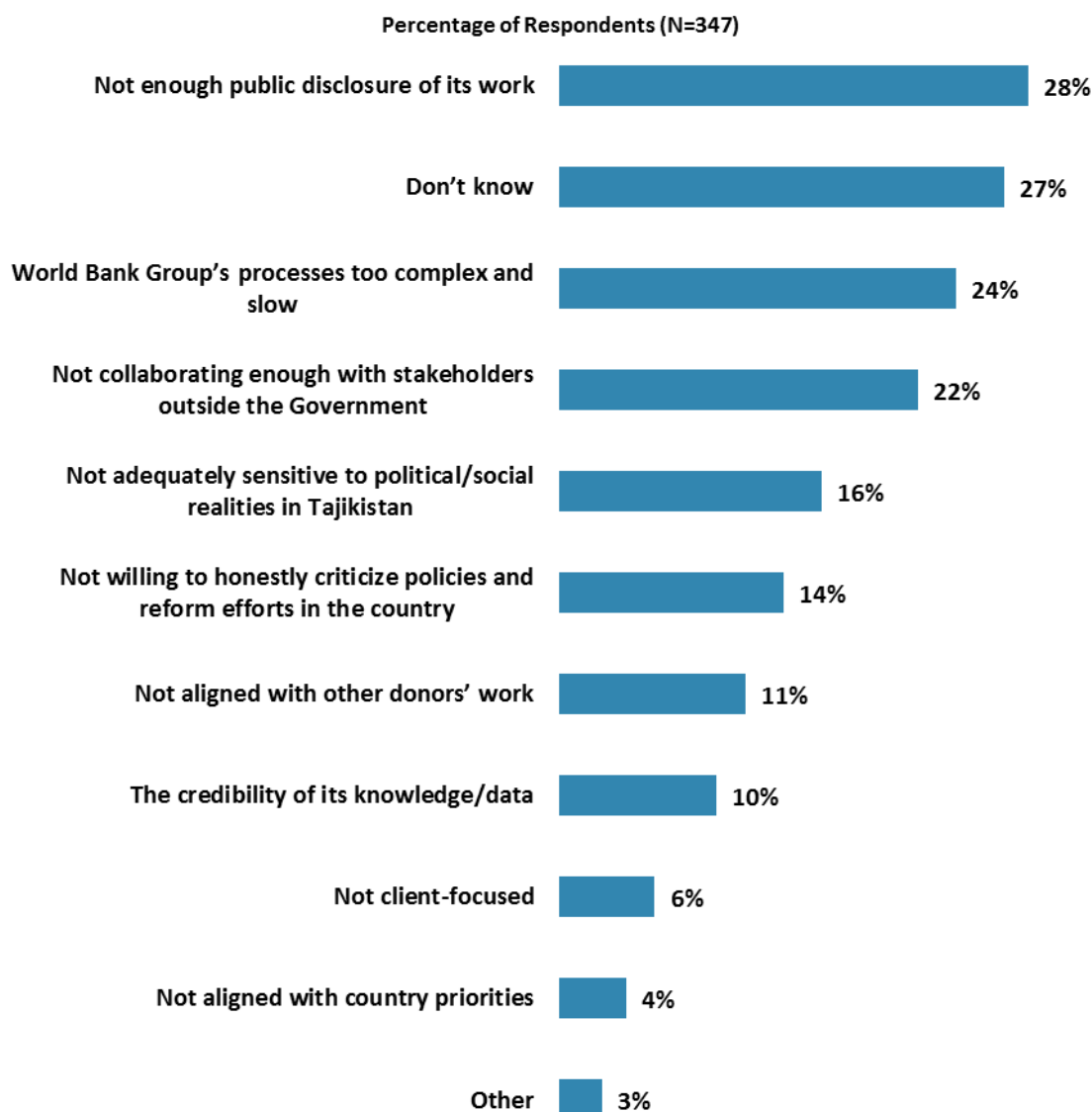
"How EFFECTIVE do you believe the following World Bank Group's instruments are in supporting the Tajikistan Government's efforts to reduce poverty?"

Greatest Weakness

- **Year comparison:** A plurality of respondents in the FY '14 Country Survey indicated that they didn't know what the WBG's greatest weakness was (percentage of respondents = 29%). This was followed by respondents indicating that not collaborating enough with non-state actors (22%), not enough public disclosure of its work (22%) and not being willing to honestly criticize policies and reform efforts in Tajikistan (20%) were the WBG's greatest weakness in its work in Tajikistan.



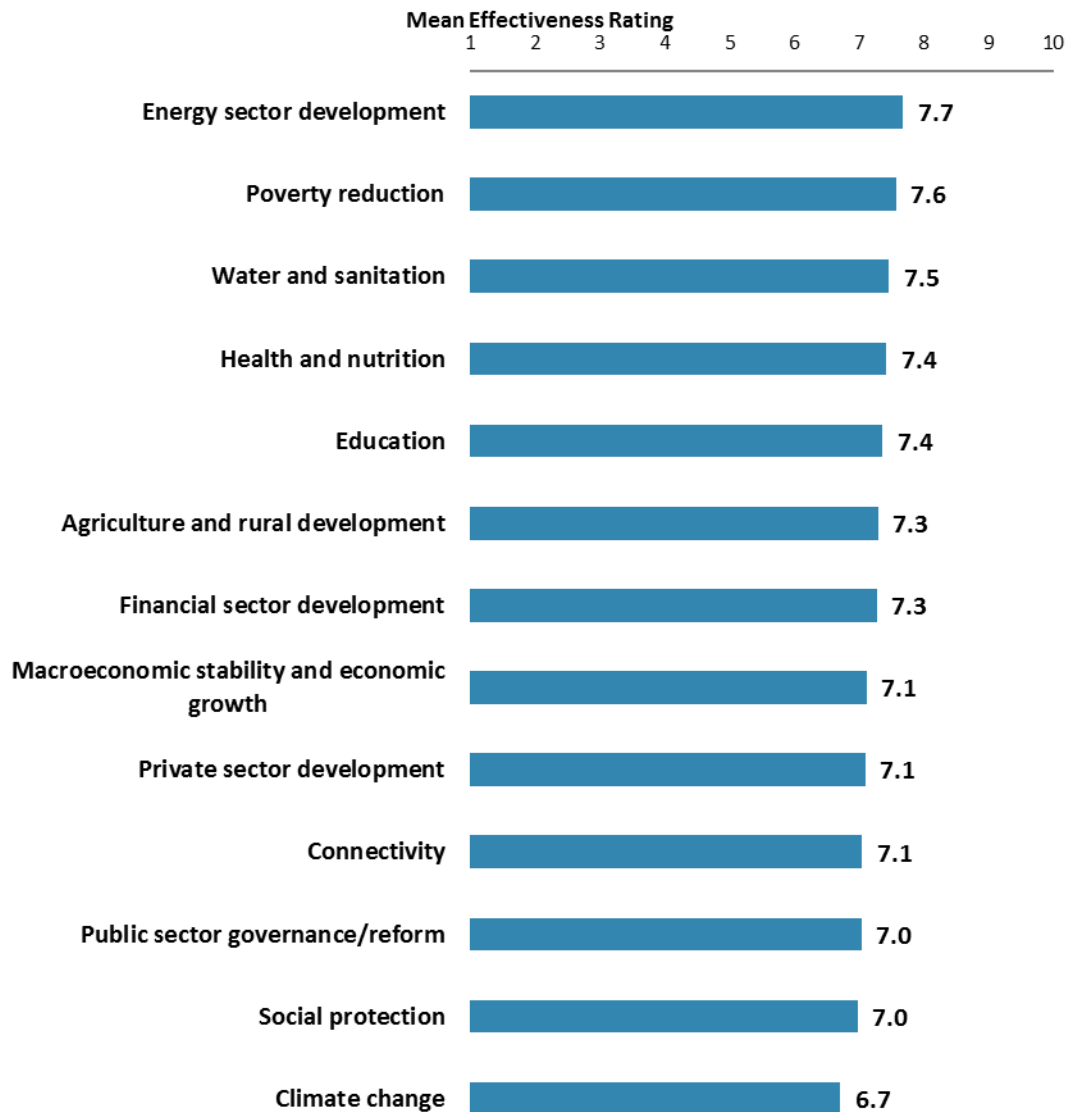

VI. Sectoral Effectiveness

Effectiveness of WBG's Support in Sectoral Areas

- **Collaboration:** Respondents who are collaborating with the WBG gave significantly higher ratings for the WBG's effectiveness at "*Macroeconomic stability and economic growth*" (mean rating = 7.4) compared to respondents who are not collaborating (mean rating = 6.6).

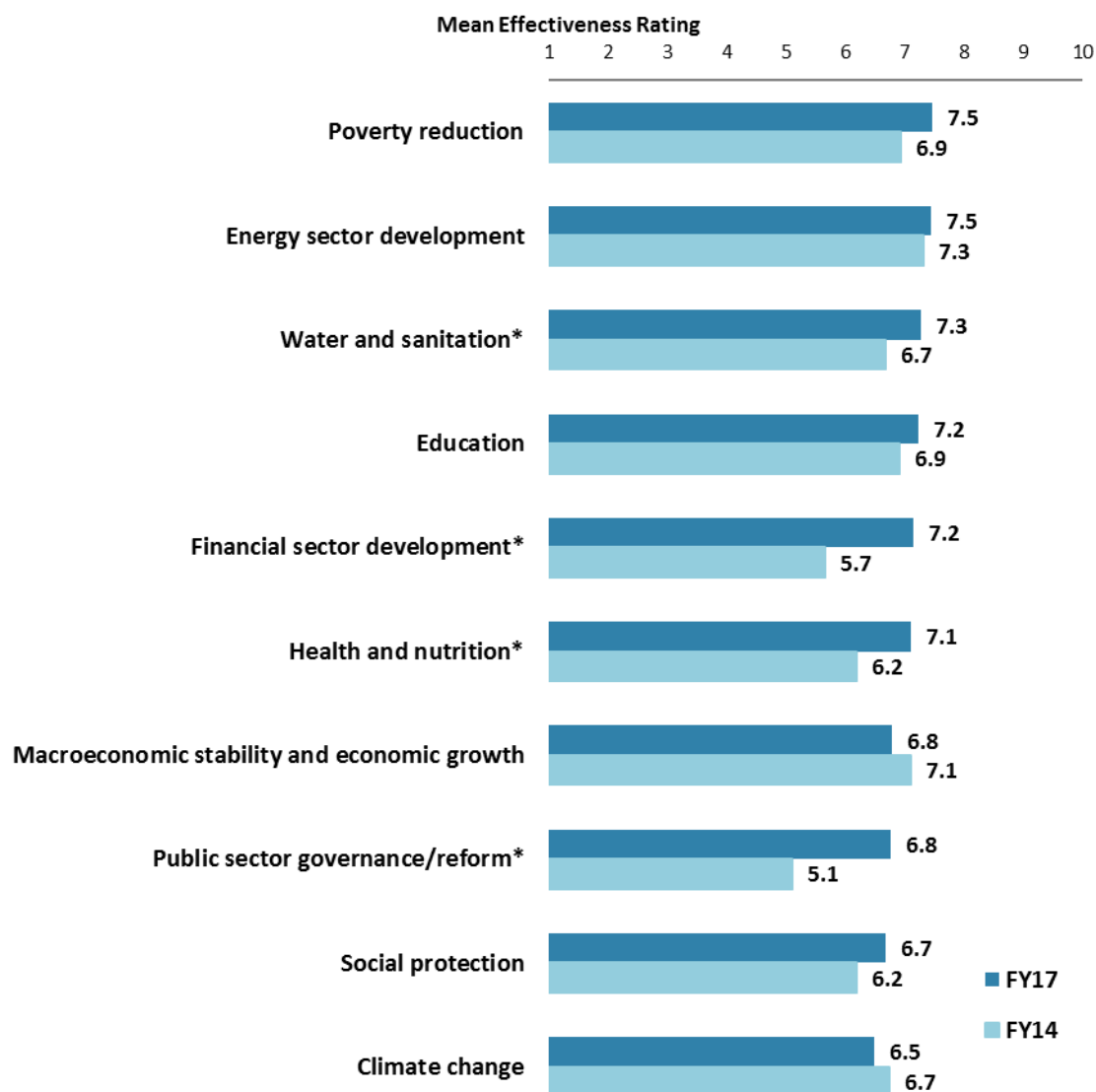

Effectiveness of WBG's Support in Sectoral Areas: Year Comparison⁴



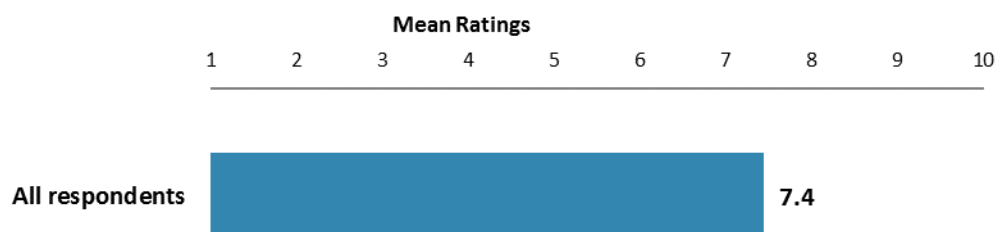

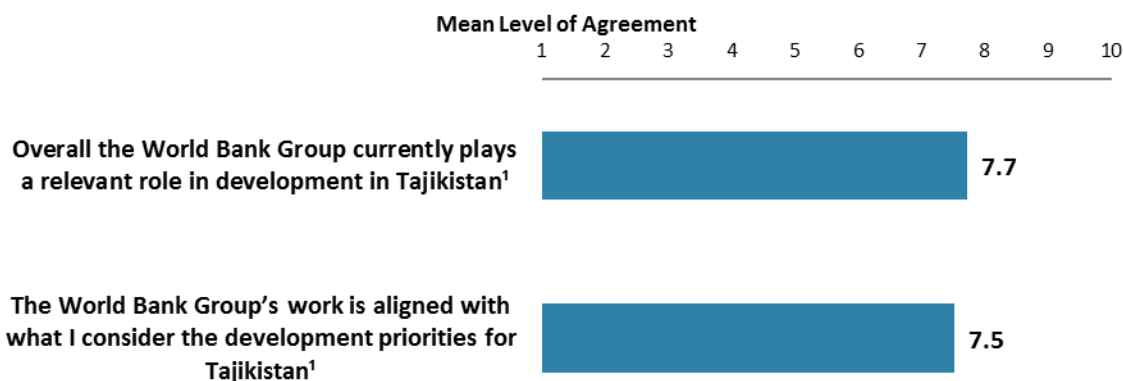
"To what extent do you believe that the World Bank Group's work helps to find solutions that promote private public partnerships in Tajikistan?"

VII. How the World Bank Group Operates

The World Bank Group's Work in Tajikistan

- **Stakeholders:** Respondents from local government, PMUs/Consultants on WBG-supported projects, and independent government institutions had the highest levels of agreement that *“Overall the World Bank Group currently plays a relevant role in development in Tajikistan”* whereas respondents from bilateral/multilateral agencies and the media had significantly lower mean ratings. Respondents from local government, PMUs/Consultants on WBG-supported projects, and independent government institutions had the highest levels of agreement that *“The WBG’s work is aligned with what I consider the development priorities for Tajikistan”* whereas respondents from the office of the President/Prime Minister, bilateral/multilateral agencies, and the media had significantly lower mean ratings. 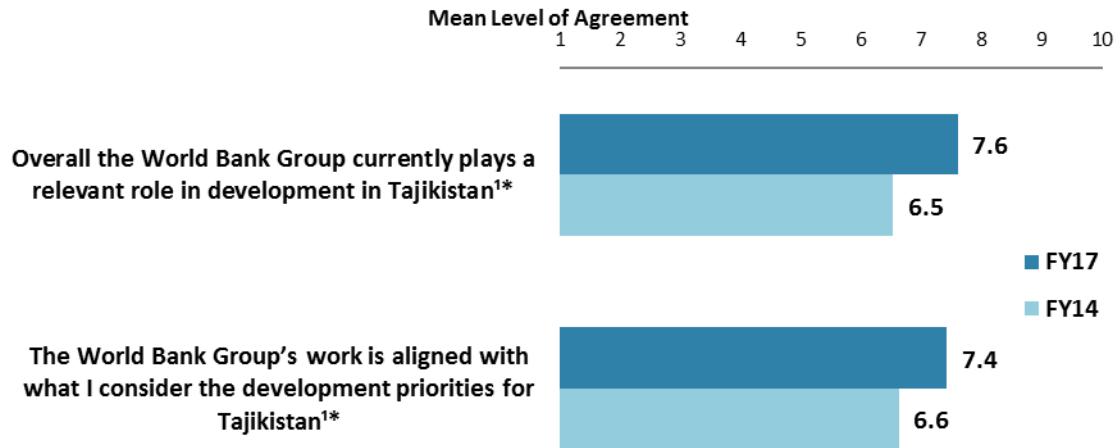

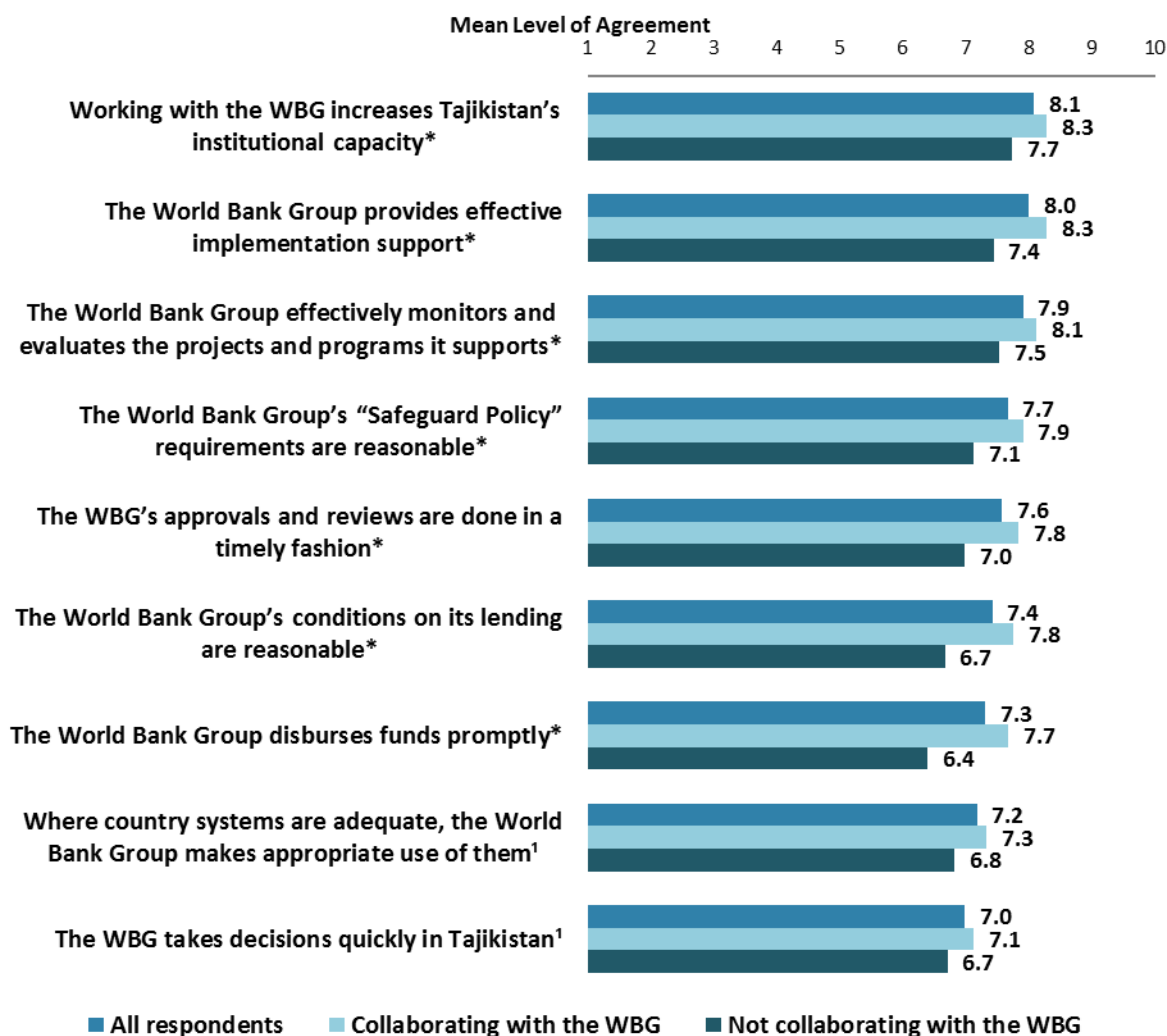

Overall Perceptions

- **Stakeholders:** There were significant differences between stakeholder groups in their levels of agreement across all of these aspects of how the WBG operates. For the most part, respondents from PMUs/Consultants on WBG-supported projects tended to have the highest levels of agreement whereas respondents from bilateral/multilateral agencies tended to have significantly lower levels of agreement (refer to Appendix B, page 52, for a complete breakdown).



"To what extent do you agree/disagree with the following statements?"

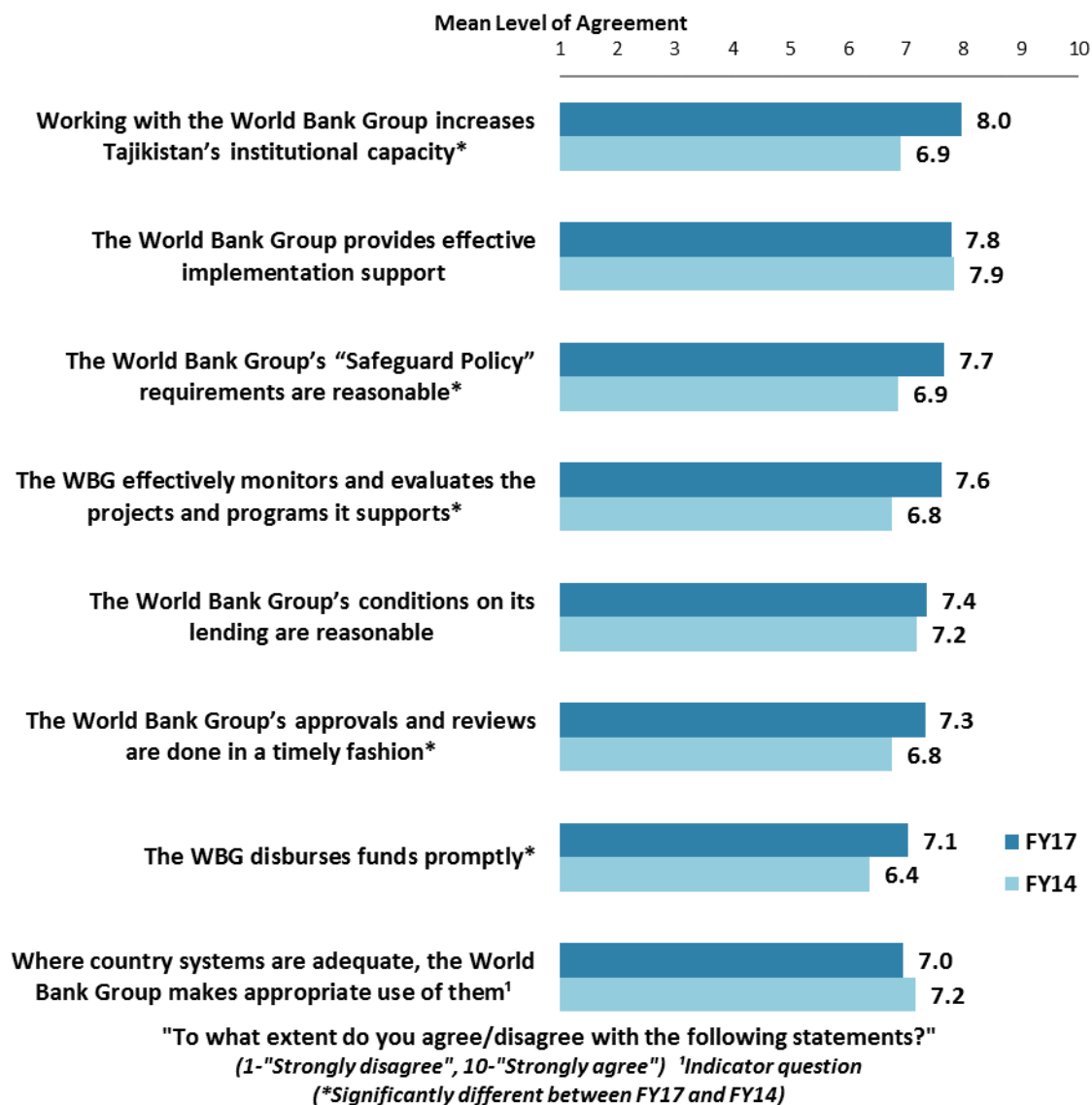

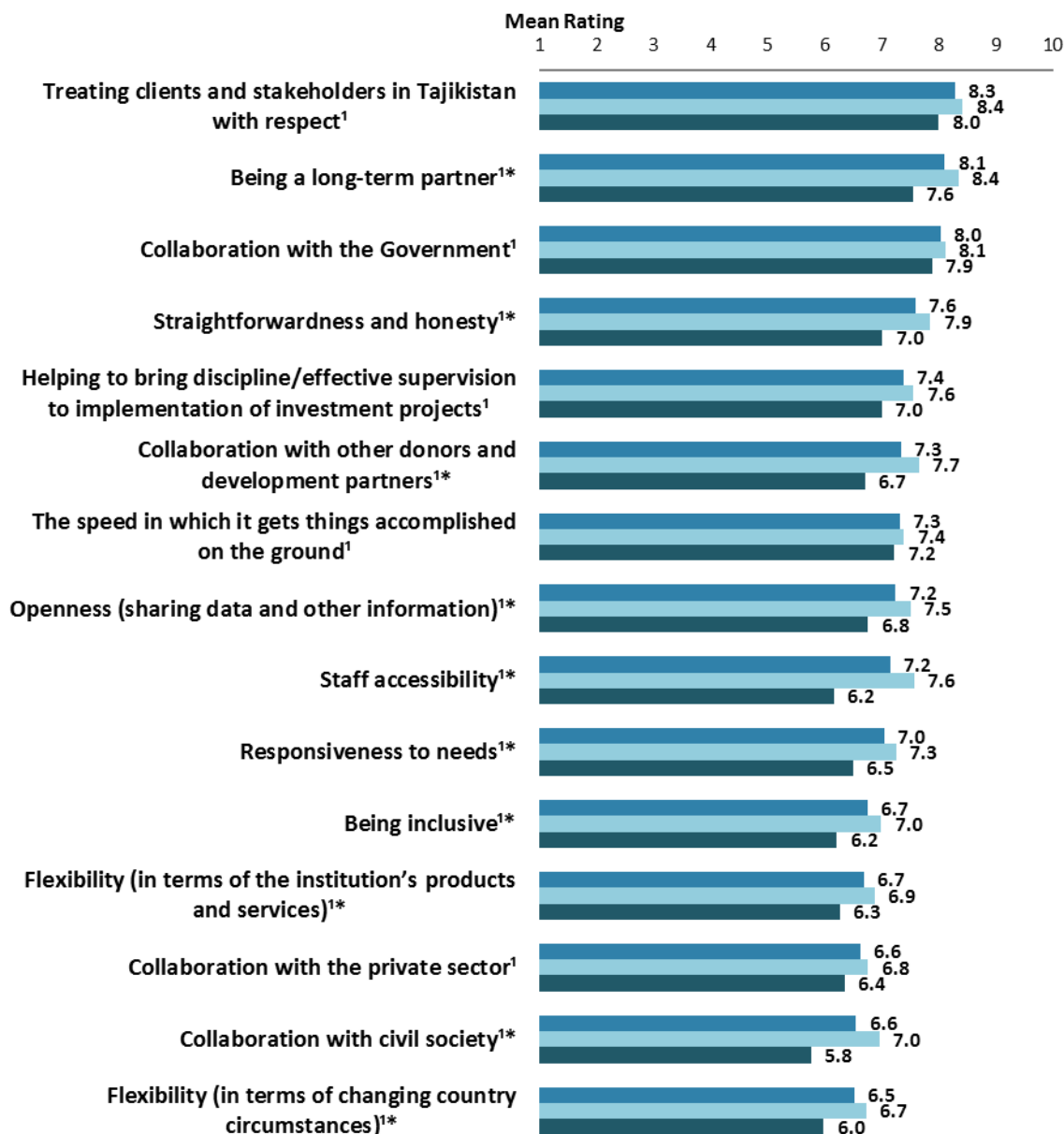

The WBG as an Effective Development Partner

- **Stakeholders:** There were significant stakeholder group differences across all but one of these aspects of how the WBG operates in Tajikistan (see Appendix B, page 52). For the most part, respondents from local government and PMUs/Consultants on WBG-supported projects tended to give the highest ratings whereas respondents from bilateral/multilateral agencies and civil society tended to give significantly lower ratings.



■ All respondents ■ Collaborating with the WBG ■ Not collaborating with the WBG

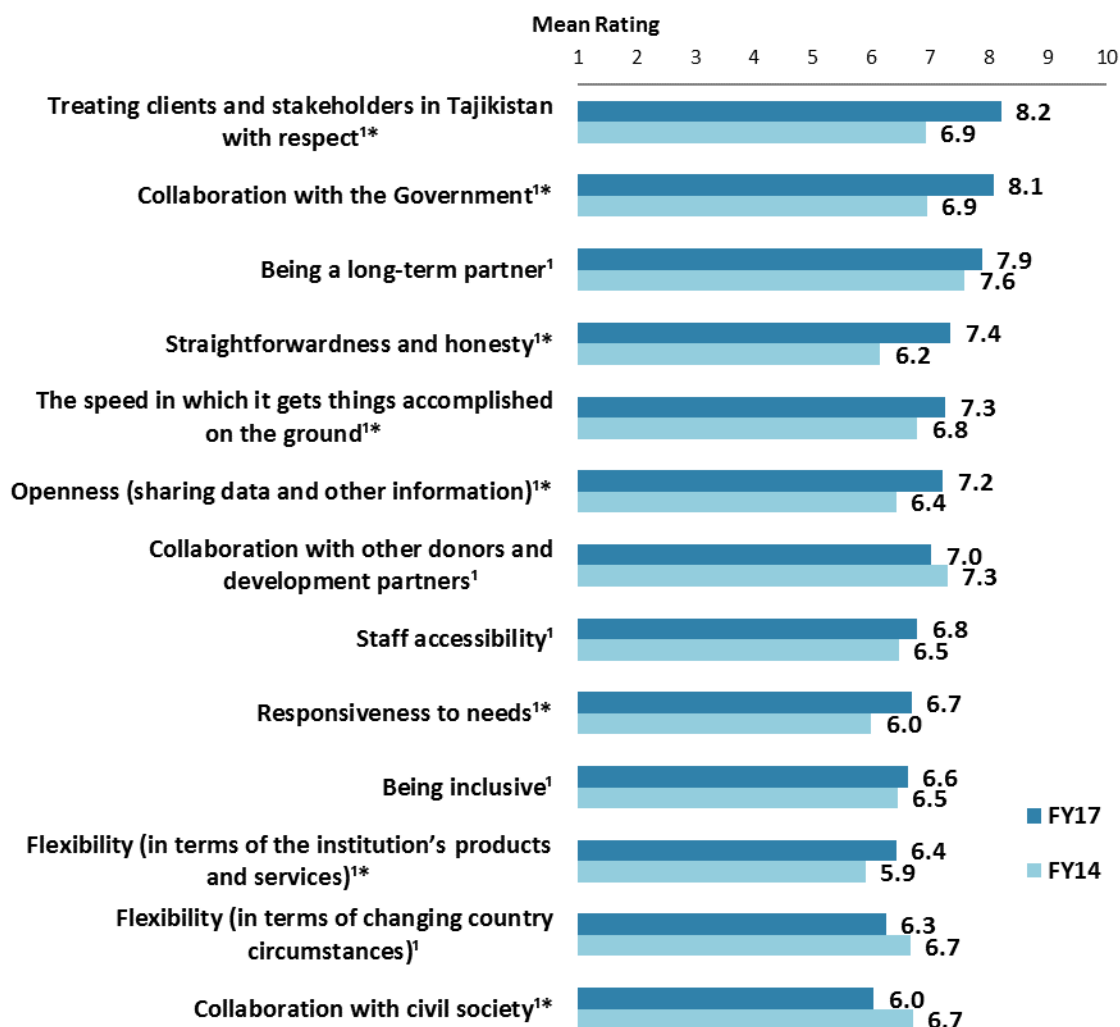

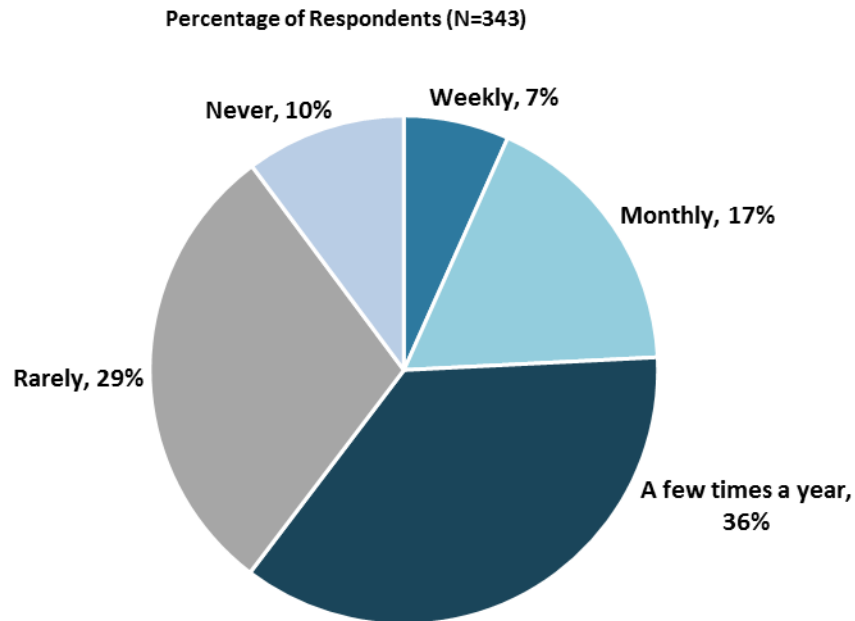

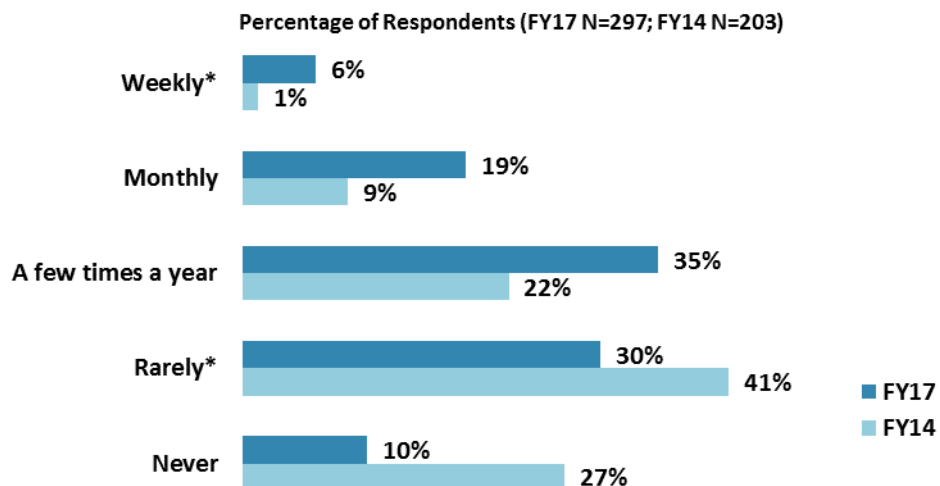
Frequency of Consulting WBG Knowledge Work and Activities

- **Stakeholders:** Respondents from PMUs/Consultants on WBG-supported projects indicated the most frequent usage of the WBG's knowledge work (percentage of respondents = 46% weekly/monthly) whereas employees of ministries indicated significantly less frequent usage (59% rarely/never).

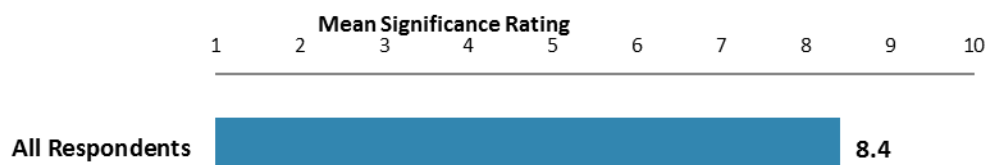
Meeting Tajikistan's Knowledge Needs (*Indicator Question*)

- **Year comparison:** Respondents in this year's Country Survey had significantly higher levels of agreement that the WBG meets Tajikistan's needs for knowledge services (weighted mean = 7.1) compared to respondents from the FY '14 Country Survey (weighted mean = 6.3)⁹.
- **Stakeholders:** Respondents from local government and other organizations had the highest levels of agreement that the WBG meets Tajikistan's needs for knowledge services whereas respondents from bilateral/multilateral agencies had significantly lower levels of agreement.



Contribution of the WBG's Knowledge Work and Activities (*Indicator Question*)

- **Year comparison:** Respondents in this year's Country Survey gave statistically similar ratings for the significance of the contribution of the WBG's knowledge work and activities (weighted mean = 8.4) compared to respondents from the FY '14 Country Survey (weighted mean = 8.0)⁹.
- **Stakeholders:** Respondents from local government and independent government institutions gave the highest ratings for the significance of the contribution of the WBG's knowledge work and activities whereas respondents from bilateral/multilateral agencies gave significantly lower ratings.
- **Location:** Respondents from Other Areas gave significantly higher ratings for the significance of the contribution of the WBG's knowledge work and activities (mean rating = 8.9) compared to respondents from Dushanbe and Districts of Republican Subordination (mean rating = 8.3).



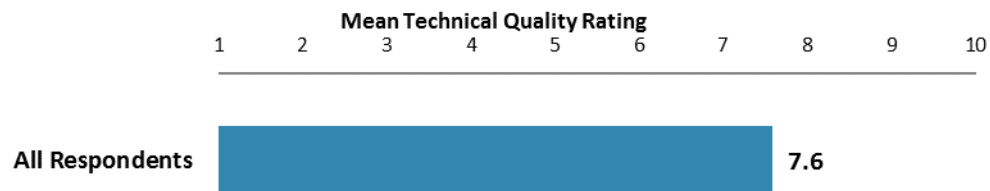

Qualities of the WBG's Knowledge Work and Activities

- **Stakeholders:** There were significant stakeholder group differences across all but two of these aspects of the WBG's knowledge work and activities (see Appendix B, page 52). For the most part, respondents from local government, PMUs/Consultants on WBG-supported projects, and other organizations tended to give the highest ratings whereas respondents from the office of a Minister, bilateral/multilateral agencies, and employees of ministries tended to give significantly lower ratings.
- **Collaboration:** Respondents who are collaborating with the WBG gave significantly higher ratings for the extent to which the WBG's knowledge work and activities "Are accessible" (mean rating = 7.5) compared to respondents who are not collaborating (mean rating = 6.9).

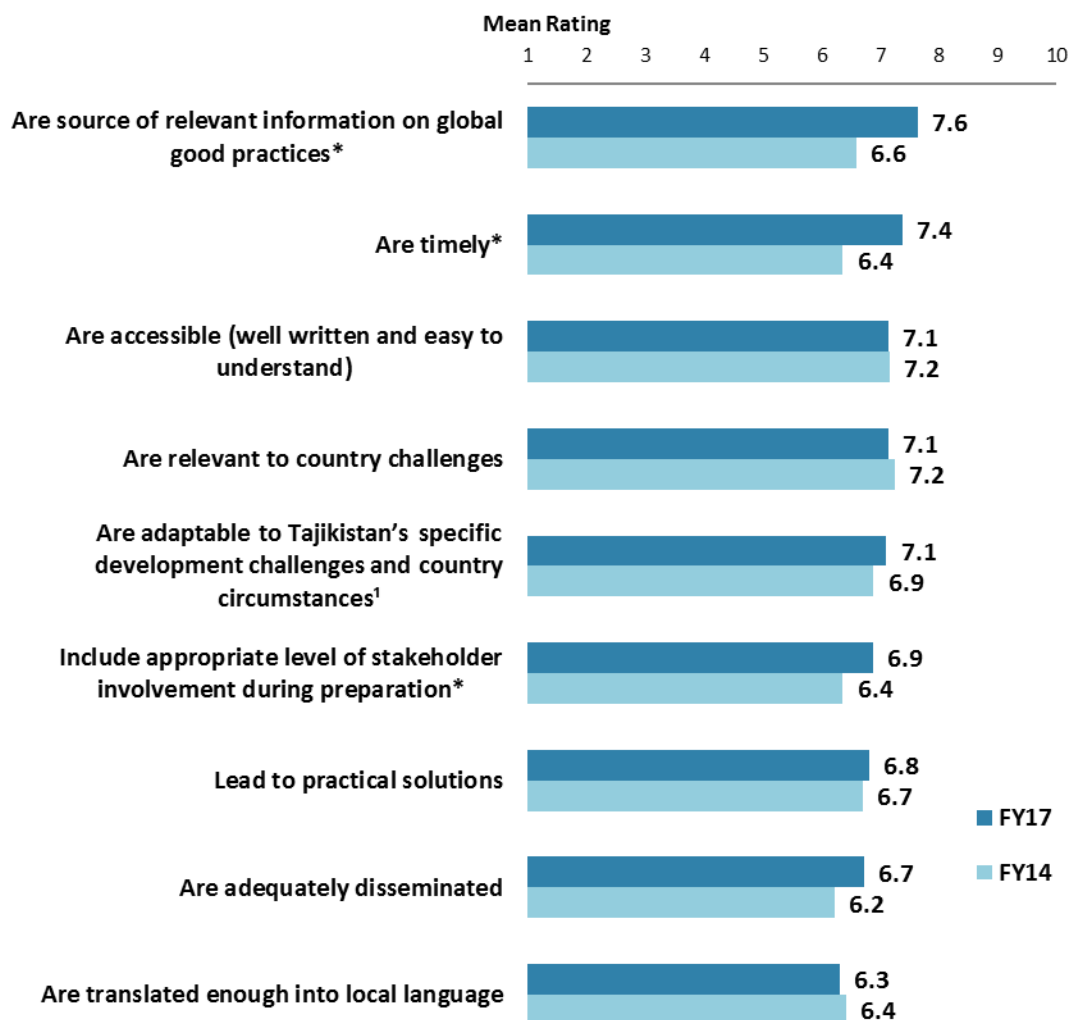

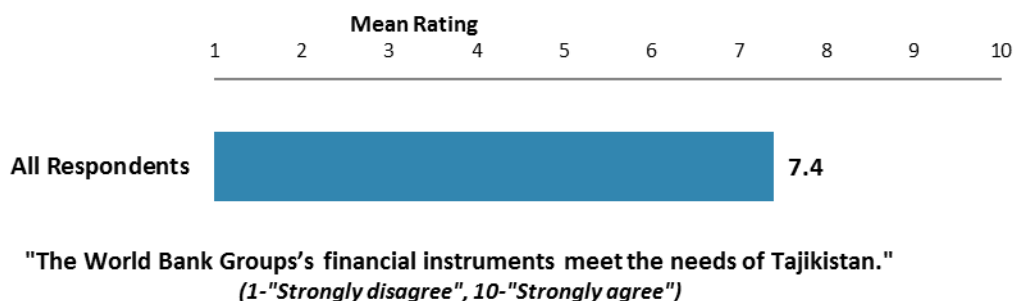

- **Year comparison:** Respondents in this year's Country Survey had significantly higher levels of agreement that the WBG's financial instruments meet Tajikistan's needs (weighted mean = 7.2) compared to respondents from the FY '14 Country Survey (weighted mean = 6.6)¹².
- **Stakeholders:** Respondents from PMUs/Consultants on WBG-supported projects had the highest levels of agreement that the WBG's financial instruments meet Tajikistan's needs whereas respondents from bilateral/multilateral agencies had significantly lower levels of agreement.
- **Location:** Respondents from Other Areas had significantly higher levels of agreement that the WBG's financial instruments meet Tajikistan's needs (mean rating = 8.1) compared to respondents from Dushanbe and Districts of Republican Subordination (mean rating = 7.2).



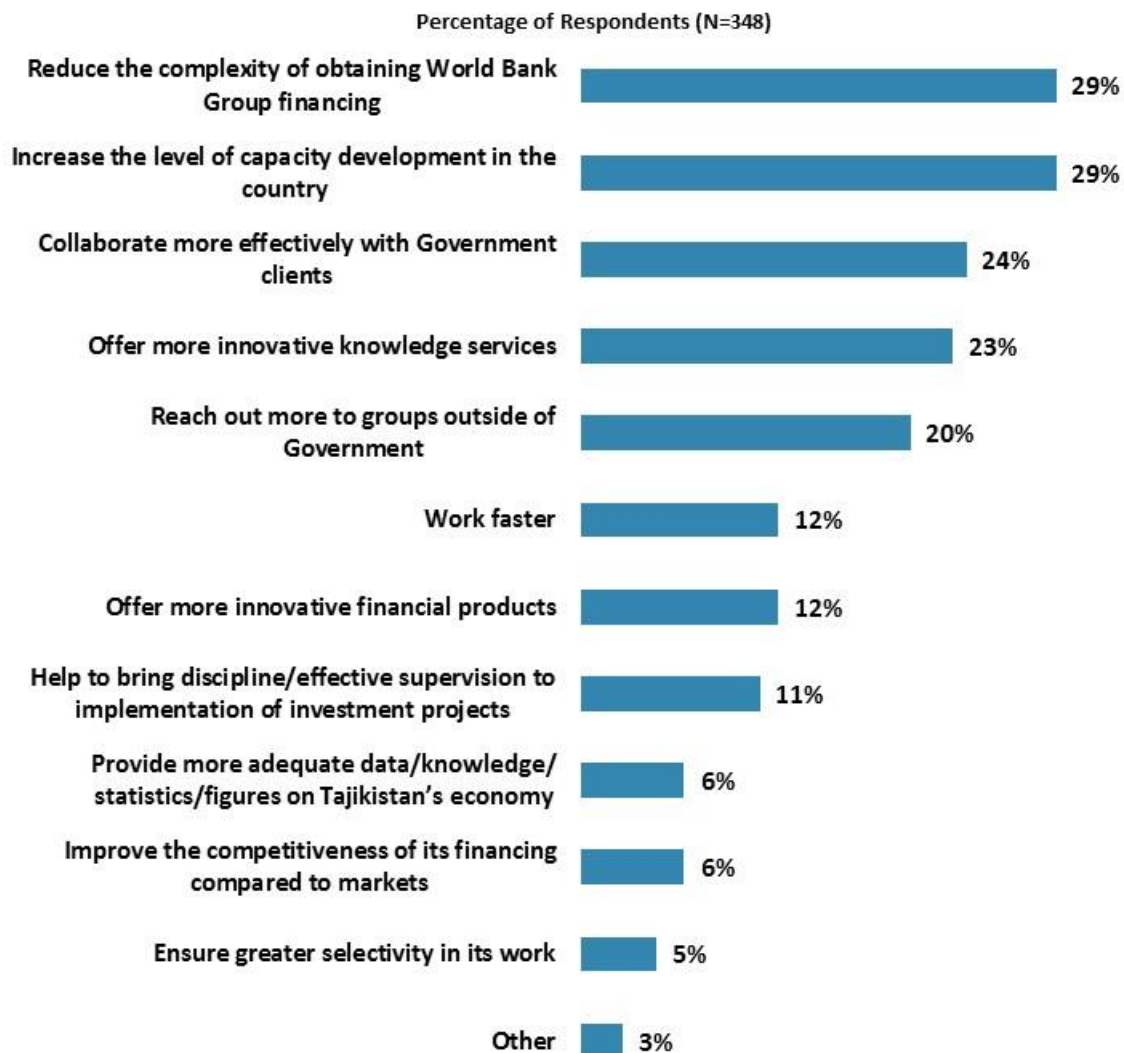

IX. The Future Role of the WBG in Tajikistan

Making the World Bank Group of Greater Value

- **Year comparison:** Respondents in the FY '14 Country Survey indicated that, to make itself of greater value, the WBG should reach out more to groups outside of Government (percentage of respondents = 41%), followed by providing more adequate data/knowledge/statistics/figures on Tajikistan's economy (28%) and improving the quality of its experts as related to Tajikistan's specific challenges (21%).



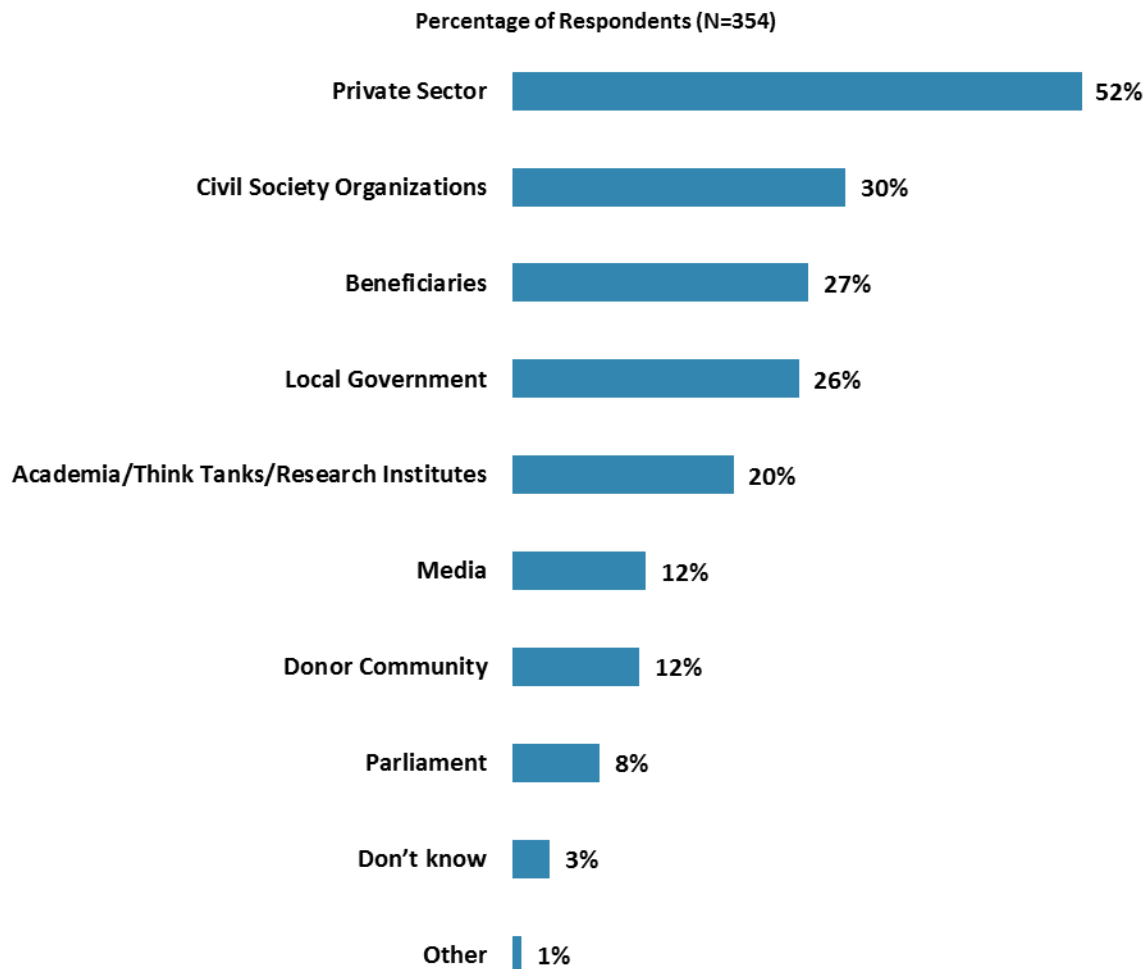

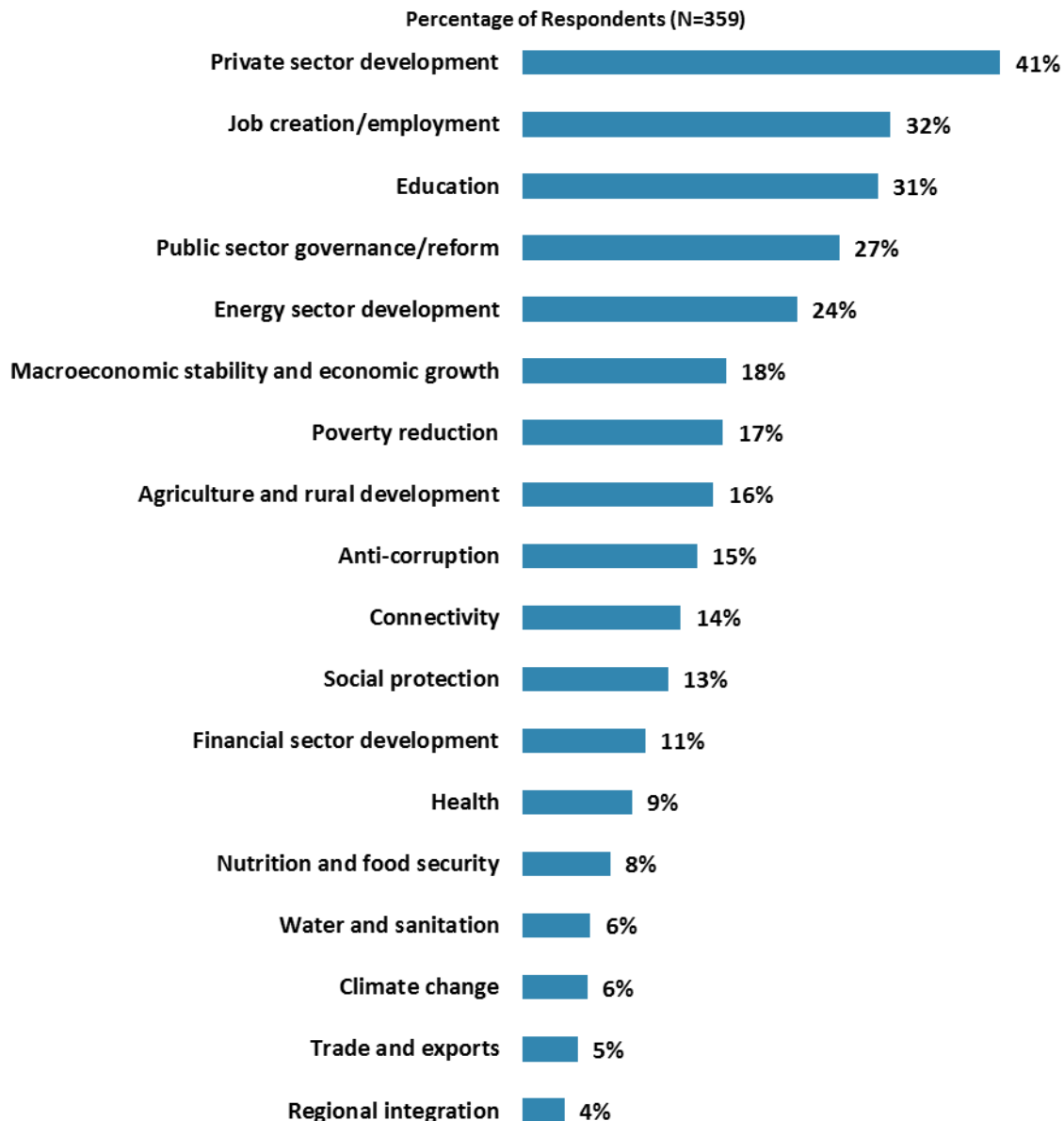

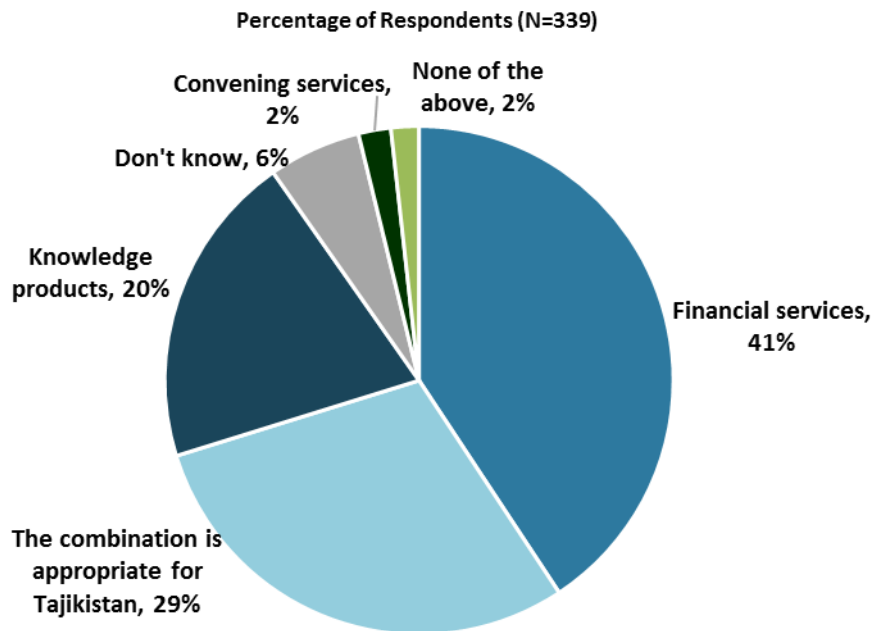

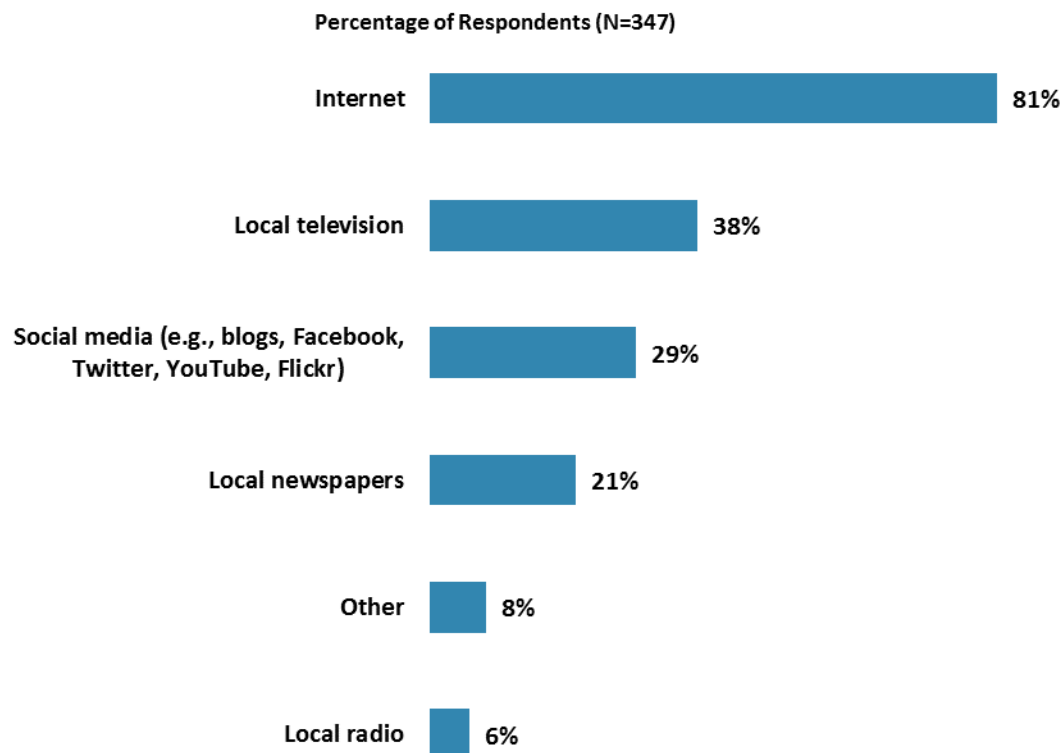

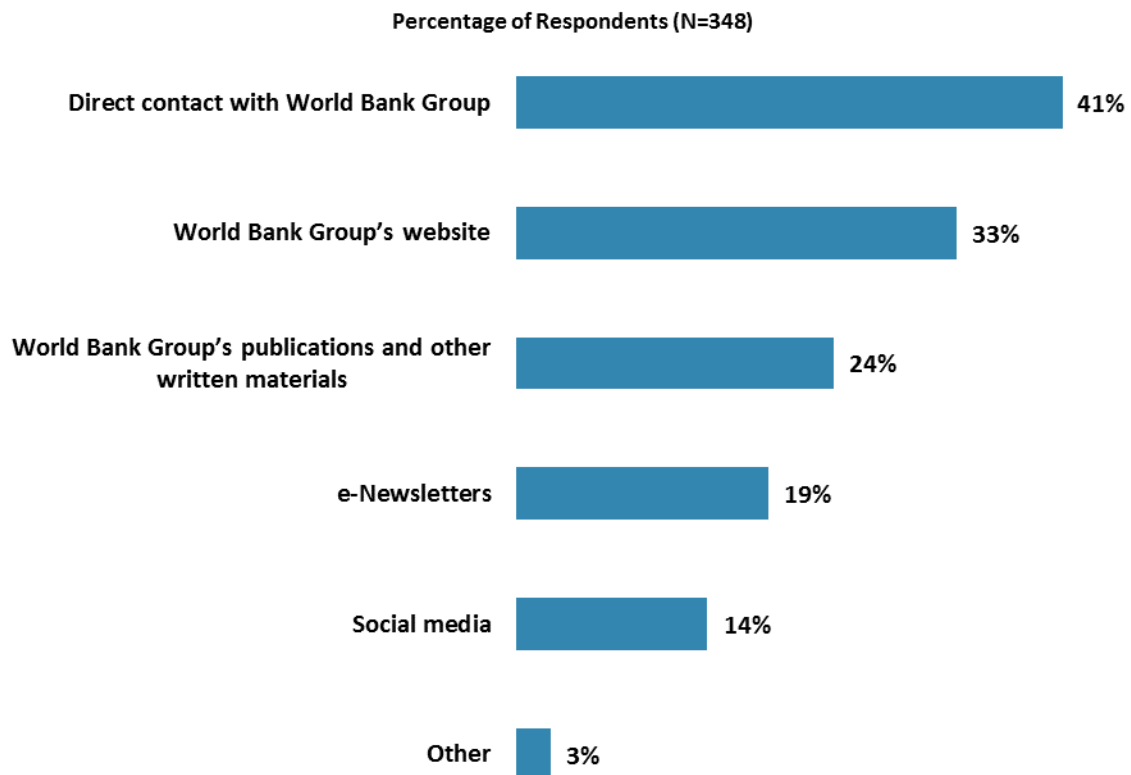
"How do you get most of your information about economic and social development issues in Tajikistan? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

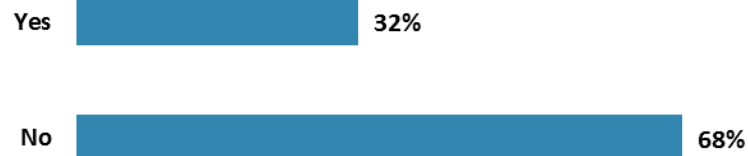
"How would you prefer to receive information from the World Bank Group?

Access to the Internet

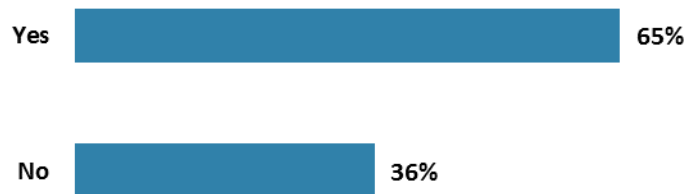
Percentage of Respondents (N=335)

WBG Website Usage

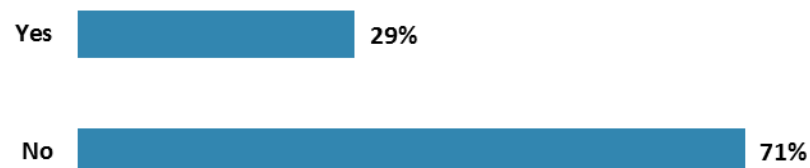
Percentage of Respondents (N=332)
