I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Kosovo perceive the WBG. The survey explored:

- *General Issues Facing Kosovo*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Effectiveness and Results*
- *The World Bank Group's Knowledge Work and Activities*
- *Working with the World Bank Group*
- *The Future Role of the World Bank Group in Kosovo*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From May to June 2016, 240 stakeholders of the WBG in Kosovo were invited to provide their opinions on the WBG's work in the country by participating in a country opinion survey. Participants were drawn from the Office of the President/Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; bilateral/multilateral agencies; private sector organizations; private foundations; the financial sector/private banks; NGOs/community based organizations; the media; independent government institutions; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the judiciary branch; and other organizations. A total of 105 stakeholders participated in the survey (44% response rate).

Respondents received and returned the questionnaires via post or courier. Respondents were asked about: general issues facing Kosovo; their overall attitudes toward the WBG; the WBG's effectiveness and results; the WBG's knowledge work and activities; working with the WBG; the WBG's future role in Kosovo; and the WBG's communication and information sharing.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

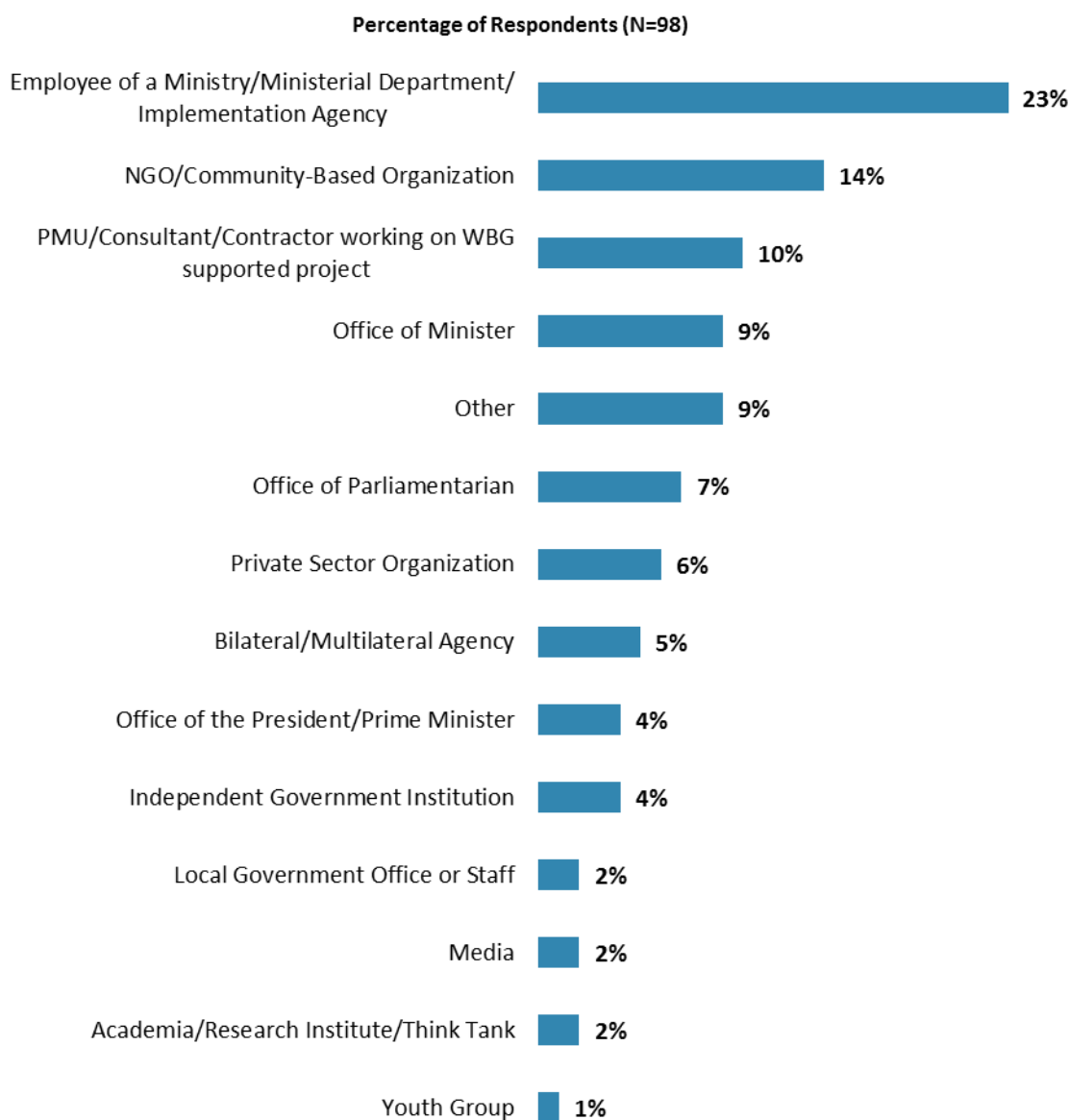
The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'13 (response rate was 50%, N=101). As a rule, the COS data are weighted for year comparisons in order to reach the same stakeholder composition in two fiscal years. However, in the case of Kosovo, due to the small number of respondents in the FY'13 and FY'16 Country Surveys and different stakeholder composition in the samples, weighting would have been statistically unsound. Therefore, only basic comparisons of the unweighted data from the FY'13 and FY'16 Country Surveys are presented in the report and should be considered provisional. III. Demographics of the Sample

Current Position

- For further analyses, respondents from the Office of the President/Prime Minister were combined with respondents from the office of a minister; respondents from NGOs/community based organizations and youth groups were combined in the “CSO” category; and the few respondents from independent government institutions, local governments, academia/research institutes/think tanks, and the media were included in the “Other” category. There were no respondents from private foundations, financial sector/private banks, trade unions, faith-based groups, and the judiciary branch.

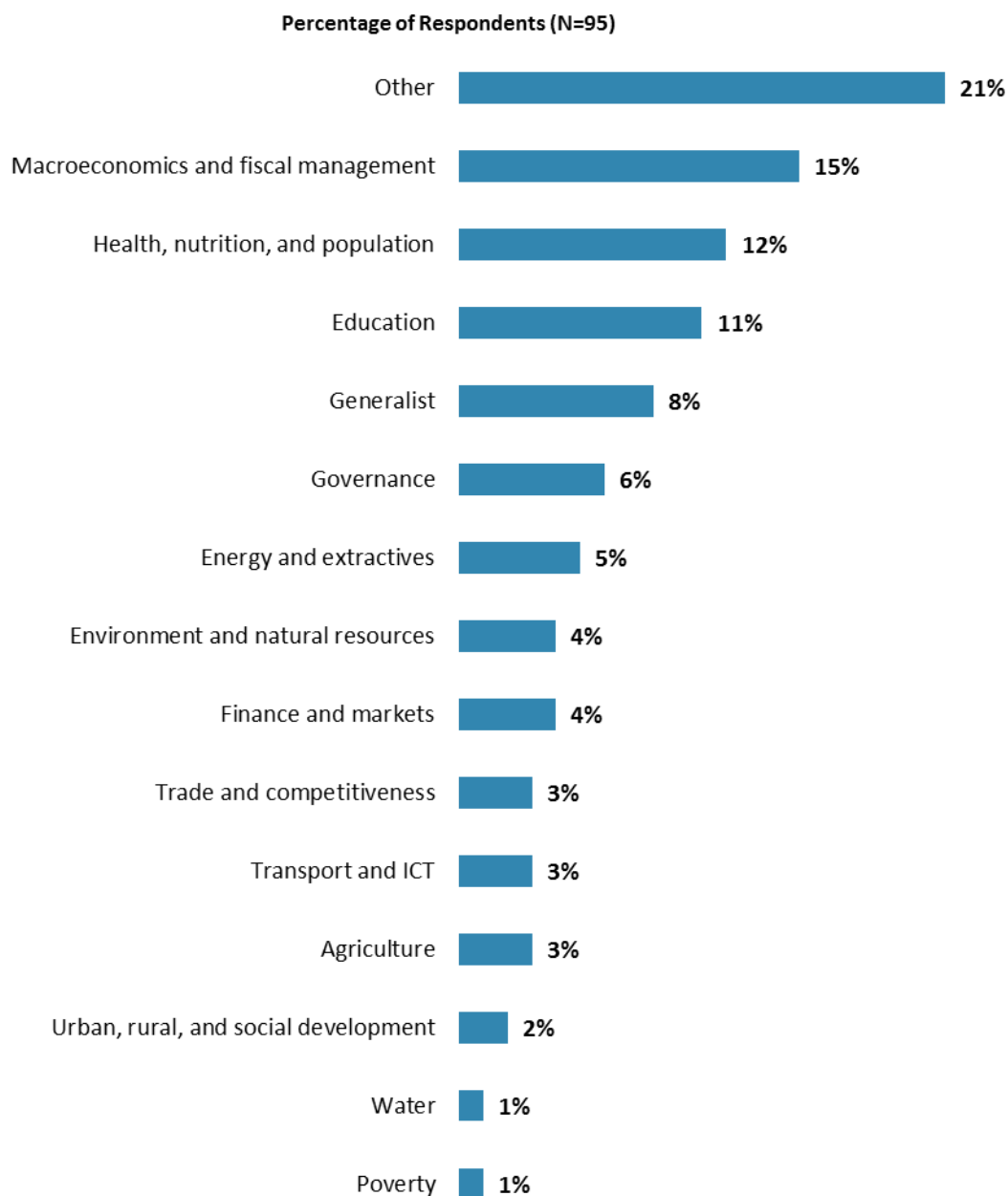


“Which of the following best describes your current position?” (Respondents chose from a list.)

Area of Primary Specialization



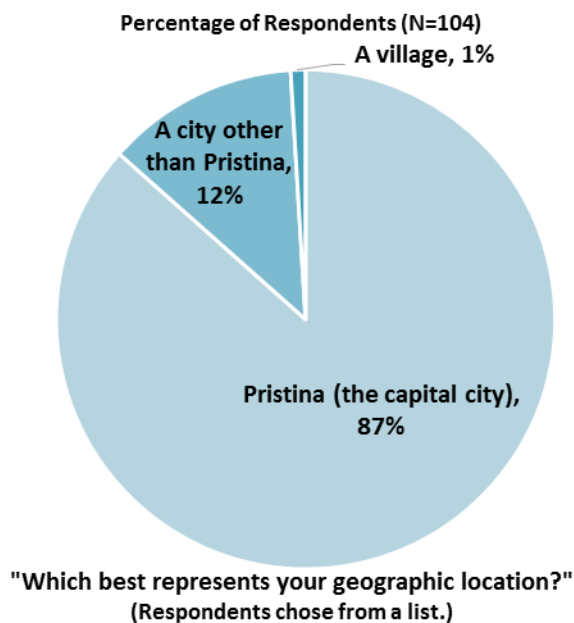
"Please identify the primary specialization of your work." (Respondents chose from a list.)



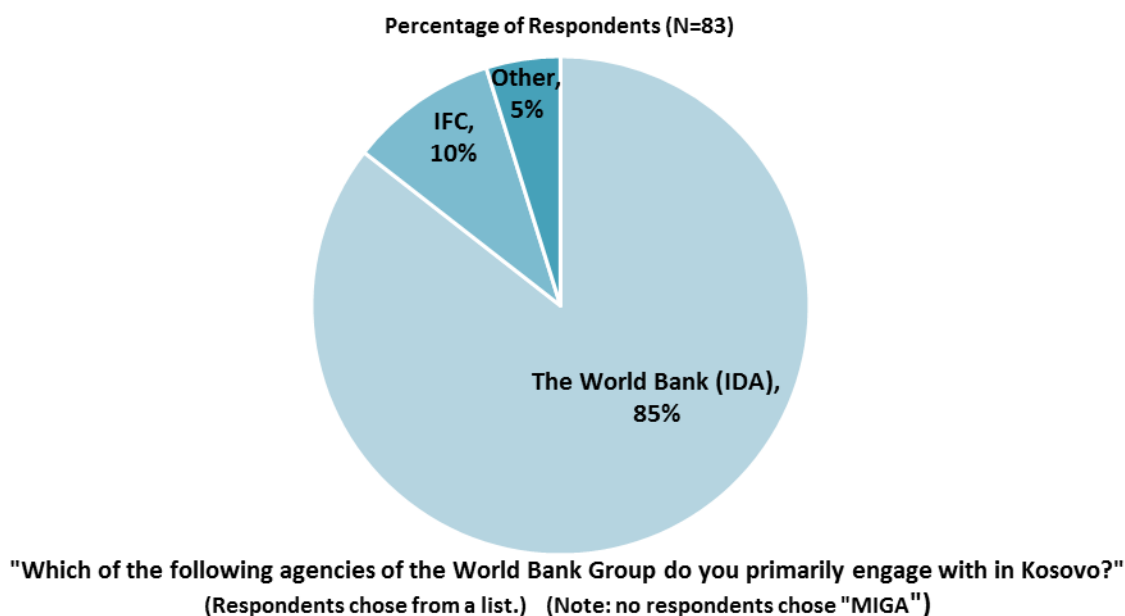

Exposure to Agencies within the World Bank Group

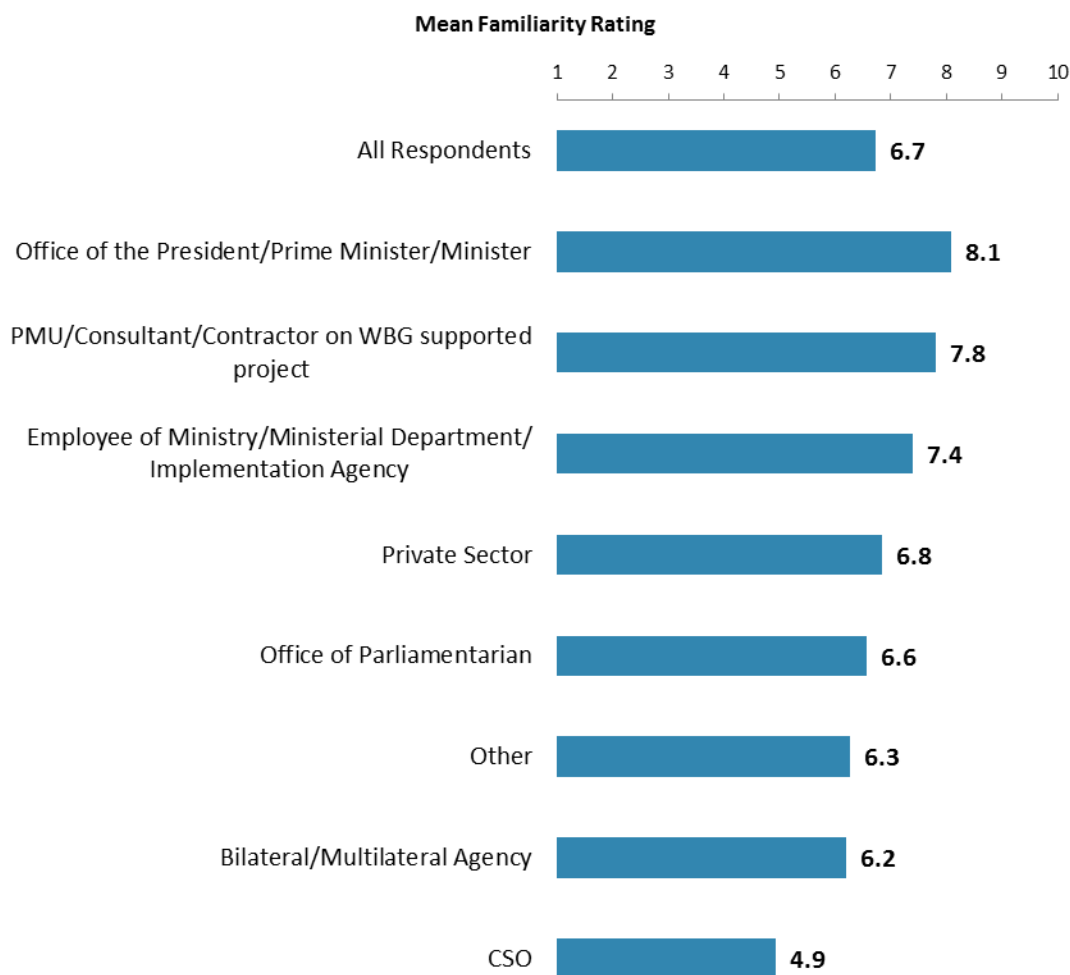

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey and the FY'13 Country Survey had statistically similar levels of familiarity with the WBG (mean familiarity rating in FY'16 = 6.7; mean familiarity rating in FY'13 = 6.6).¹
- Respondents' levels of familiarity with the WBG were significantly, moderately correlated with their ratings of the WBG's overall effectiveness in Kosovo, the extent to which the WBG plays a relevant role in development in Kosovo, and the extent to which the WBG contributes to the country's development results.

(1 - "Not familiar at all", 10 - "Extremely familiar")

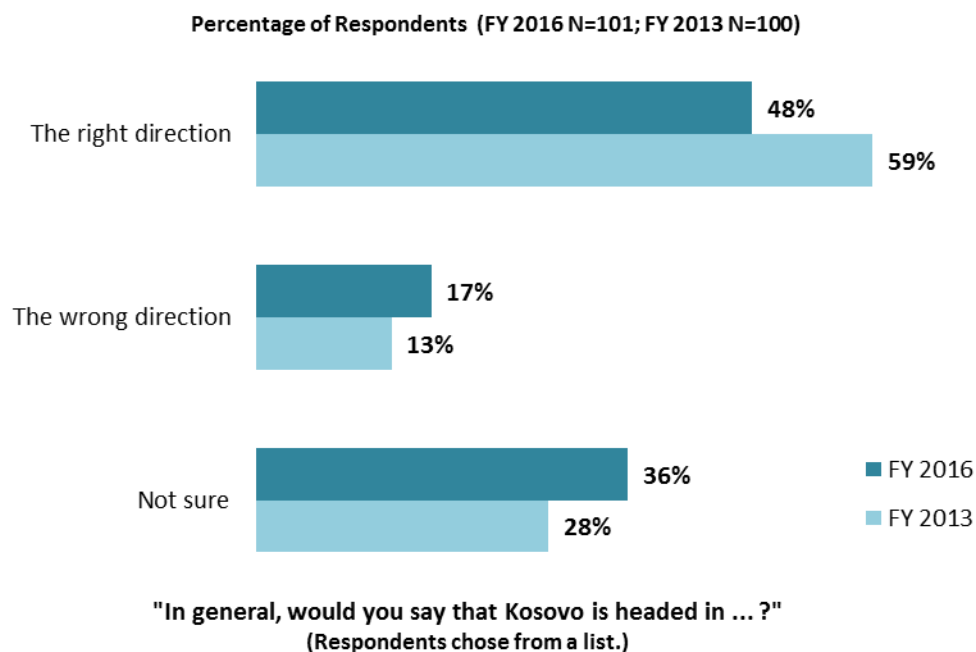

IV. General Issues Facing Kosovo

Headed in the Right Direction

- **Stakeholder groups:** In this year's Country Survey, respondents from the Office of the President/Prime Minister/Minister were significantly more likely to indicate that Kosovo is headed in the right direction, whereas respondents from bilateral/multilateral agencies and CSOs were least positive about the prospect of Kosovo.

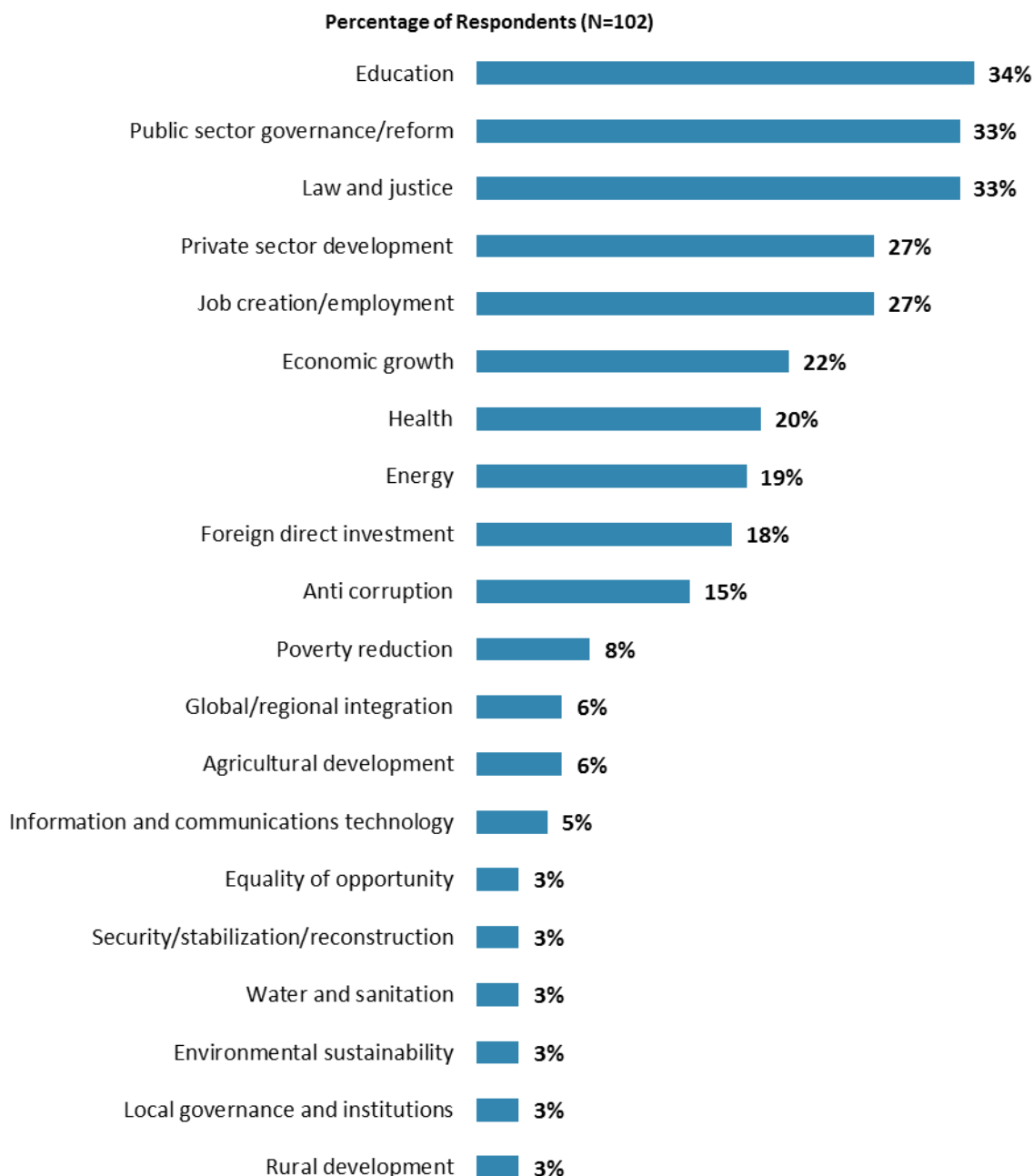

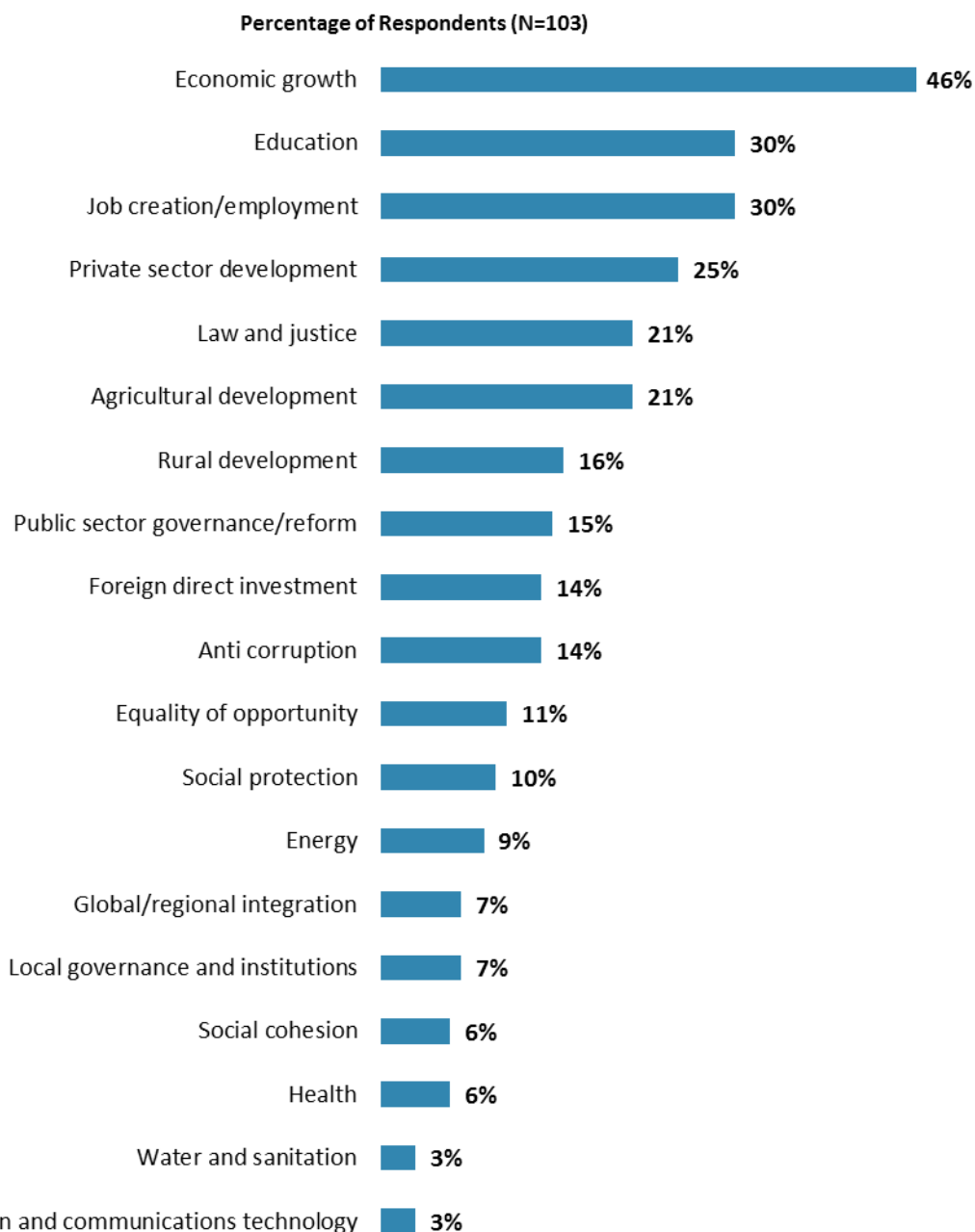
"Listed below are a number of development priorities in Kosovo. Please identify which of the following you consider the most important development priorities in Kosovo. (Choose no more than THREE)"

What Would Contribute Most to Reducing Poverty

- **Year comparison:** In the previous FY'13 Country Survey, respondents indicated that the greatest contributors to poverty reduction in Kosovo were “*economic growth*” (57%), “*anti-corruption*” (32%), and “*job creation/employment*” (31%).



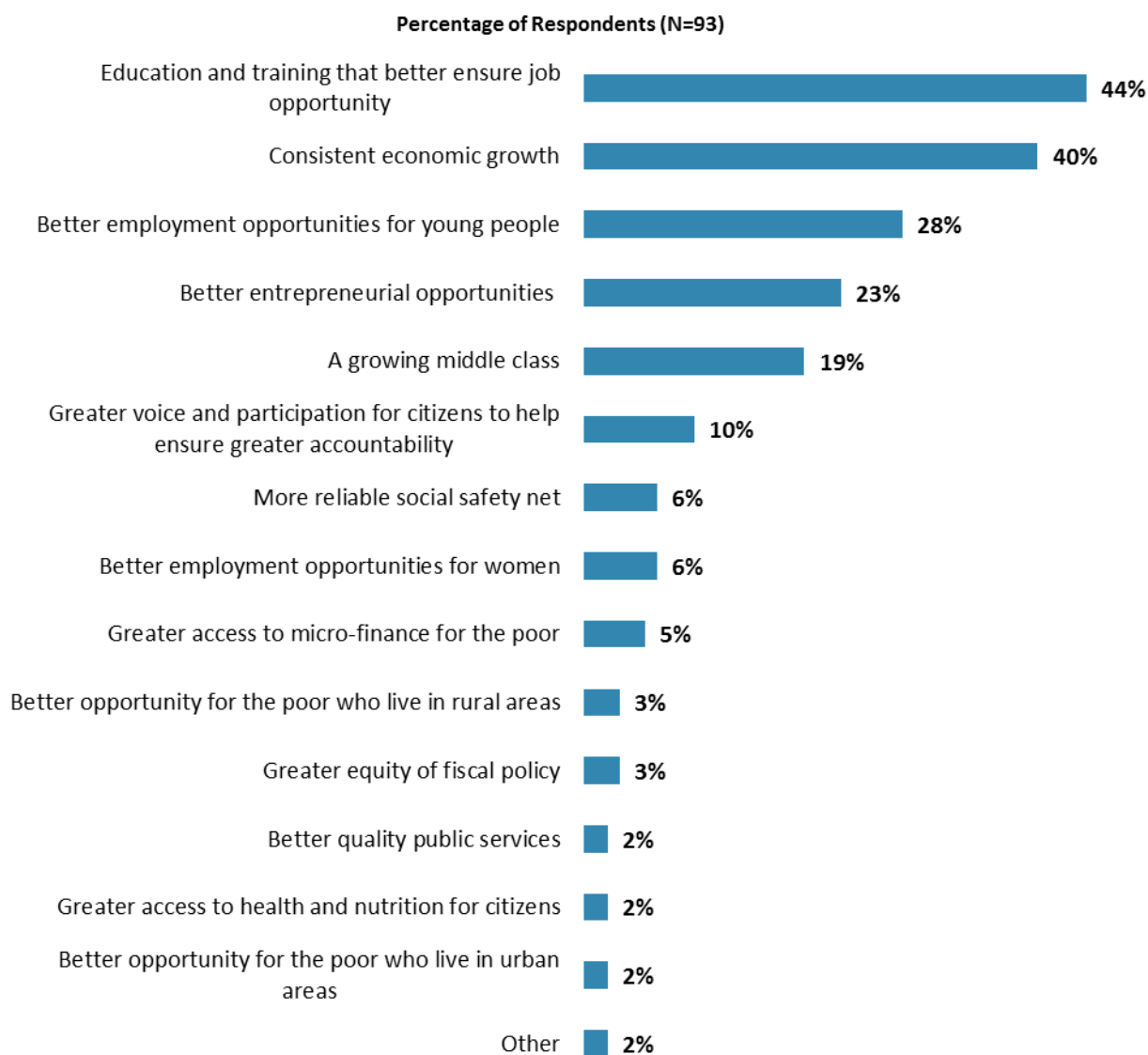

Factors Contributing to “Shared Prosperity”

- **Year comparison:** In the previous FY’13 Country Survey, respondents indicated that the greatest contributors to “shared prosperity” in Kosovo were “*consistent economic growth*” (46%), “*better employment opportunities for young people*” (42%), and “*education and training that better ensure job opportunity*” (39%).



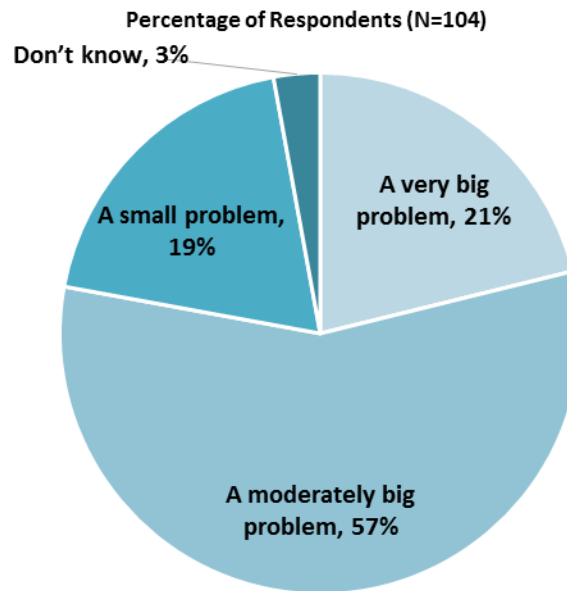

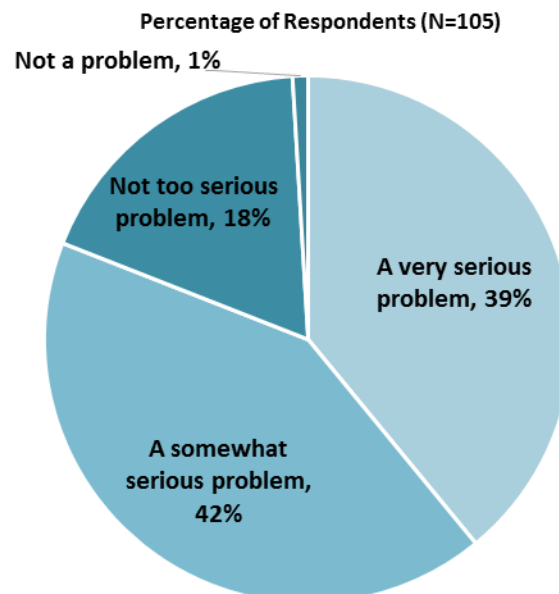

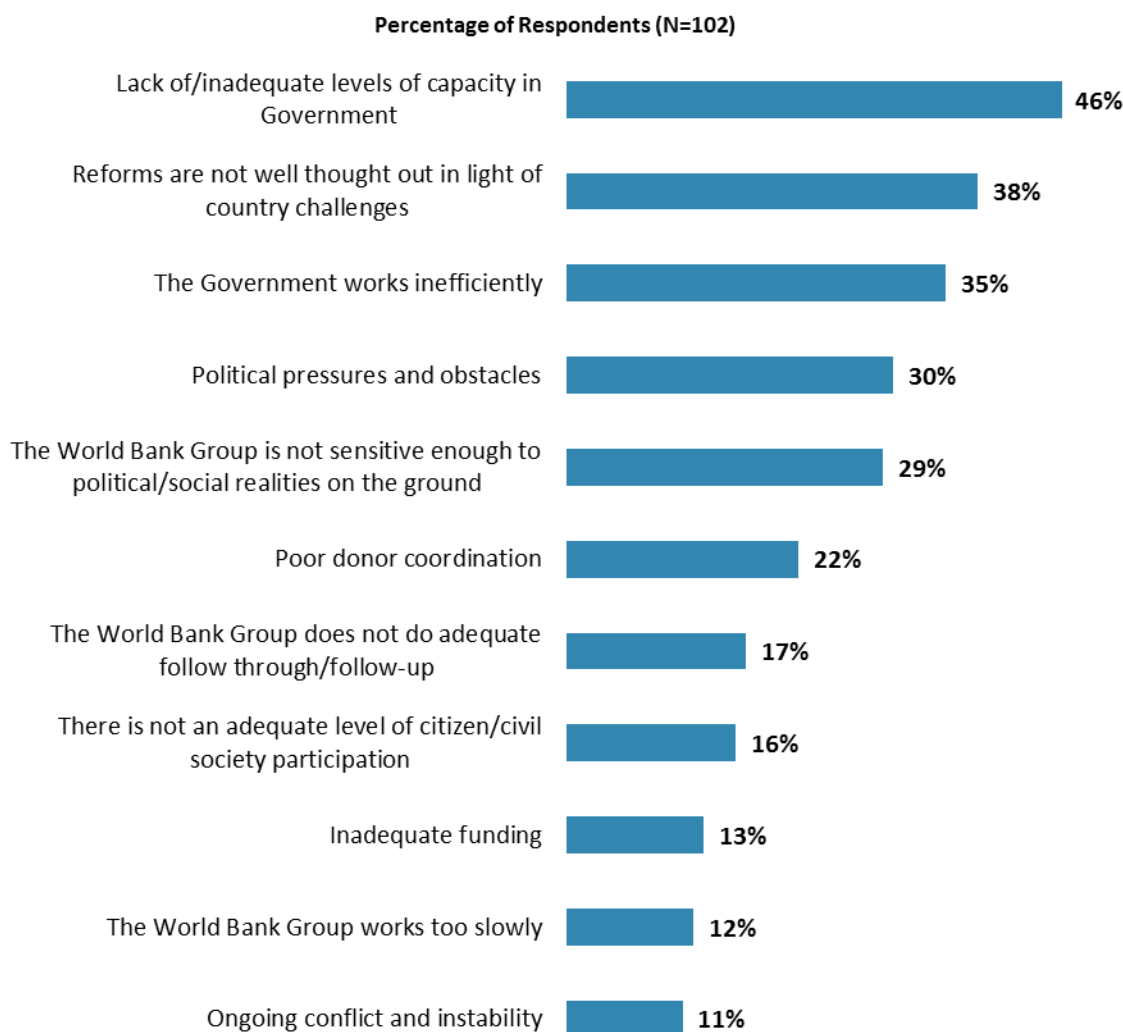

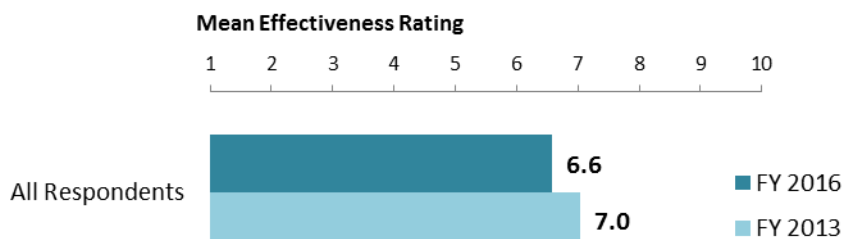
"When World Bank Group assisted reform efforts fail or are slow to take place, which THREE of the following would you attribute this to? (Choose no more than THREE)"

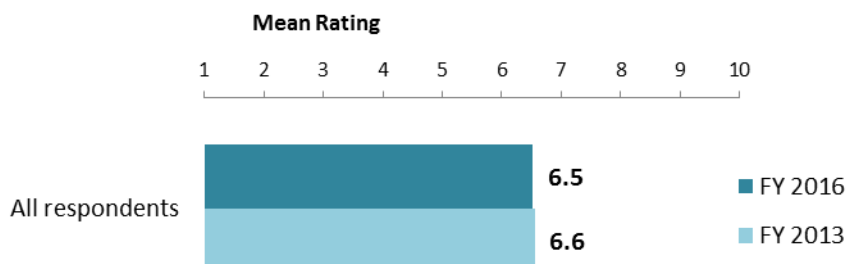

The World Bank Group's Overall Effectiveness (Indicator Question)



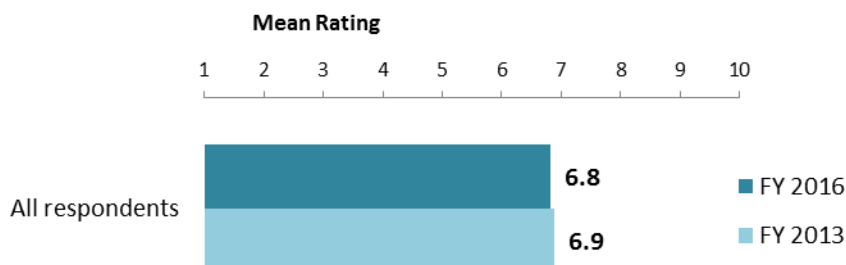
"Overall, please rate your impression of the World Bank Group's effectiveness in Kosovo."

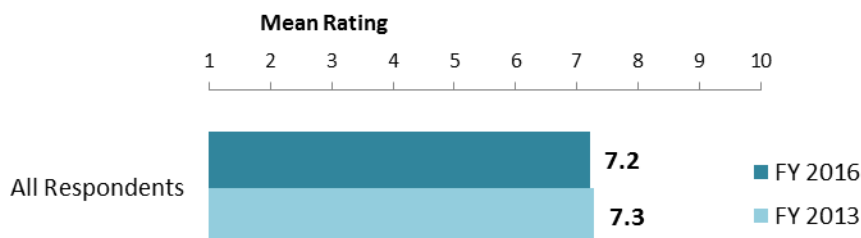


"To what extent does the World Bank Group help to build/strengthen existing country systems in Kosovo?" (1-"To no degree at all", 10-"To a very significant degree")



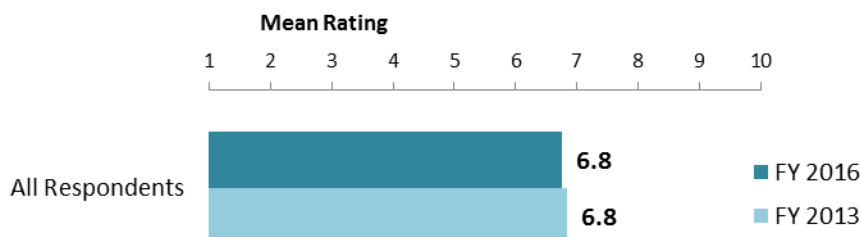

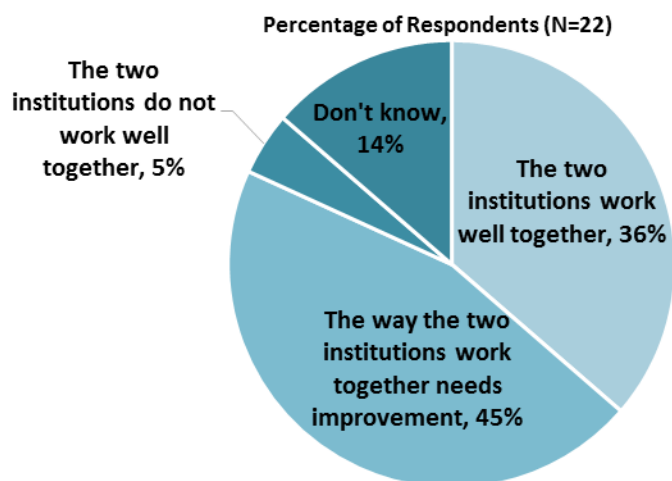
WBG Staffing in Kosovo

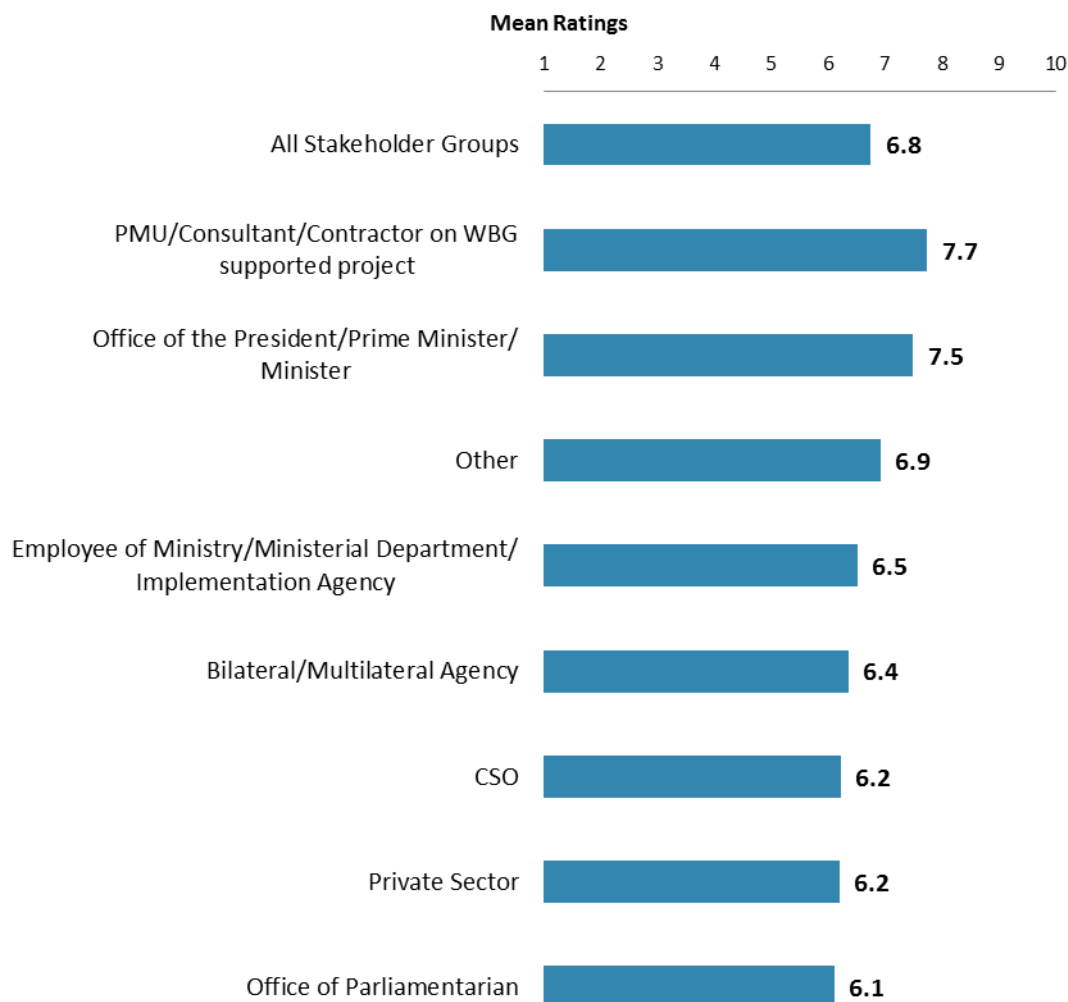
"If your projects involved both the World Bank and the IFC, what was your view on the two institutions working together in Kosovo?" (Respondents chose from a list.)

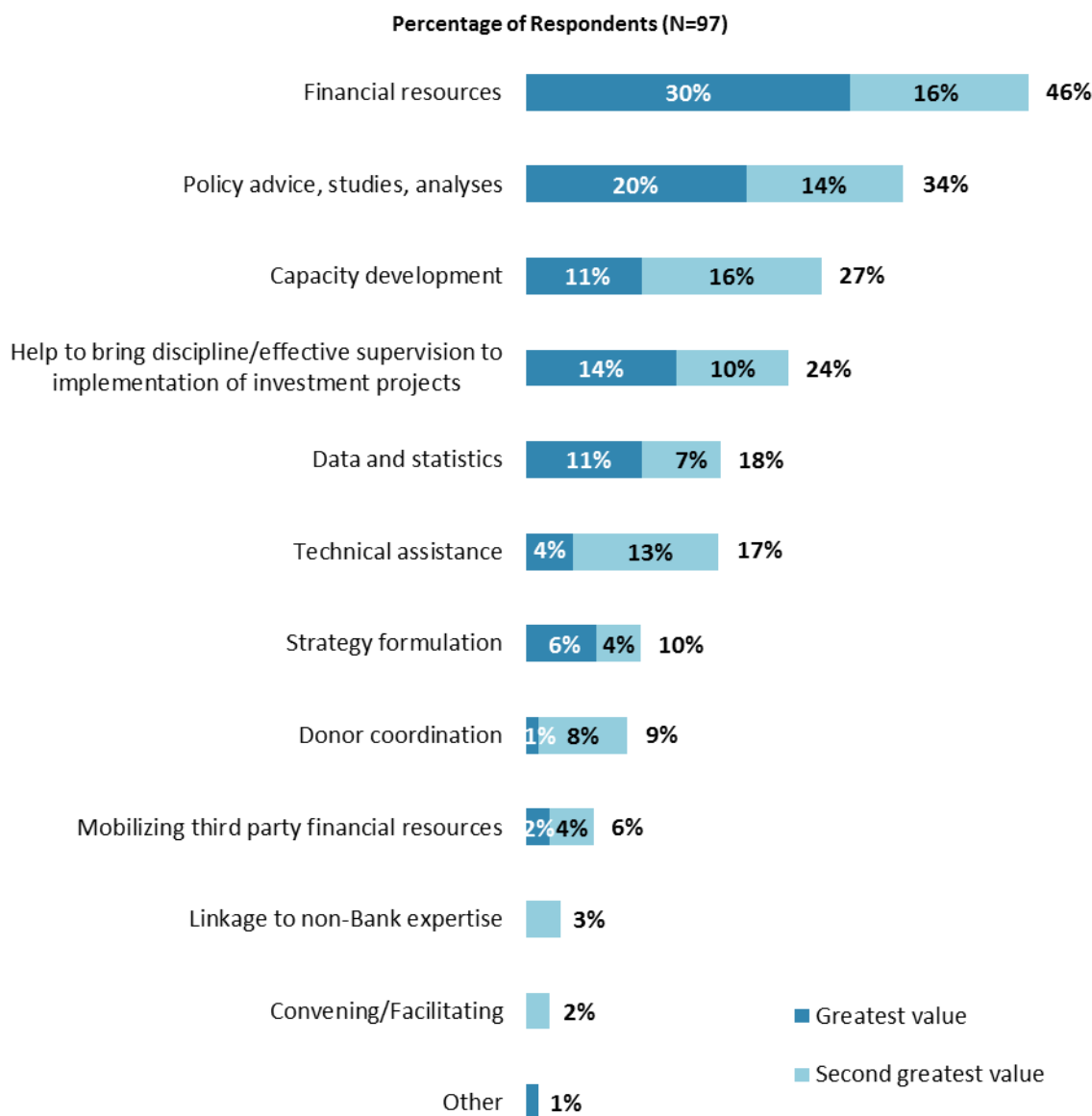
Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10

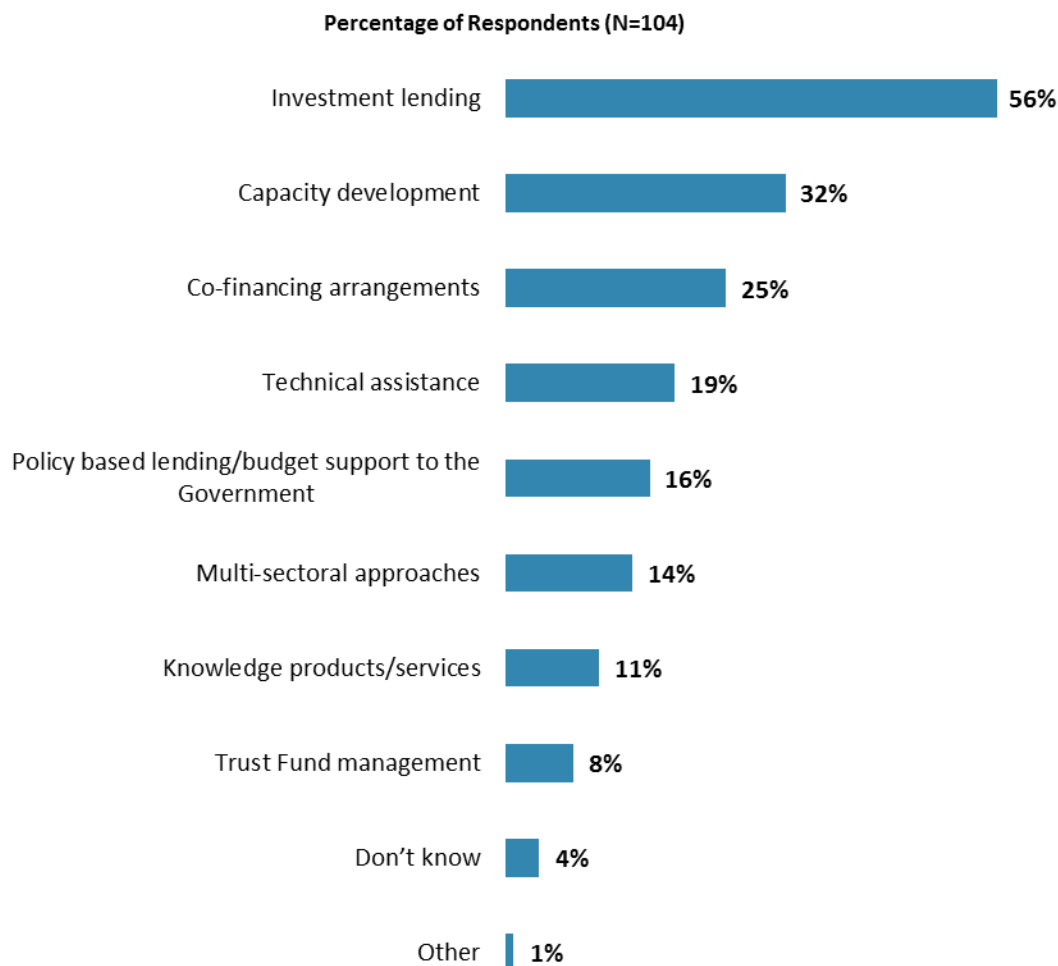
"When thinking about the World Bank Group's role, which activity do you believe is of greatest VALUE and which activity is of second greatest value in Kosovo?"

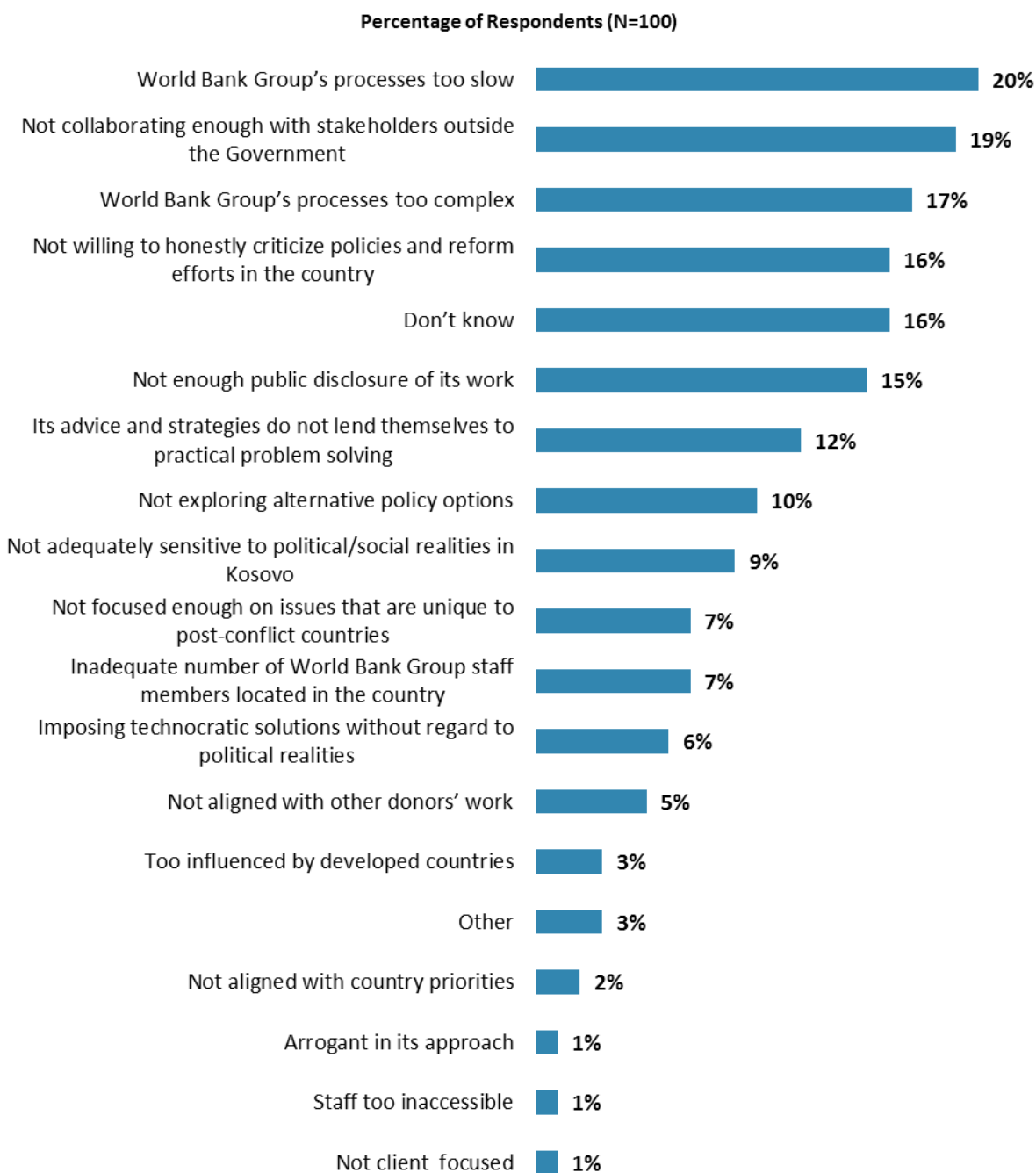
“Which World Bank Group's instruments do you believe are the MOST effective in reducing poverty in Kosovo? (Choose no more than TWO)”

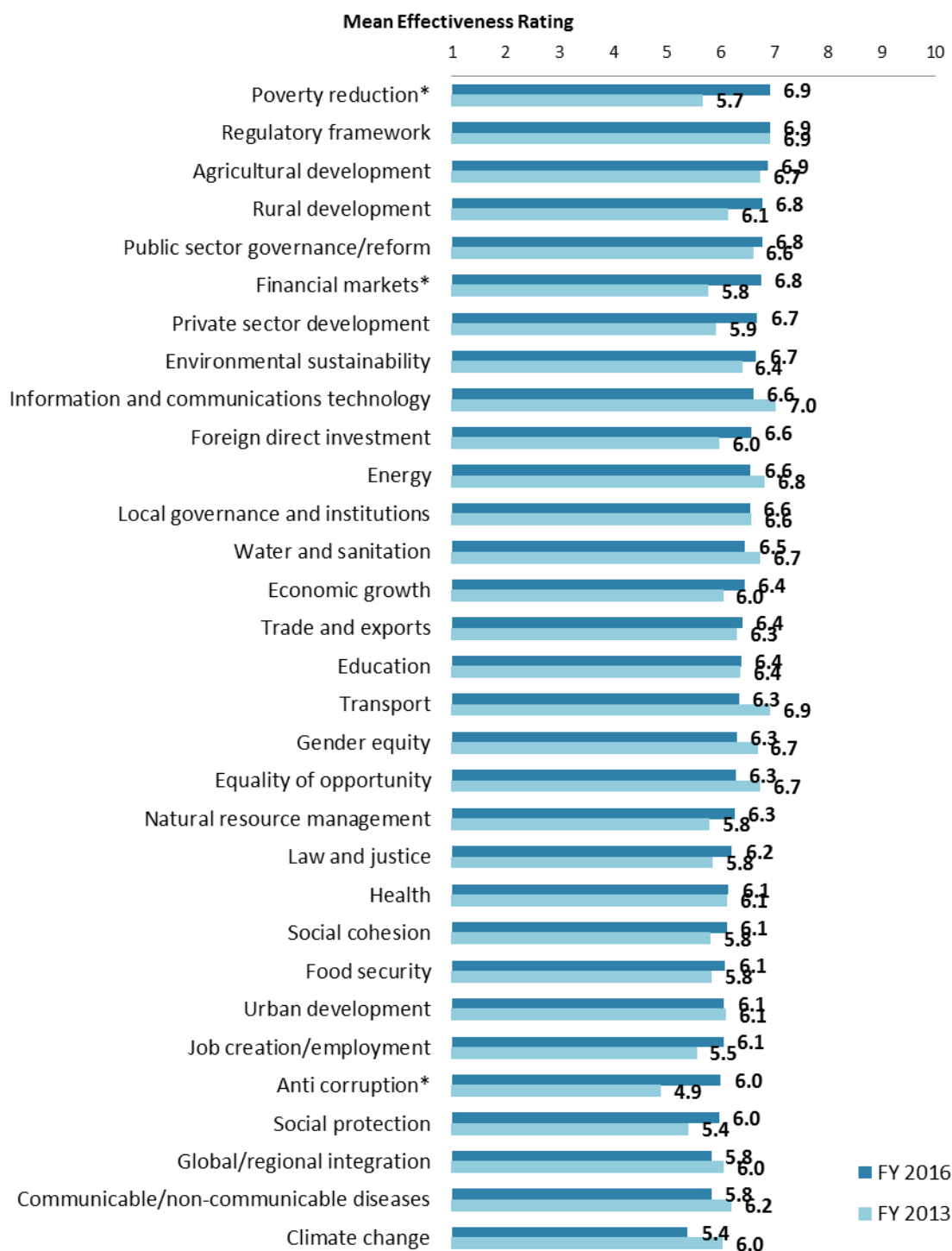

Effectiveness of WBG's Support in Sectoral Areas: Year Comparison

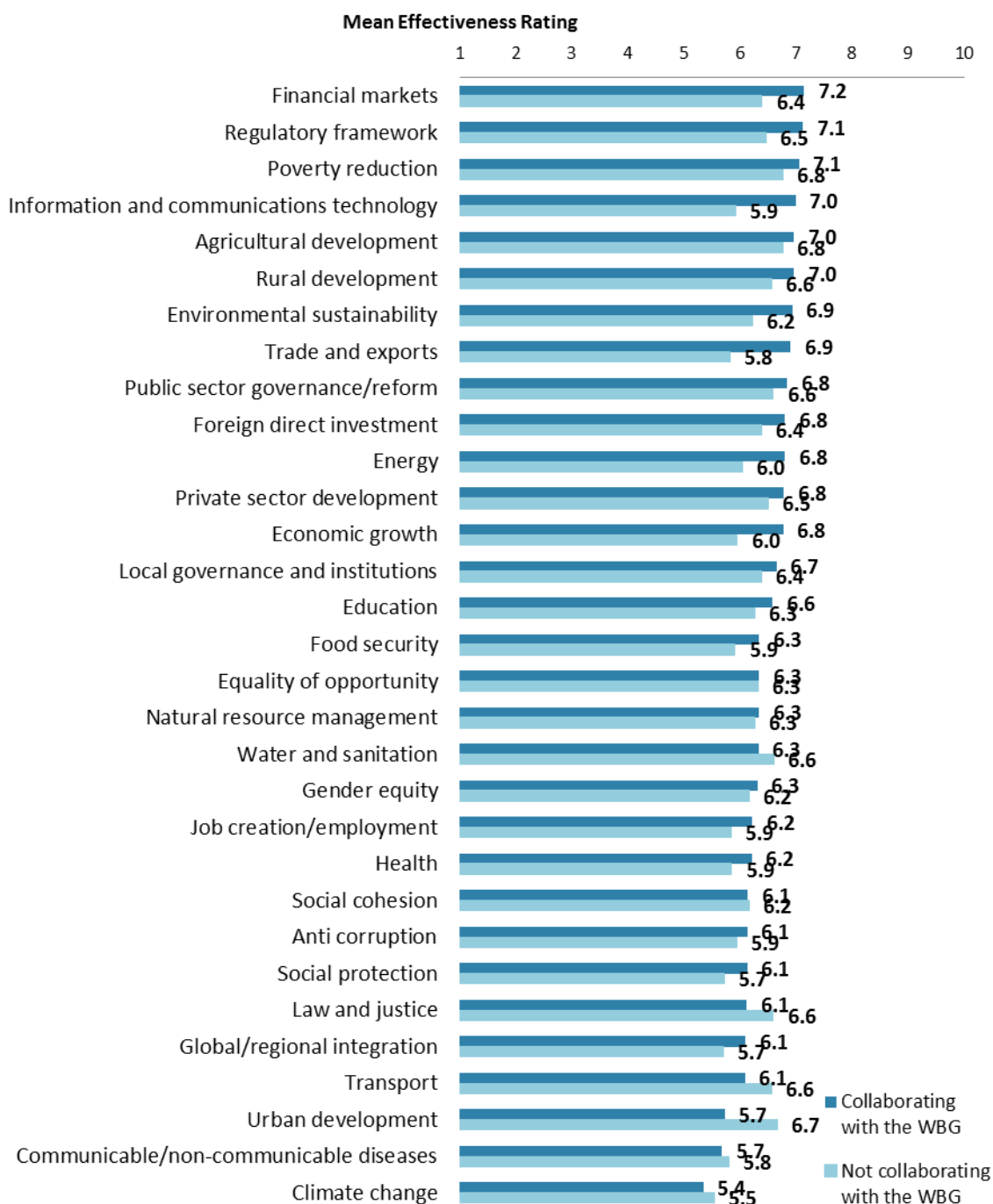

Drivers of Effectiveness

To determine the key drivers of respondents' ratings of the World Bank Group's overall effectiveness and ratings of its ability to help achieve development results in Kosovo, bivariate correlational analyses were conducted using respondents' ratings of the thirty one specific areas of effectiveness.

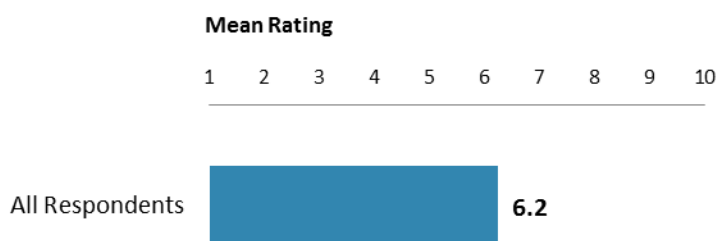
Correlational analyses, however, are not able to tell us exactly what is causing respondents' ratings of the World Bank Group's overall effectiveness or ratings of its ability to help achieve development results. Rather, these analyses tell us that as ratings of effectiveness in one area increase, respondents' ratings of the WBG's overall effectiveness increase, or as ratings of effectiveness in one area increase, ratings of the WBG's ability to help achieve development results increase. Thus, it can be inferred that respondents' perceptions of effectiveness in one specific area are related to, or drive, respondents' perceptions of the WBG's overall effectiveness or perceptions of the WBG's ability to help achieve development results.

- Overall Effectiveness: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's overall effectiveness, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's overall effectiveness in Kosovo. The areas determined to be key drivers from these analyses were:
 - The WBG's effectiveness at gender equity;
 - The WBG's effectiveness at law and justice; and
 - The WBG's effectiveness at job creation/employment.
- Achieving Development Results: Those specific areas with the highest Pearson Product-Moment correlations were determined to be the most closely related to perceptions of the WBG's ability to help achieve development results in Kosovo, suggesting that ratings of effectiveness in those specific areas are drivers of perceptions of the WBG's ability to help achieve development results. The area determined to be key driver from these analyses was:
 - The WBG's effectiveness at law and justice;
 - The WBG's effectiveness at transport; and
 - The WBG's effectiveness at gender equity.



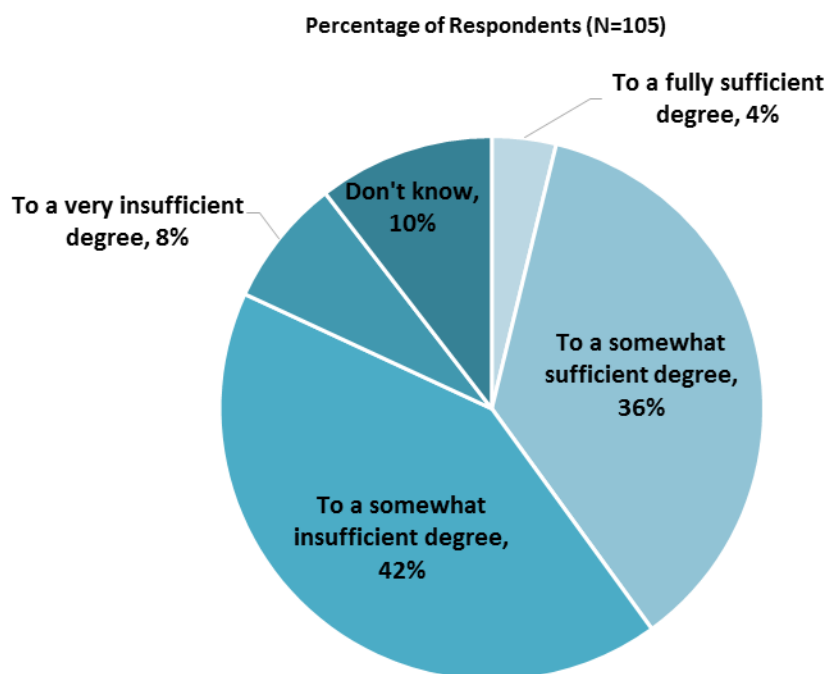

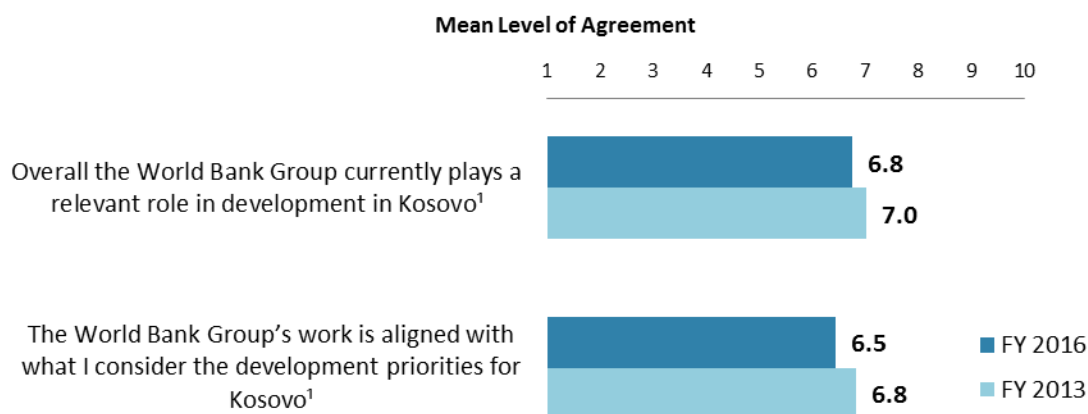


"To what extent do you believe that the World Bank Group's work and support help the poorest in Kosovo?"
(Respondents chose from a list.)



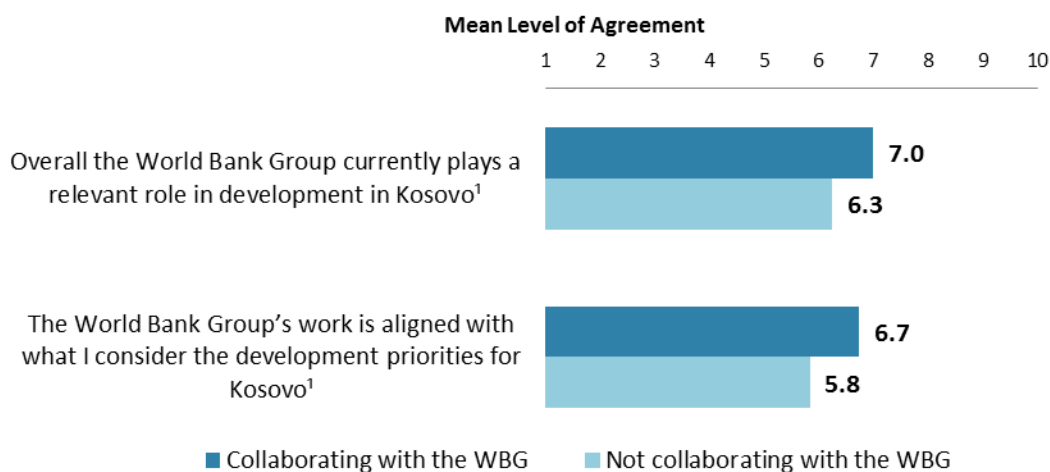

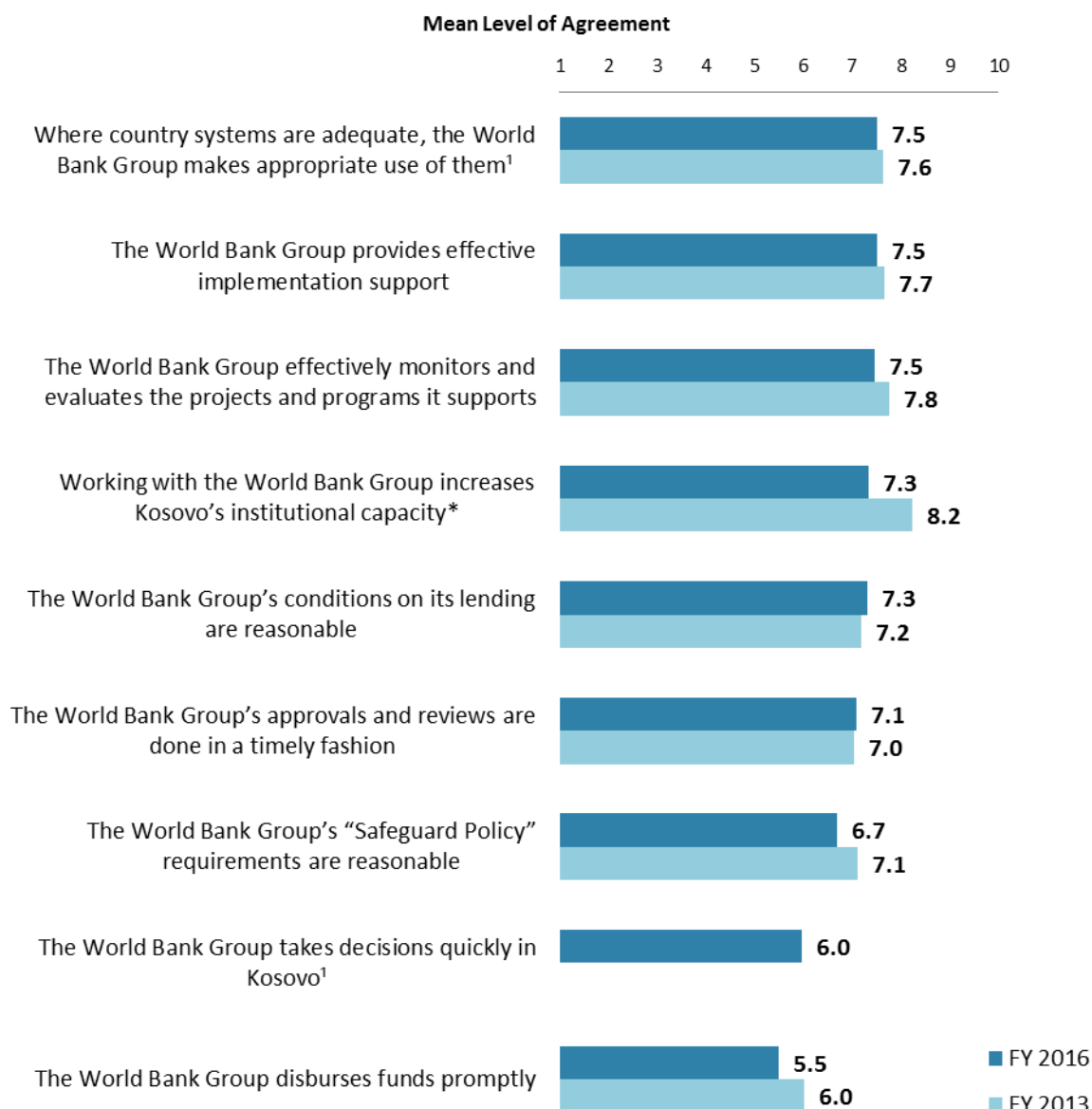

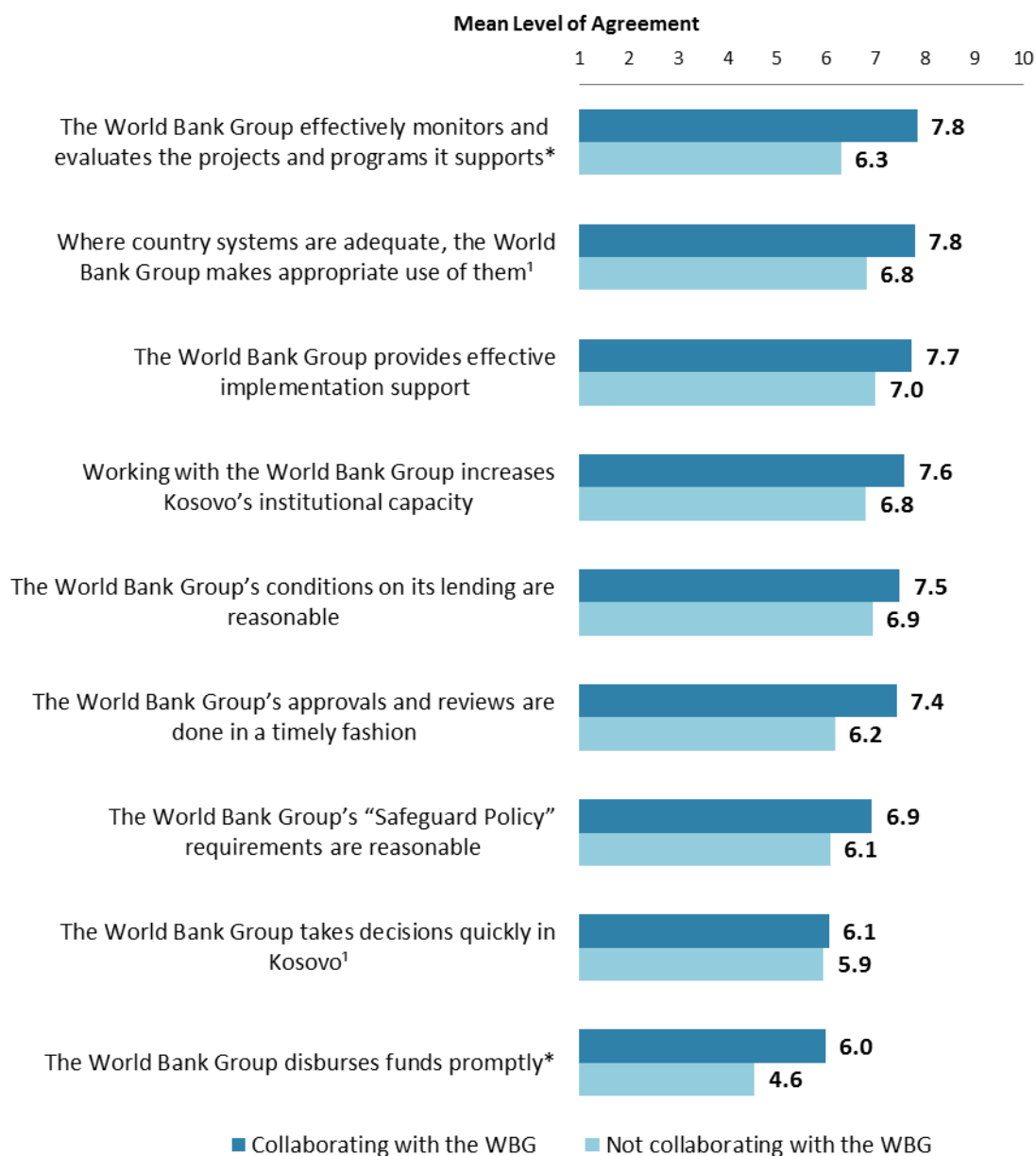

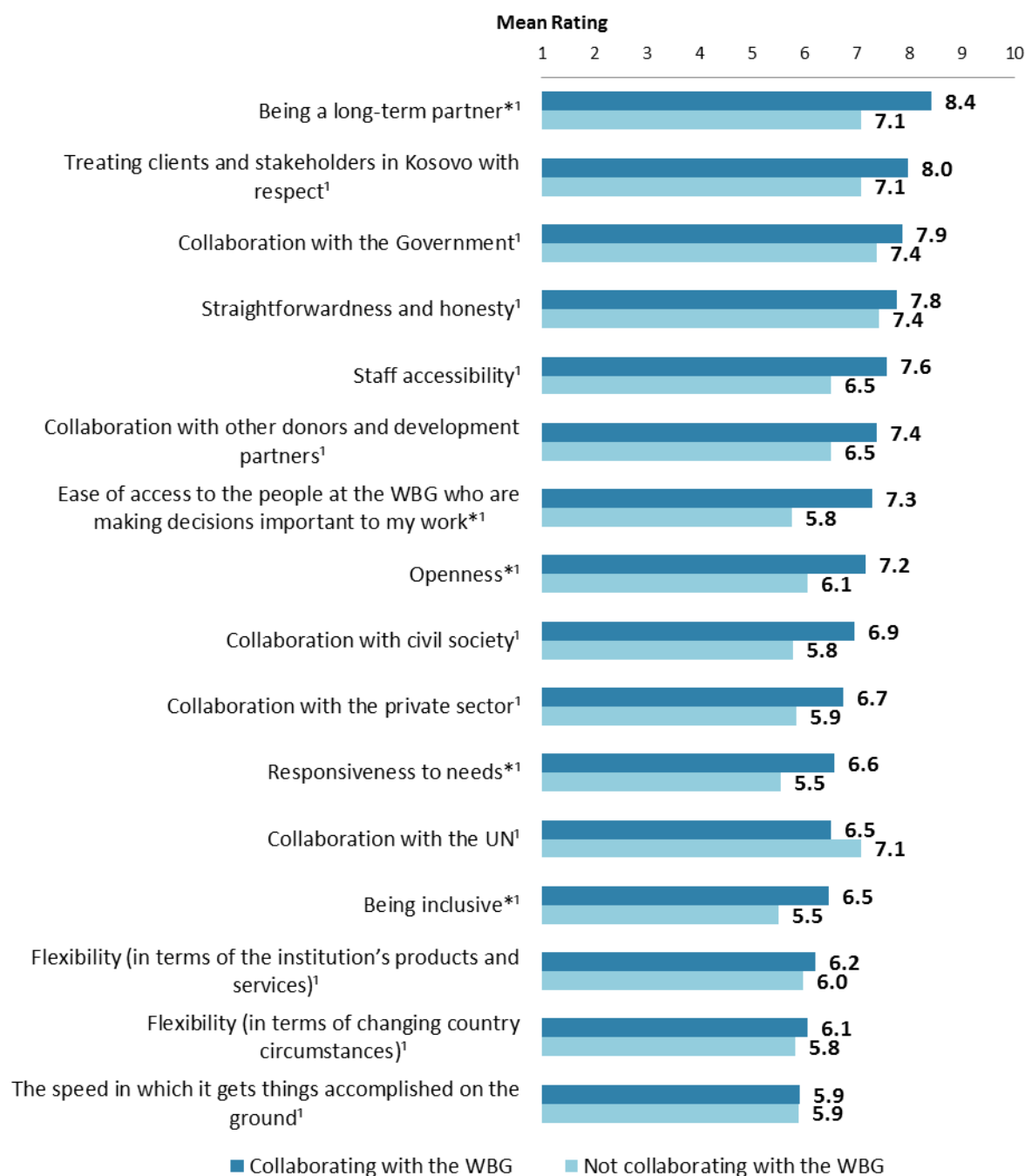

"To what extent is the World Bank Group an effective development partner in Kosovo, in terms of each of the following?" (1-"To no degree at all", 10-"To a very significant degree")

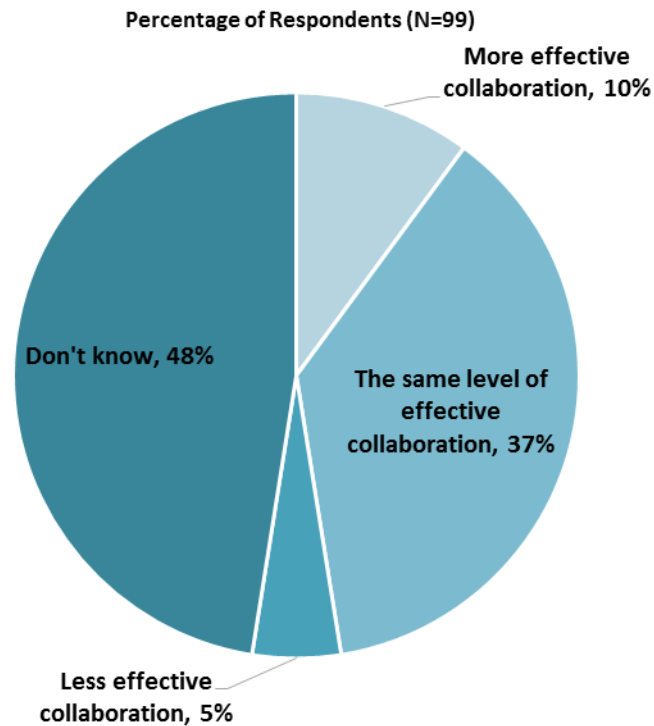

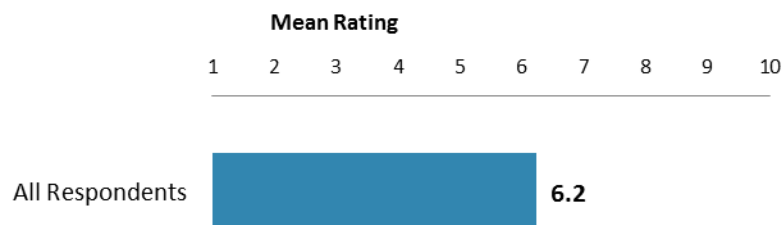

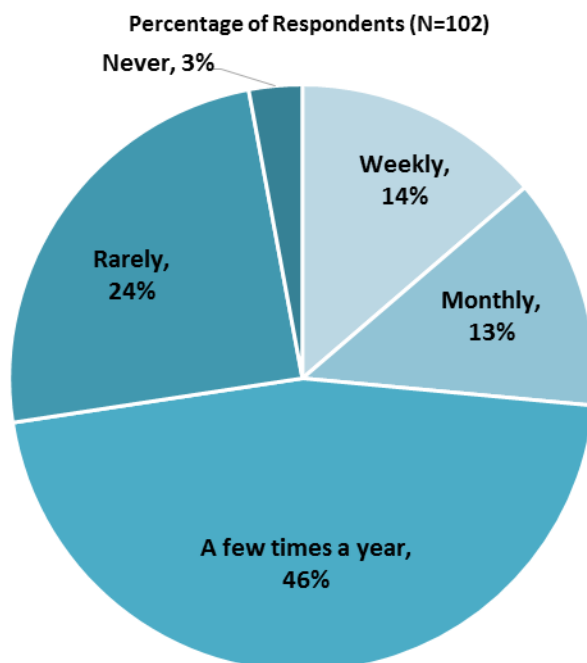
"To what extent do you believe the World Bank Group measures and corrects its work in real time in Kosovo?" (1-"To no degree at all", 10-"To a very significant degree")

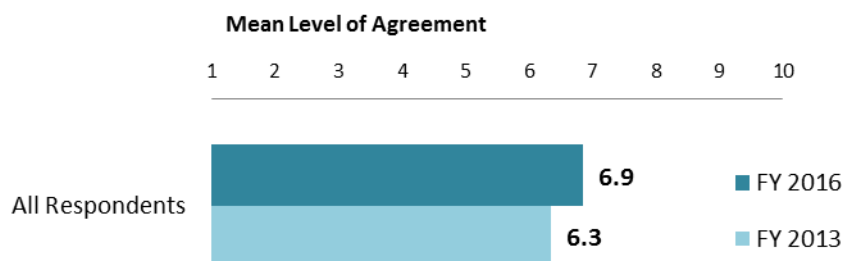


"How frequently do you consult World Bank Group's knowledge work and activities in the work you do?"
(Respondents chose from a list.)



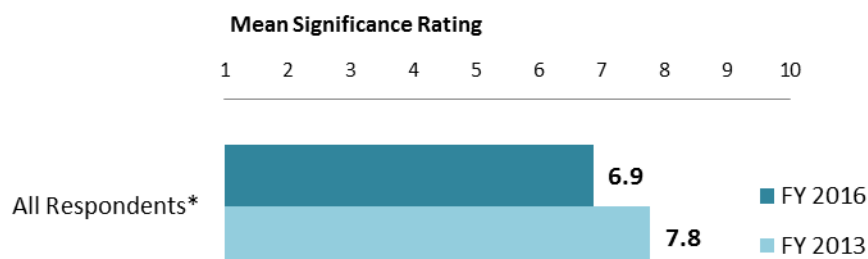

Meeting Kosovo's Knowledge Needs (*Indicator Question*)



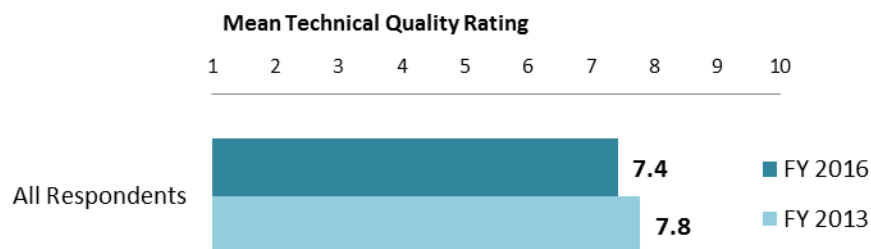

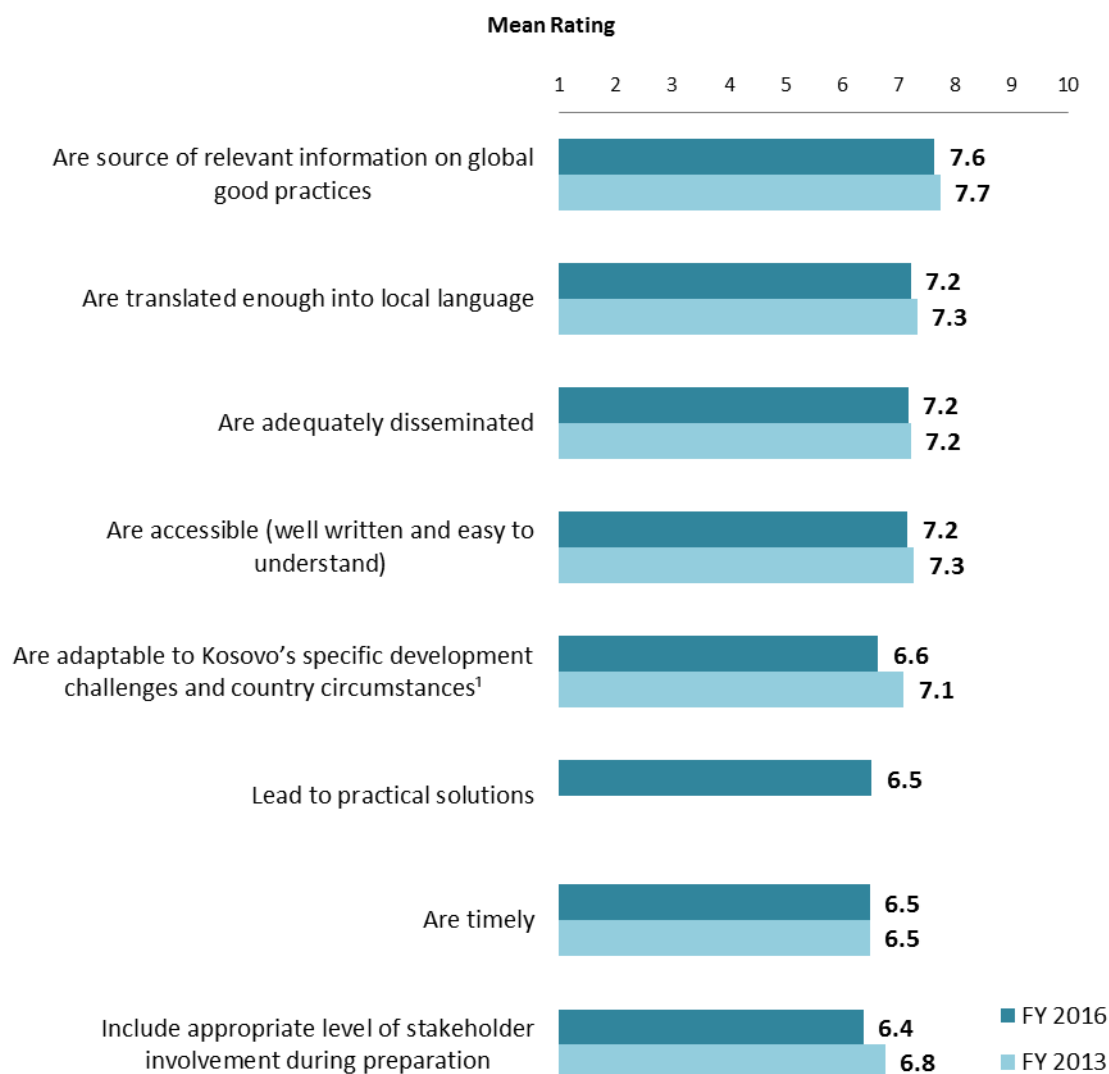


"Overall, how would you rate the technical quality of the World Bank Group's knowledge work and activities?" (1-"Very low technical quality", 10-"Very high technical quality")

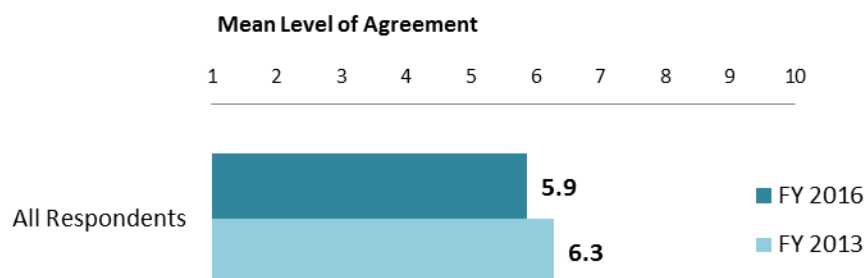

Meeting Kosovo's Needs for Financial Instruments (*Indicator Question*)



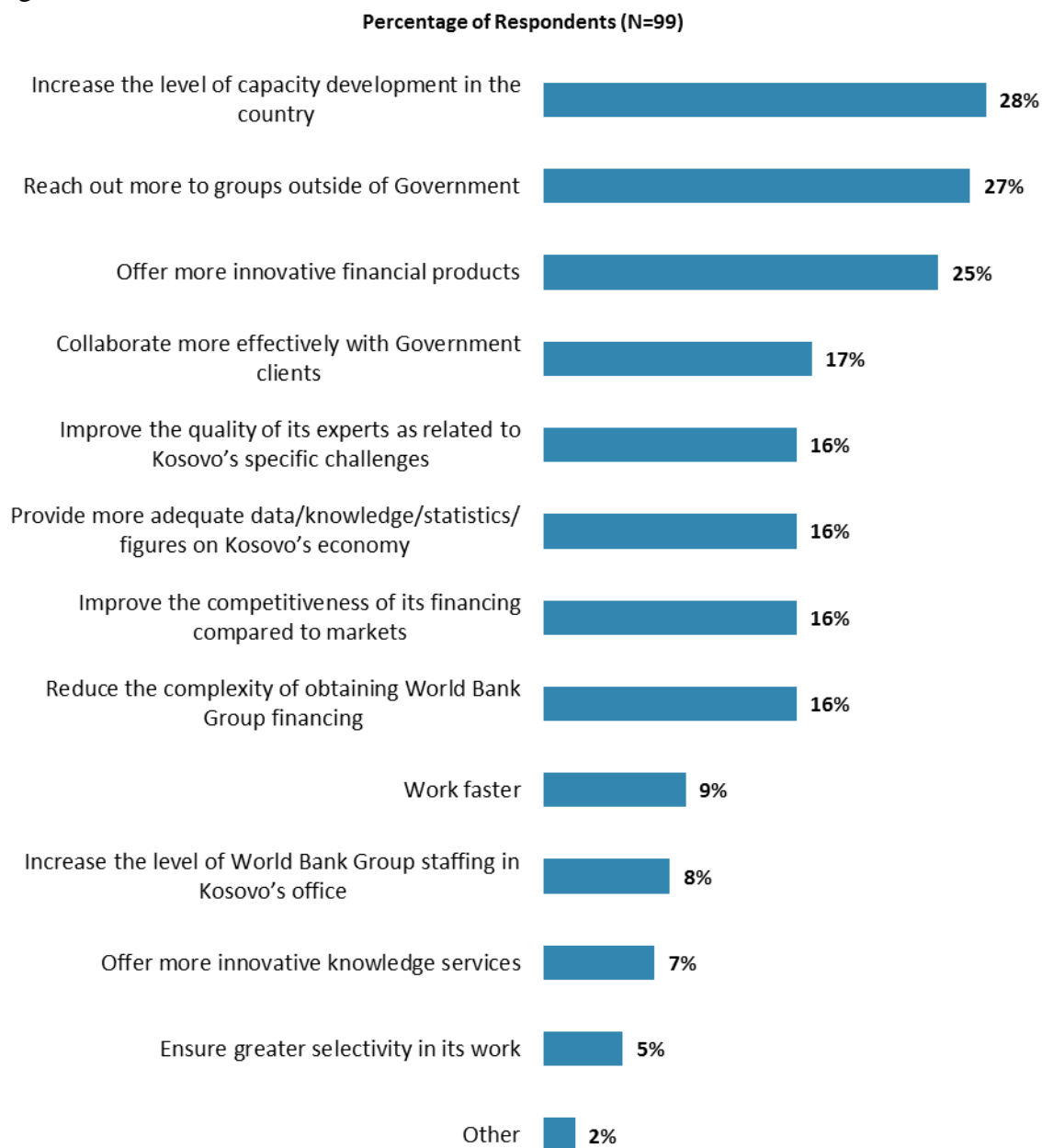

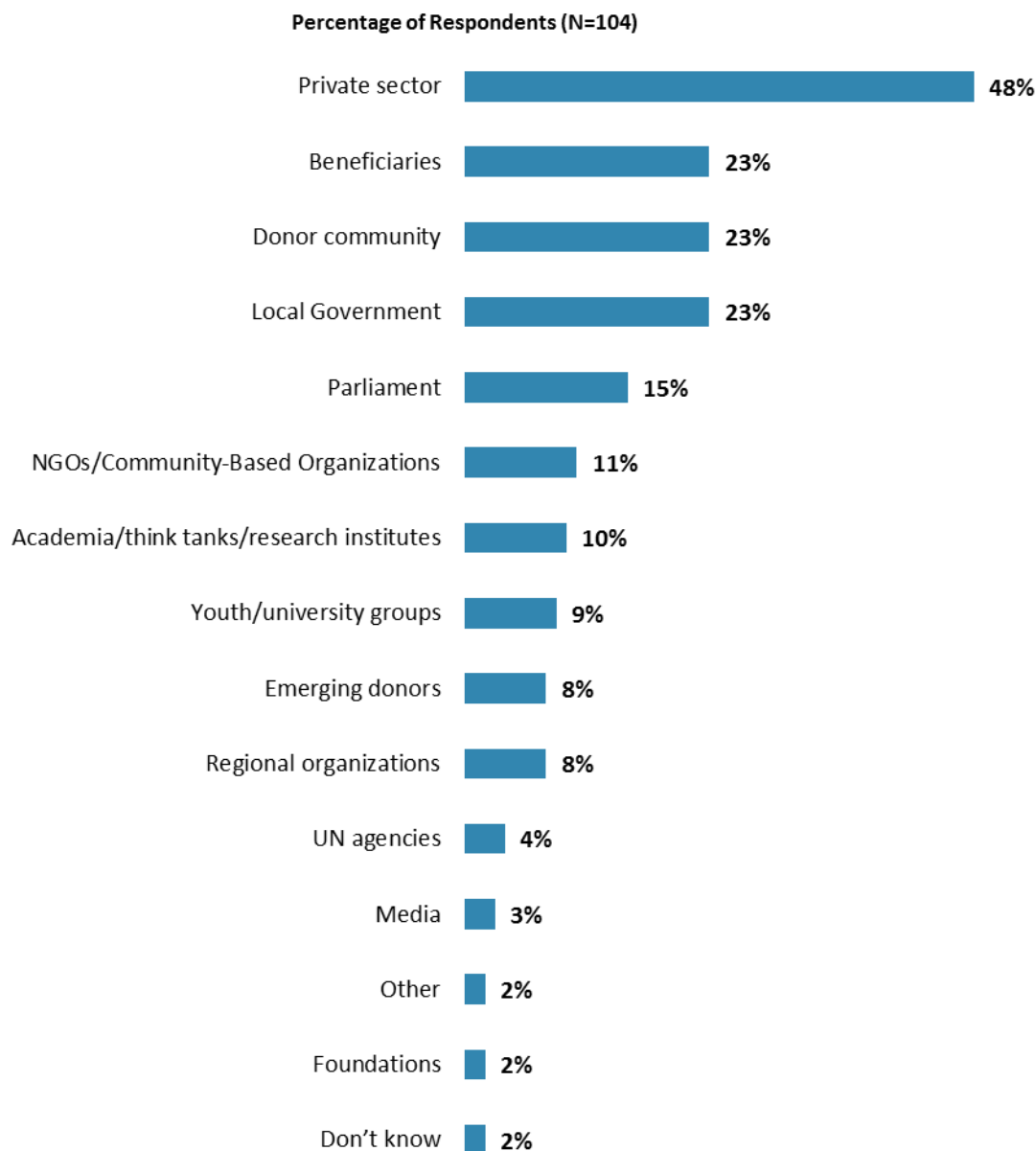

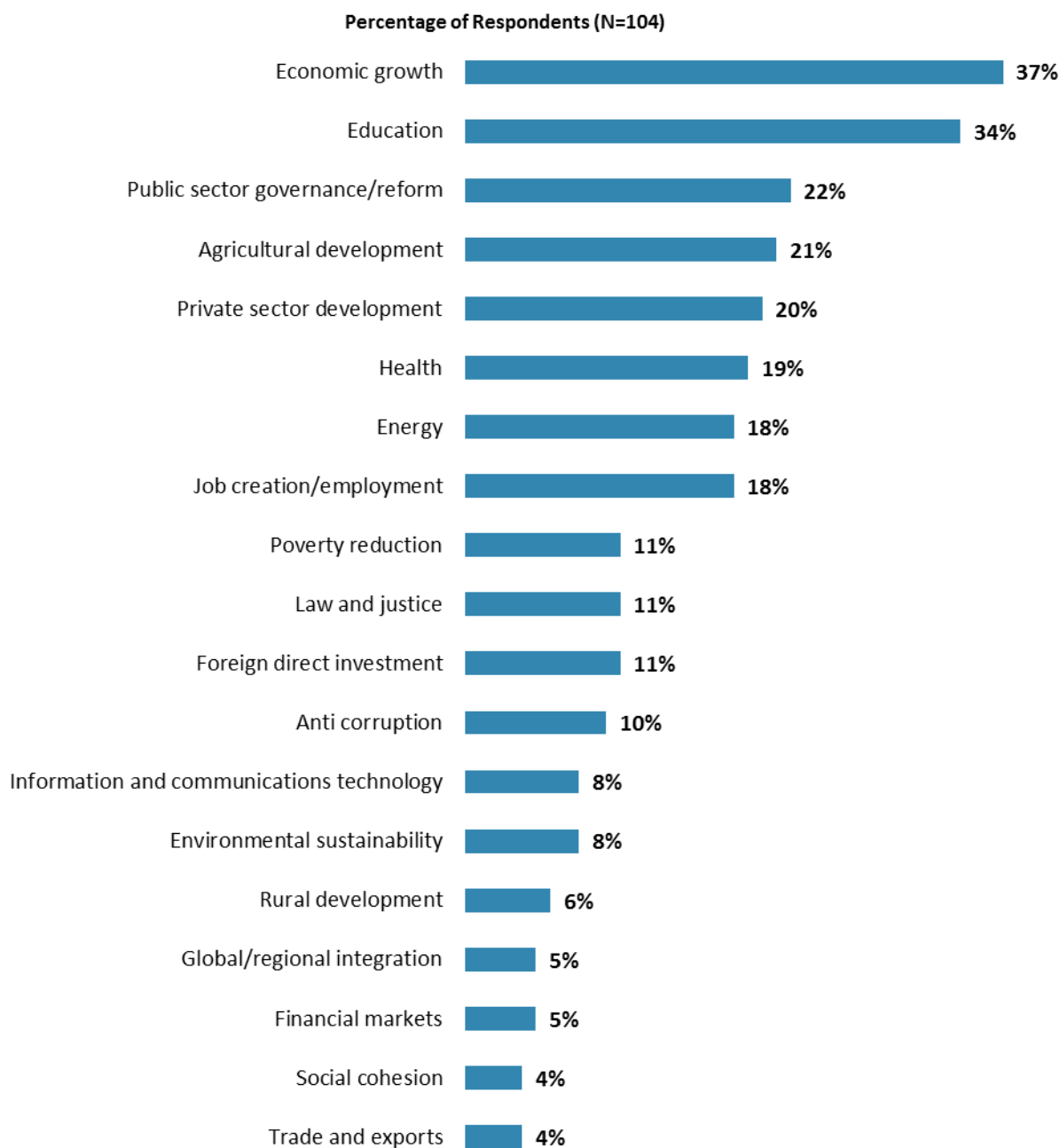
"In addition to the regular relations with the national government, which TWO of the following groups should the World Bank Group collaborate with more in your country?"

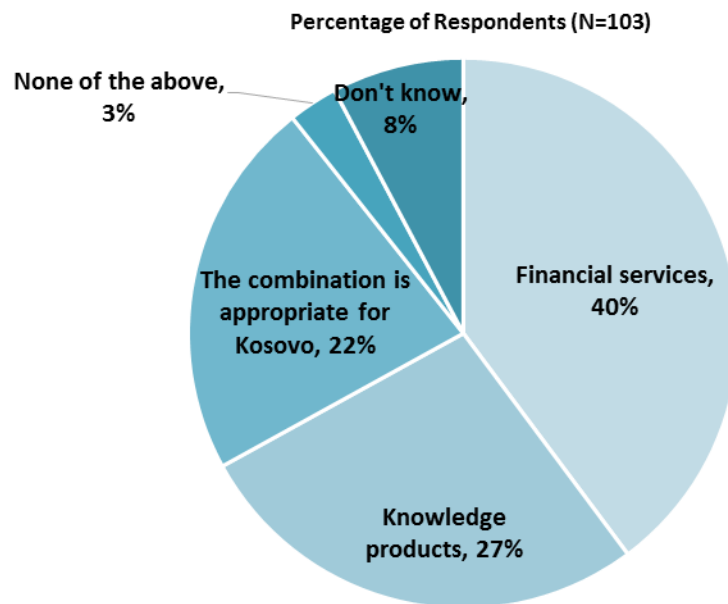

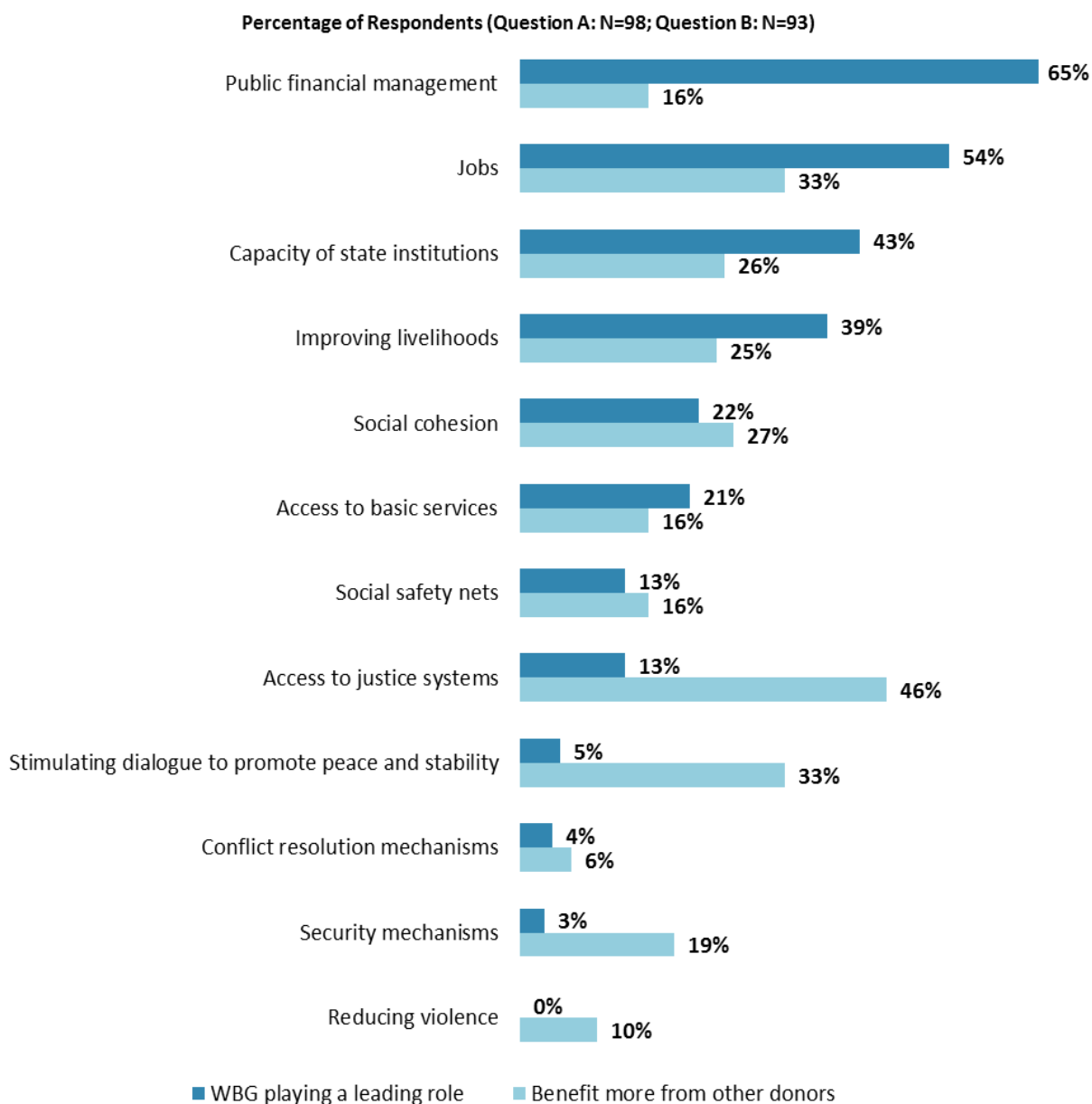

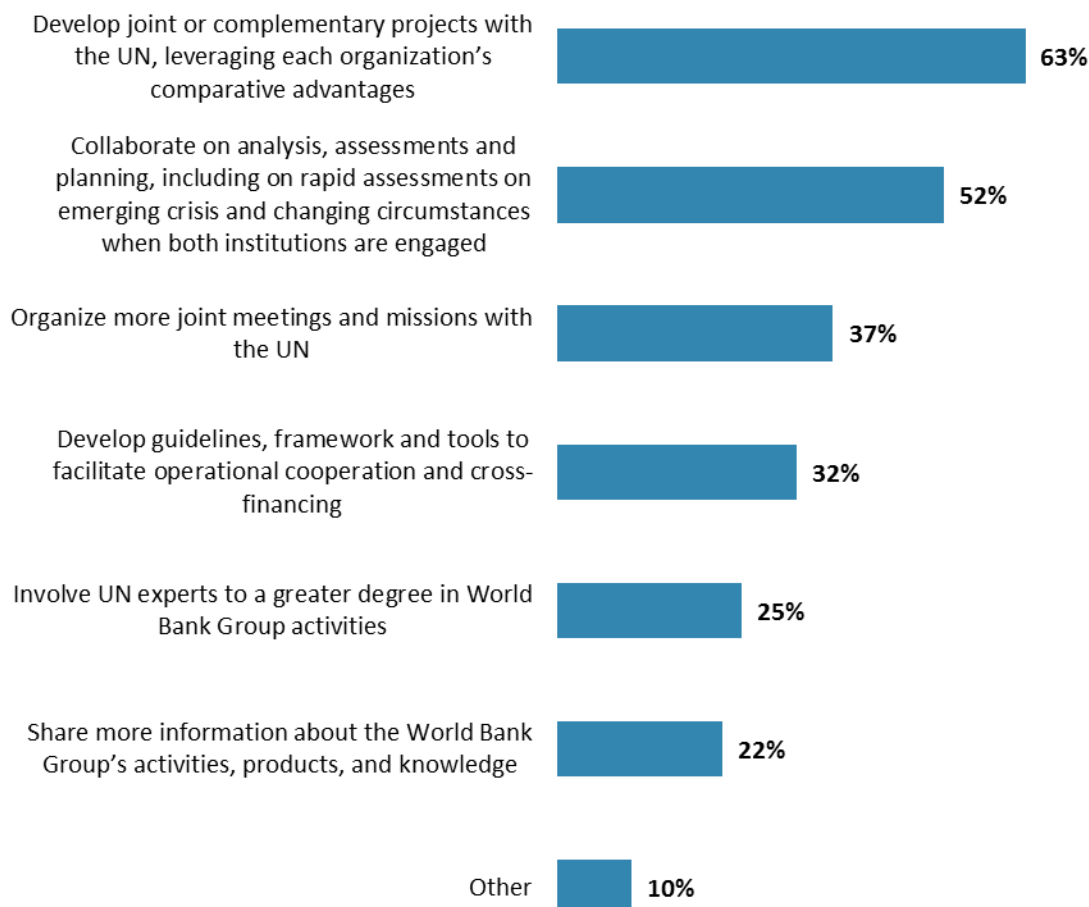

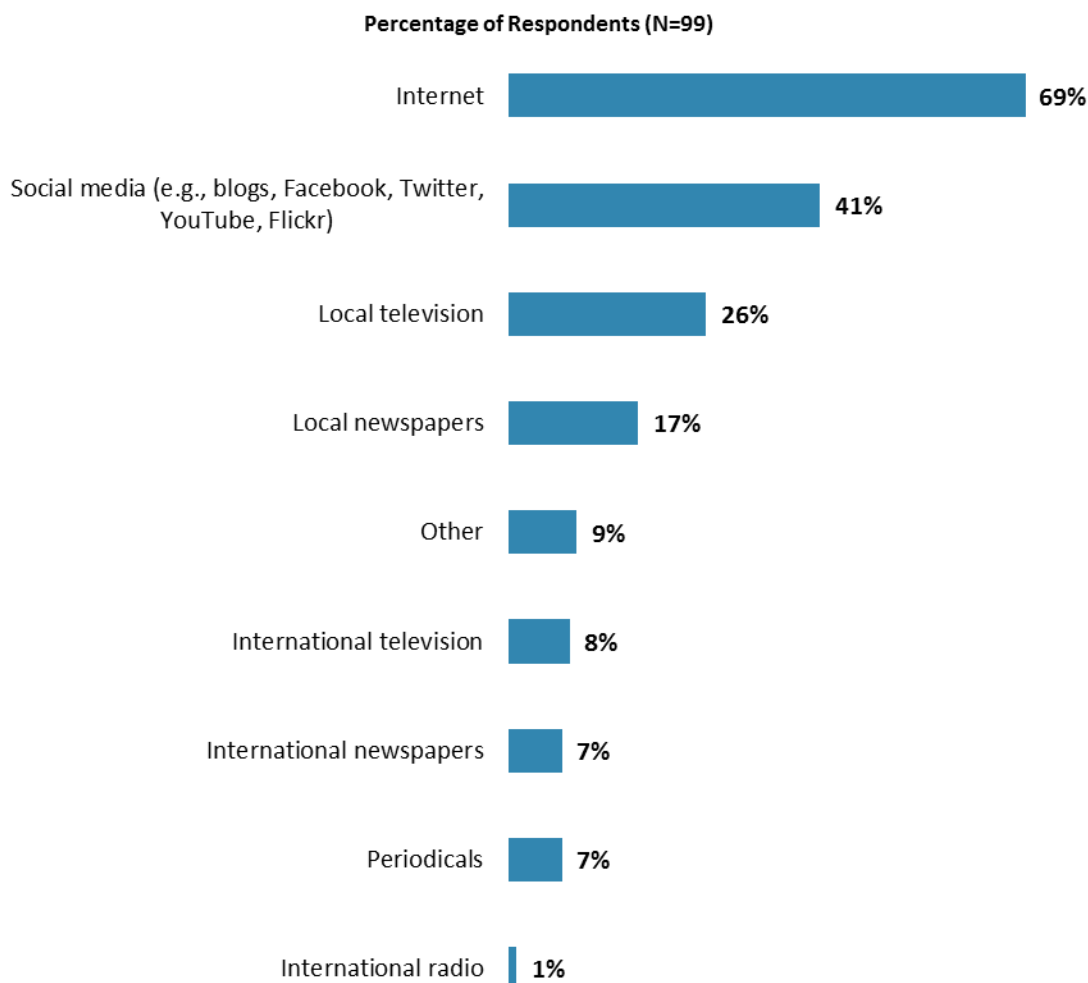

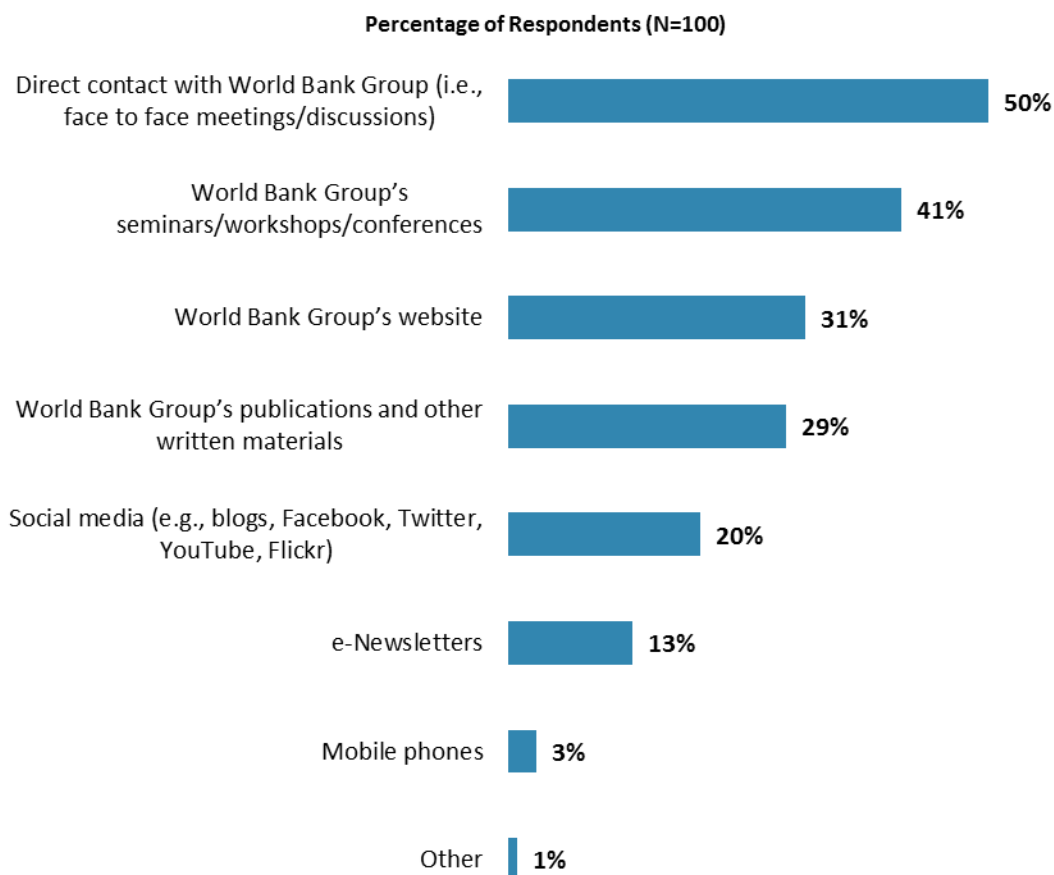
"How do you get most of your information about economic and social development issues in Kosovo? (Choose no more than TWO)" (Respondents chose from a list. Responses combined.)

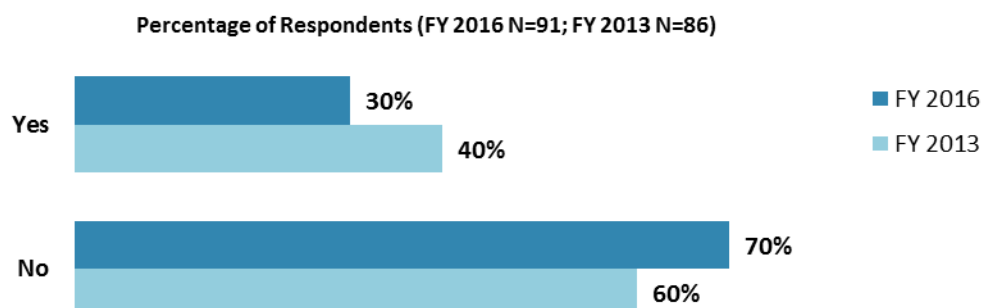


"How would you prefer to receive information from the World Bank Group?
(Choose no more than TWO)" (Respondents chose from a list. Responses combined.)



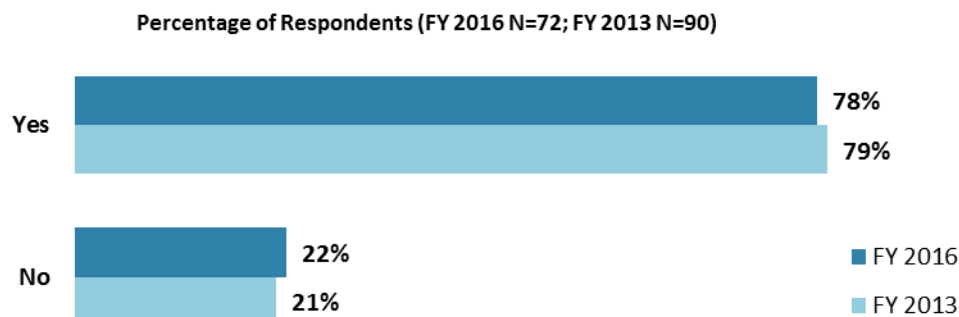

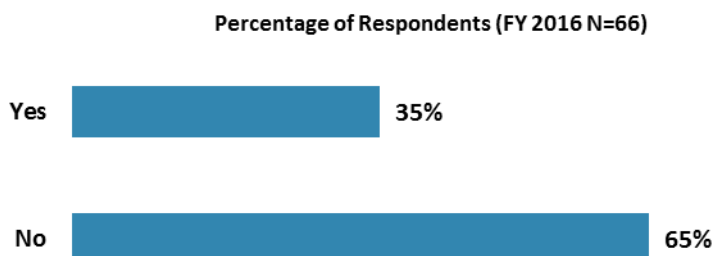
"Are you aware of the World Bank Group's Access to Information Policies under which the WBG discloses any information in its possession that is not on a list of exceptions?"

Appendix D: Responses to Selected Questions by Year⁵

Comparing responses across Country Opinion Surveys (COS) reflect changes in attitudes over time, but also changes in respondent samples and changes to the survey instrument itself. To reduce the influence of the latter factor, only those questions with similar response scales/options were analyzed. As a rule, the COS data are weighted for year comparisons in order to reach the same stakeholder composition in two fiscal years. However, in the case of Kosovo, due to the small number of respondents in the FY'13 COS (101 respondents) and the FY'16 COS (105 respondents) and different stakeholder composition in the samples (see the table below), weighting would have been statistically unsound. Therefore, only basic comparisons of the unweighted data from the FY'13 and FY'16 Country Surveys are presented and should be considered provisional.
