

I. Objectives

This survey was designed to assist the World Bank Group (WBG) in gaining a better understanding of how stakeholders in Côte d'Ivoire perceive the WBG. The survey explored:

- *Overall Context*
- *Overall Attitudes toward the World Bank Group*
- *World Bank Group's Work and Engagement on the Ground*
- *World Bank Group's Support in Development Areas*
- *World Bank Group's Knowledge Work and Activities*
- *The Future Role of the World Bank Group in Côte d'Ivoire*
- *Communication and Information Sharing*
- *Background Information*

II. Methodology

From August to September 2021, 500 stakeholders of the WBG in Côte d'Ivoire were invited to provide their opinions on the WBG's work in the country by participating in a Country Opinion Survey. Participants were drawn from the Office of the President, Prime Minister; office of a minister; office of a parliamentarian; ministries/ministerial departments/implementation agencies; Project Management Units (PMUs) overseeing implementation of WBG projects; consultants/contractors working on WBG-supported projects/programs; local governments; independent government institutions; the judicial system; state-owned enterprises; bilateral and multilateral agencies; private sector organizations; the financial sector/private banks; private foundations; NGOs and community based organizations; trade unions; faith-based groups; youth groups; academia/research institutes/think tanks; the media; and other organizations.

A total of 354 stakeholders participated in the survey (71% response rate). Respondents completed the questionnaire with a representative from the local fielding agency or received the questionnaire via mail and returned it accordingly.

Every country that engages in the Country Opinion Survey (COS) must include specific indicator questions that will be aggregated for the World Bank Group's annual Corporate Scorecard. These questions are identified throughout the survey report.

The results in this year's Country Survey were compared to those in the Country Survey conducted in FY'18 (response rate was 63%, N=315). Data were weighted to reach the same stakeholder composition in two years, which allows for year comparisons. Stakeholder groups which were not present in both fiscal years were not included in the comparison. Respondents who belonged to the "other" stakeholder category were not included either. As a result, mean ratings, percentages of respondents, and the total number of respondents in both years are slightly different from those of the original data reported in the FY'18 COS report and the non-weighted data presented in appendices A, B, and C. For the weighted stakeholder breakdown and year comparison results, please refer to Appendix D (page 73).




“Which of the following best describes your current affiliation?”





Exposure to Agencies within the World Bank Group




"Which of the following agencies of the World Bank Group do you primarily collaborate/work with in Côte d'Ivoire?"

Familiarity with the World Bank Group

- **Year comparison:** Respondents in this year's Country Survey had significantly higher levels of familiarity with the WBG compared to respondents in the FY'18 Country Survey (weighted mean in FY'21 = 5.9; weighted mean in FY'18 = 4.8)².
- **Impact of familiarity:** Respondents' ratings of familiarity³ with the WBG were significantly, strongly correlated with their ratings for the WBG's overall effectiveness⁴ in Côte d'Ivoire, with their ratings of the extent to which the WBG's work helps to achieve development results, and the extent to which the WBG plays a relevant role in development in Côte d'Ivoire.





Perceptions of Economic Opportunity





Development Priority

- **Year comparison:** Respondents in the previous FY'18 Country Survey indicated that the most important development priorities in Côte d'Ivoire were “*education*” (55%), “*job creation/employment*” (31%), “*public sector governance/reform*” (28%), “*poverty reduction*” (27%), “*health*” (25%), and “*private sector development*” (24%). “*Energy*” emerged among the top development priorities, with significant increase from 4% in FY18 to 21% in FY21.
- **Specialization:** Respondents who identified their primary specialization of work as “*education*” (18% of the sample) were significantly *more* likely to indicate that “*education*” was the most important development priority in Côte d'Ivoire, compared to the rest of the respondents (education specialists = 54%; others = 35%).⁶



What Would Contribute Most to Reducing Poverty

- **Year comparison:** Respondents in the previous FY'18 Country Survey indicated that the biggest contributors to poverty reduction in Côte d'Ivoire were “*job creation/employment*” (57%), “*agriculture and rural development*” (37%), “*anti-corruption*” (31%), “*education*” (31%), “*private sector development*” (26%), and “*public sector governance/reform*” (23%). “*Transport*” emerged among the top factors that contribute to poverty reduction in Côte d'Ivoire, with significant increase from 6% in FY'18 to 23% in FY'21.








"When economic and/or social reform efforts fail or are slow to take place in Côte d'Ivoire, which of the following would you attribute this to? (Choose no more than TWO)"





Overall Ratings for Indicator Questions by Stakeholder Groups

- **Collaboration:** Respondents who collaborate with the WBG had significantly higher mean ratings for the aggregated responses to the twenty-nine COS indicator questions (mean rating = 7.1) compared to respondents who do not collaborate with the WBG (mean rating = 6.5).

This year's collaborators had statistically similar mean ratings for the aggregated responses to the indicator questions⁸ compared to the collaborators in FY'18 Country Survey (mean rating in FY'18 = 6.7; mean rating in FY'21=7.0). This suggests that significantly more positive responses to the indicator questions in this year's survey can be attributed to the increased familiarity and more positive outlook among non-collaborators.



Mean Ratings for All Indicator Questions by Stakeholder Groups on a Scale from 1 to 10






"When thinking about the World Bank Group's role in Côte d'Ivoire, which activity do you VALUE the most? (Choose no more than TWO)"




"Which of the following do you identify as the World Bank Group's greatest WEAKNESSES in its work in Côte d'Ivoire? (Choose no more than TWO)"



Effectiveness of WBG's Support in Sectoral Areas: Collaboration¹⁰




"How EFFECTIVE do you believe the World Bank Group is in terms of the work it does in the following areas of development in Côte d'Ivoire?"



Support related to COVID-19 outbreak







The World Bank Group's Work in Côte d'Ivoire: Collaboration














"How effectively does the World Bank Group support Côte d'Ivoire's efforts ... ?"



Meeting Côte d'Ivoire's Knowledge Needs¹⁵ (Indicator Question)


















"Which of the following SHOULD the World Bank Group do to make itself of greater value in Côte d'Ivoire? (Choose no more than TWO)"



Where the World Bank Group Should Focus its Resources

- **Year comparison:** Respondents in the previous FY'18 Country Survey indicated that the WBG should focus its resources on “*education*” (47%), “*health*” (45%), “*job creation/employment*” (33%), “*agriculture and rural development*” (30%), “*poverty reduction*” (27%), and “*anti-corruption*” (21%).
- **Specialization:** Respondents who identified their primary specialization of work as “*education*” (18% of the sample) were significantly *more* likely to indicate that the WBG should focus most of its resources on “*education*”, compared to the rest of respondents (education specialists = 76%; others = 49%).¹⁹





WBG Interaction Frequency




**"How frequently do you interact with the World Bank Group now in Côte d'Ivoire?"
